When the speaker is low on power, a tone(du du) will be heard indicating that it needs to be recharged.</p> <p>BUTTON FUNCTIONS</p> <ol style="list-style-type: none">1. Long Press the  button to turn on/off the speaker.2. Press the  button to play/pause playback, answer an incoming phone call/end call.3. Long press the  button to reject a phone call.4. Press the  button to skip to the previous track. Long press the  button to decrease volume.5. Press the  button to skip to the next track. Long press  button to increase volume.6. Press the  button to control LED light. <p>BLUETOOTH PAIRING</p> <ol style="list-style-type: none">1. Power the speaker ON. A tone will be heard and the speaker will enter Bluetooth pairing mode. The LED indicator will flash Blue.2. Set your mobile device to search for Bluetooth devices. When it appears, select ARCYBR100 from the list of found devices.3. After a successful pairing, a tone will be heard, and LED indicator will turn Solid Blue.
