## CHARGING

For first time use, charge the battery until it is full. To charge, open the headset's USB jack and plug the charging cable into the charging port. Indicator LED is red when charging. Turn blue when fully charged.

(1) VOLUME KEY - / PREVIOUS


(2) MULTIFUNCTION BUTTON

(3) VOLUME + / NEXT

(4) MICRO USB PORT

(5) MICROPHONE

## AUTOMATIC RECONNECTION

Once the headset and the pairing device have been paired together, they will automatically be reconnected if they are within distance of each other and the pairing device's Bluetooth function is turned on.

## TURNING ON and pairing

Activate your pairing device's Bluetooth feature. Search for "Light up earbud", and select it to connect.

## VOLUME CONTROL

Short press the volume + or - repeatedly to adjust the volume.

## MUSIC CONTROL

Press and hold the volume + or - repeatedly to switch the next or previous track.

### **TAKING / REJECTING CALLS**

Answering: Press the Multifunction button once to take a call.

Rejecting: Press and hold the Multifunction button to reject a call.

Redialing: Double click the Multifunction button to redial a latest number in your call logs.
