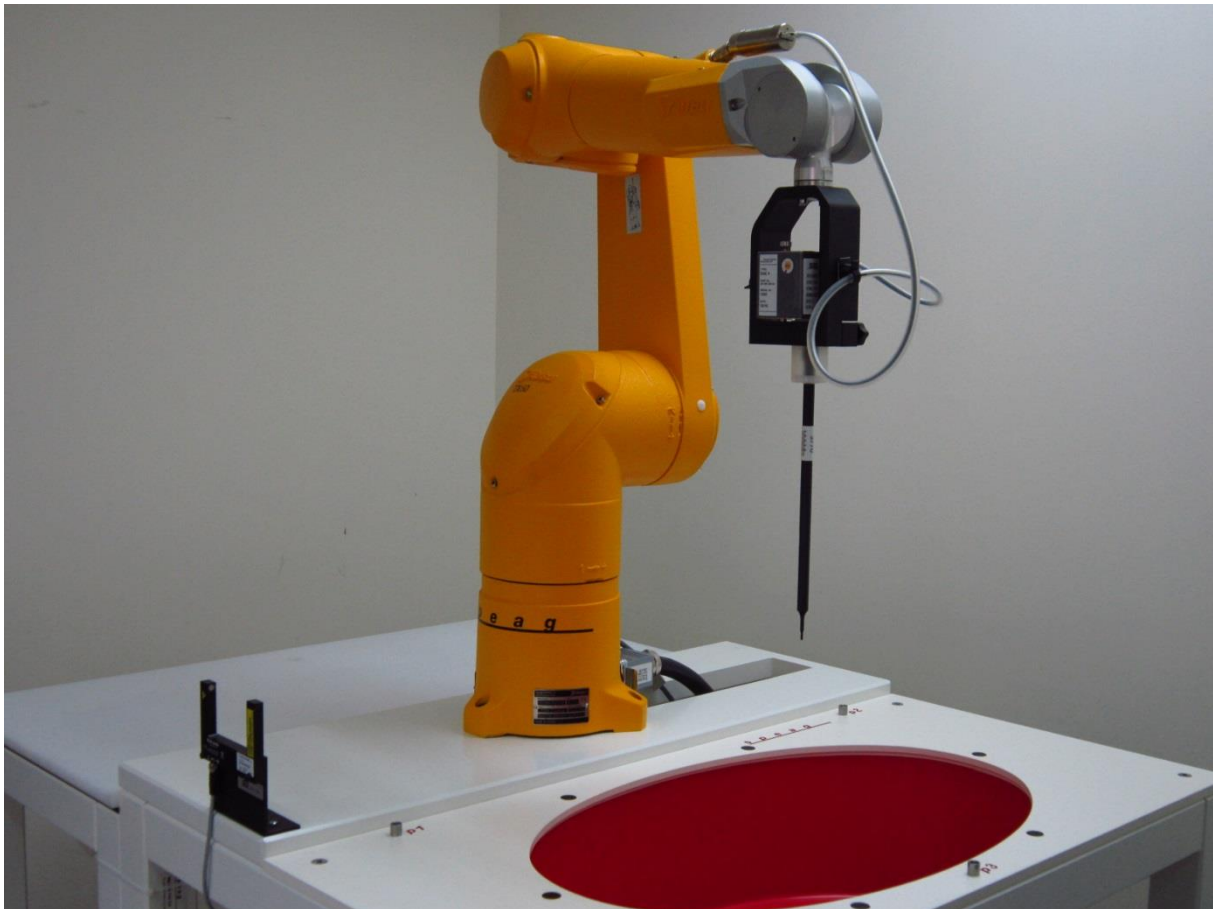

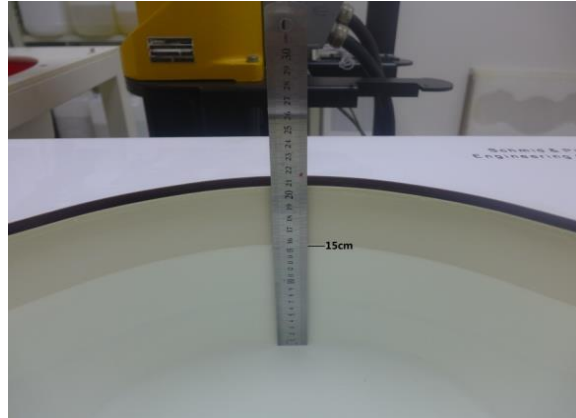

Photo 1: Tissue Simulant Liquid for Head 2450



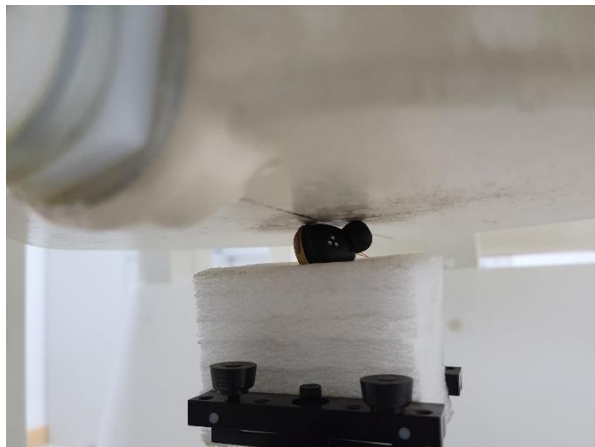

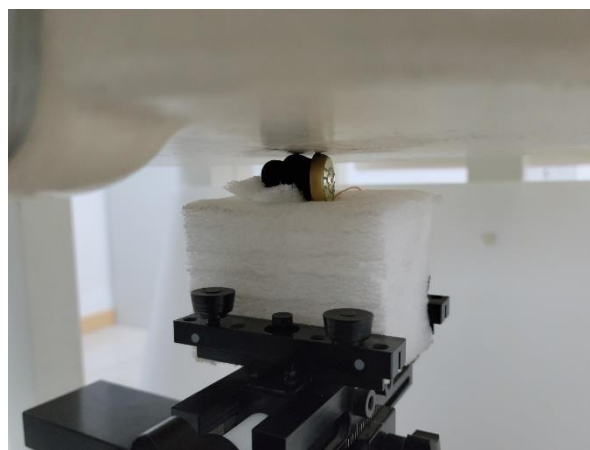

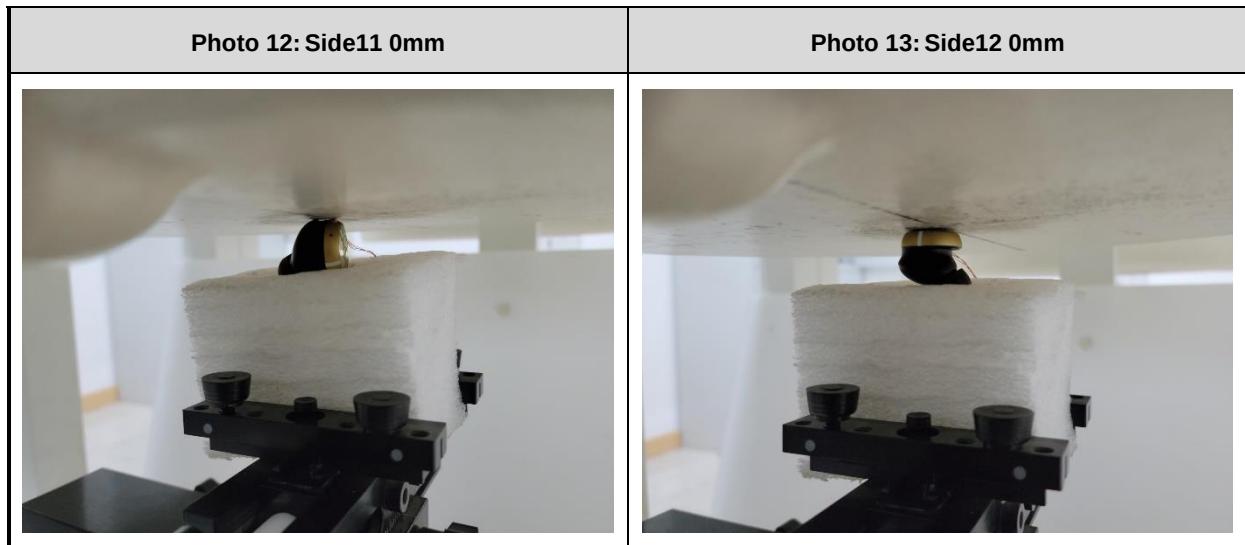
