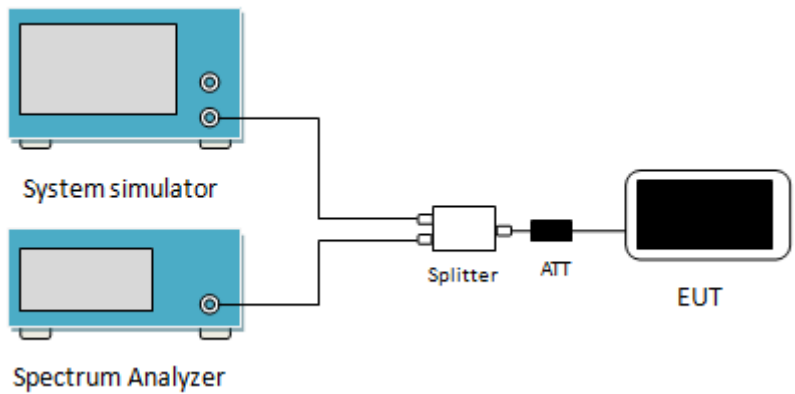

Limit:	The peak-to-average ratio (PAR) of the transmission may not exceed 13 dB.

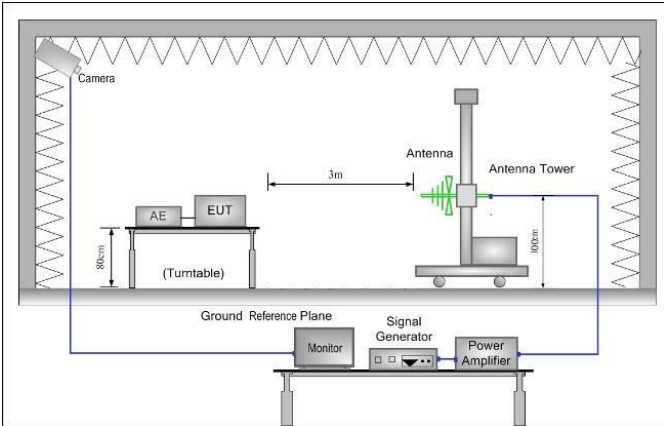
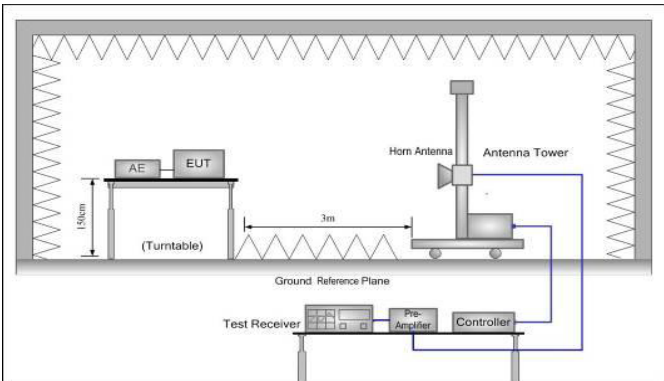
6.3 Occupy Bandwidth

Test Requirement:	Part 24.238(b), Part 27.53(h), Part 27.53(m)
Test Setup:	 The diagram illustrates the test setup. On the left, there are two blue rectangular devices: a 'System simulator' on top and a 'Spectrum Analyzer' on the bottom. Both have RF connectors on their right side. These two connectors are connected to a single input of a 'Splitter' (a white square with two outputs). Test Requirement:	Part 24.238 (a), part 27.53(h), Part 27.53(m)
Limit:	LTE Band 2 & 4 : The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) in watts by at least $43 + 10 \log_{10}(P)$ dB (-13 dBm). LTE Band 7: For mobile digital stations, the attenuation factor shall be not less than $40 + 10 \log(P)$ dB on all frequencies between the channel edge and 5 megahertz from the channel edge, $43 + 10 \log(P)$ dB on all frequencies between 5 megahertz and X megahertz from the channel edge, and $55 + 10 \log(P)$ dB on all frequencies more than X megahertz from the channel edge, where X is the greater of 6 megahertz or the actual emission bandwidth as defined in paragraph (m)(6) of this section. In addition, the attenuation factor shall not be less that $43 + 10 \log(P)$ dB on all frequencies between 2490.5 MHz and 2496 MHz and $55 + 10 \log(P)$ dB at or below 2490.5 MHz.

Test Procedure:	1 The RF output of the transceiver was connected to a spectrum analyzer through appropriate attenuation. 2 For the out of band: For Band 5 & 12 & 17 set the RBW=100 kHz, VBW=300 kHz and for Band 2 & 4 & 7 set the RBW=1 MHz, VBW=3 MHz when below 1 GHz, RBW =1 MHz, VBW=3 MHz when above 1 GHz, Start=30MHz, Stop= 10th harmonic. 3 Band Edge Requirements: In the 1 MHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 1 percent of the emission bandwidth of the fundamental emission of the transmitter may be employed to measure the out of band Emissions.

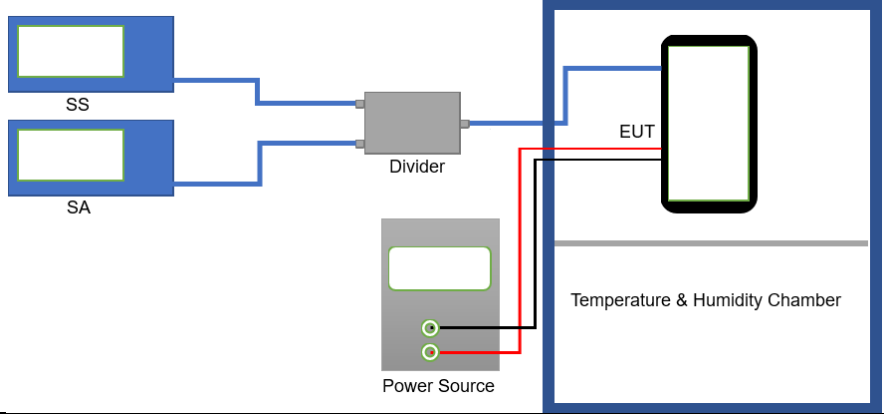

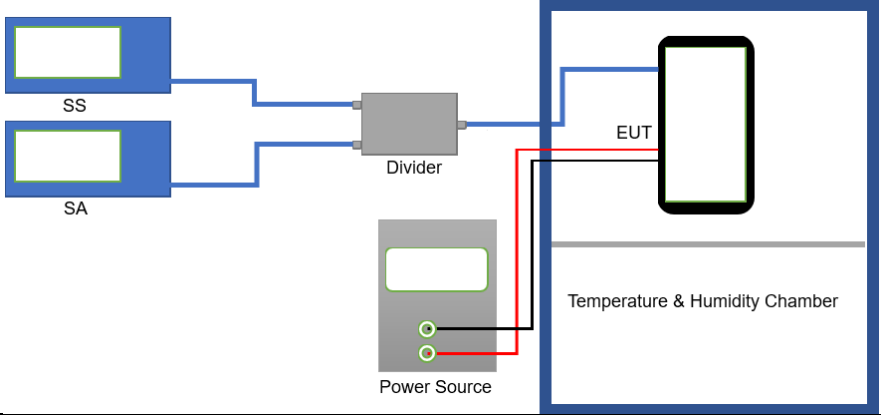
