2 SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plan. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

2.3.2 Radiated Emissions

The EUT is placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plan. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated

emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

2.4 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

Note: The spectrum analyzer offset is derived from RF cable loss 1.8dB+ splitter 3.2dB. Total offset = 1.8 +3.2=5dB.

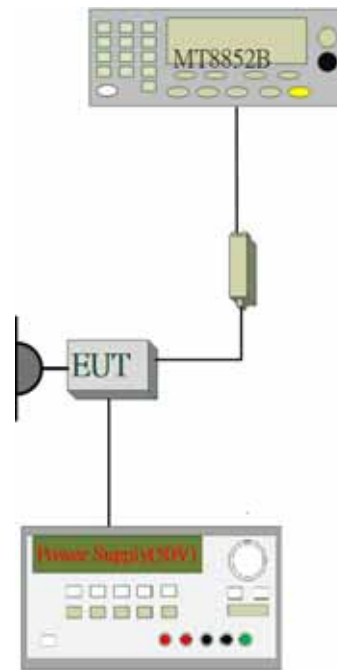

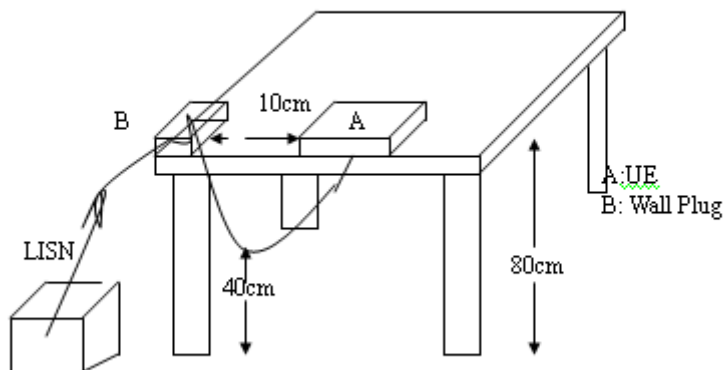

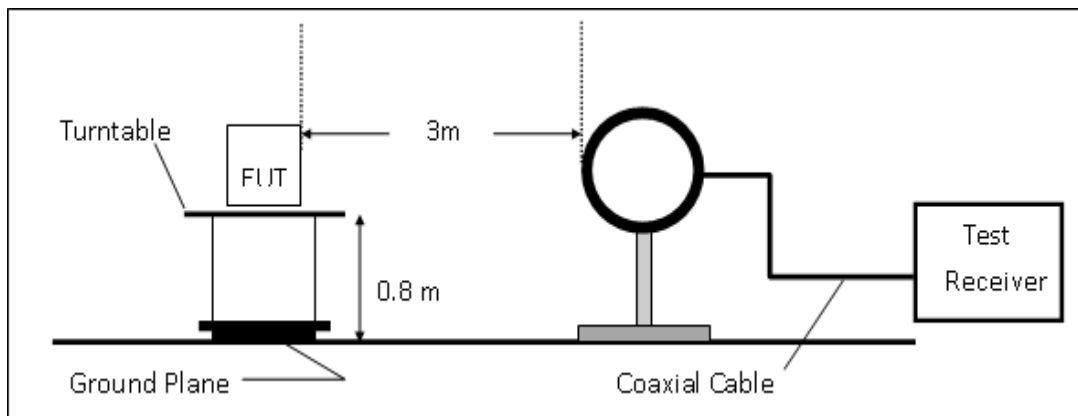

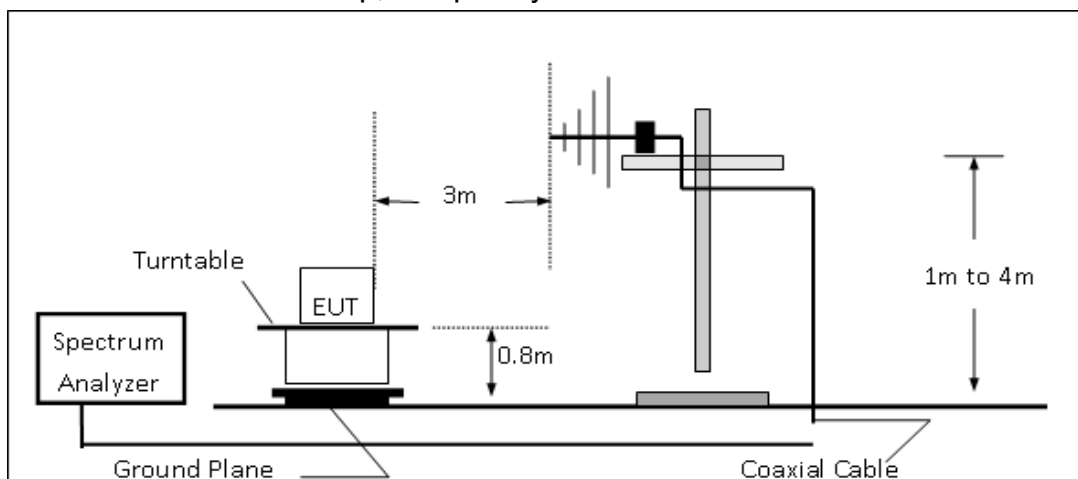

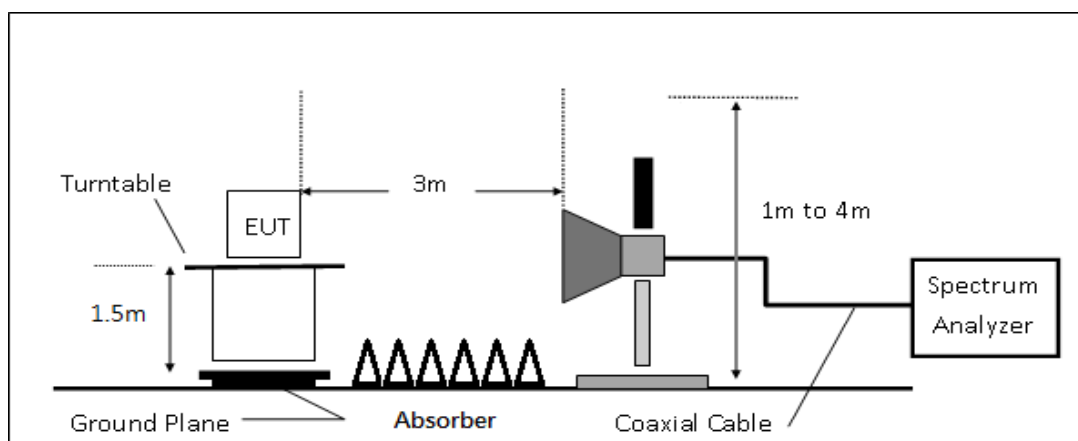
(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

10.4 Measurement Procedure

Radiated Emission

1. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
2. The EUT was placed on a turn table with 0.8m for frequency < 1GHz and 0.8m for frequency > 1GHz above ground plan.
3. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
4. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
5. Use the follow spectrum analyzer setting:
 - (1) Span = wide enough to fully capture the emission being measured
 - (2) RBW = 1 MHz for $f \geq 1$ GHz, 100 kHz for $f < 1$ GHz, VBW \geq RBW, Sweep = auto, Detector function = peak, Trace = max hold
 - (3) For average measurement: use duty cycle correction factor method per 15.35(c)
Duty Cycle = On time/100 milliseconds
On time = $N1 \cdot L1 + N2 \cdot L2 + \dots + N(n-1) \cdot LN(n-1) + N(n) \cdot L(n)$
Where N1 is number of type 1 pulses, L1 is length of type 1 pulses, etc.
Average Emission Level = Peak Emission Level + $20 \cdot \log(\text{duty Cycle})$
6. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.
7. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
8. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
9. Repeat above procedures until all frequency of the interest measured were complete.

10.5 Field Strength Calculation
