

安装方法

- 1.在桌面上钻6mm以上小孔。
- 2.取发射器,用手撕开3M胶表面贴纸。
- 3.取发射器把线穿过桌面的孔,用力压住黏贴桌面。
- 4.取主控盒,用力十字螺丝刀固定在桌子下面线孔附近。
 5.把发射器的磁线穿入主控盒线孔,
- 取十字螺丝刀在底面把螺丝固定,连接电源。
- 6.发射器的线连接后,把手机放到发射器上完成充电后, 超薄桌面无线充电器安装成功。





注意事项

- 1.充电时,请使用2A充电器,否则影响充电线效果。
- 保护壳超过2mm厚度或金属保护壳充电, 充电前需移除保护壳。
- 3.若无线充电器发热,防护电路板会保护充电器。

Description & Operation Instruction

- 1.Drill a hole (≥6mm) in the desk.
- Get the wireless charging transmitter, and tear off the sticker on the surface.
- Pass magnetic wires through the hole, then press the tranmitter hard to stick on the desk.
- Fix the wireless charging controller beneath the desk with screws.
- 5.Twist the screws on the bottom of controller, make sure megnetic wires connecr to controller box.

 6. After installation, put phone down for wireless charging easily.





Caution!

- Please use 2A wall adapter while charging, otherwise it will affect the charging efficiency.
- Protective cases that exceed 2mm thick or metal cases prevent the charger from working and may have to be removed before wireless charging.
- 3.Over temperature protection will be on protection will be on to protect circuit, the device stop charging. Then it will charger again after it cool down to a safe value.
