## 9、 Self-timer function

### Key Description:

Play/Pause: Press long 3 seconds for power on, press long 5 seconds into pairing mode.

Press long 5 seconds for power off.

Press twice to redial, press short to play/pause.

When a call comes, press short to answer a call, press long to hand up.

Talking on the phone, press short to hang up, press long to switch back to the phone.

Volume +: Press long to turn up the volume, press short for the last song.

Volume -: Press long to turn down the volume, press short for the next song.

### LED light:

Blue light flash quickly , means automatically re-connect.

Blue light flash, means into pairing mode.

Blue light flash slowly, means connection successful.

Blue light flash slowly for 7 seconds, means connection successful.

Voice prompt: Under these modes will be alarm (Power on/off, pairing, connection, low battery, redial, max volume, mini volume).

Self-timer function operation: open the phone camera, long press the volume + or volume - into self-timer mode, press the play / pause button to take pictures

The voltage is 3.3V under low battery. Less than 3V the power will be off. Low power alarm is from 3.3 V to 3V every 30 seconds each time.
