

BEAM Authentic BEAM1 Device IMPORTANT SAFETY AND PRODUCT INFORMATION

NORMAL OPERATING CONDITIONS

The BEAM Authentic BEAM1 device has a normal operating temperature range from 0° to 35° Celsius (32° to 95° Fahrenheit) and a non-operating temperature interval from -20° to 45° Celsius (-4° to 113° Fahrenheit).

WARNING

Failure to heed the following warnings could result in an accident or medical event resulting in death or serious injury.

Battery Warnings

A lithium-ion battery is in this device. If these guidelines are not followed, battery may experience a shortened life span or may present a risk of damage to the device, fire, chemical burn, electrolyte leak, and/or injury.

- Do not disassemble, modify, remanufacture, puncture or damage the device.
- Do not remove or attempt to open device or to remove the battery.
- Do not expose the device or battery to fire, explosion, or other hazard.
- **KEEP BATTERIES AWAY FROM CHILDREN.** NEVER PUT BATTERIES IN MOUTH. Swallowing can lead to chemical burns, perforation of soft tissue, and death. Severe burns can occur within 2 hours of ingestion. Seek medical attention immediately.
- When charging the device, only use the BEAM Authentic accessory USB charging cable approved for your product.

Magnet Warnings

The BEAM Authentic BEAM1 device comes with two magnet set attachment accessories. These are used to attach your BEAM device to clothing, a backpack, or surface.

The BEAM Authentic magnet accessories have a pull force of 8.42 lbs. 909 gauss rating, Magnet grade N52.

MAGNETS ARE NOT TOYS. CHILDREN SHOULD NOT BE ALLOW TO HANDLE MAGNETS.

Keep away from all children. If swallowed, magnets can stick to intestines causing serious injury. Seek immediate medical attention if magnets are swallowed or inhaled.

Placing the parts of one magnet set close to each other, or placing a whole magnet set near the other magnet set will cause them to attract and leap towards each other with great acceleration and then slam together.

Battery Notices
