
GROUNDING INSTRUCTIONS

This product must be grounded. If it should malfunction or breakdown, grounding provides a path of least resistance for electric current to reduce the risk of electric shock. This product is equipped with a cord having an equipment-grounding conductor and a grounding plug. The plug must be plugged into an appropriate outlet that is properly installed and grounded in accordance with all local codes and ordinances.

Before Use: Safety Precautions

Before using, please carefully read the “Safety Precautions” section for proper installation and operation.

Please do not try to install or repair the massage chairs without the assistance of BODYFRIEND technicians.

BODYFRIEND is not responsible for replacement cost if the product is damaged or breaks due to self-troubleshooting.

CAUTION – Please do not install in a non-residential settings.

This product is for non-commercial, residential use only. Warranty is subject to cancellation if the product is used for commercial purposes.

Prohibited

To reduce injury and risk of fire:

- 01 Do not install in bathrooms or areas with high humidity levels. Could result in electric shock.
- 02 Avoid using in areas with excessive amounts of dust or areas prone to rust.
- 03 Do not operate this device in settings with temperatures exceeding 104°F.
- 04 Do not use outdoors.
- 05 Do not use near heaters or anything radiating heat.
- 06 Install and use only when properly grounded on flat surfaces.
- 07 Use in areas with ample space and good air circulation.
- 08 Do not use after disassembling parts. Can result in product malfunctions.

Do not use if


Before Use

- 01 Consult a doctor before using if suffering from a medical condition listed under the “not advised to use” section or if medical condition worsens after using device.
- 02 Refer to operation guide and review situations of negative side effects of using device.
- 03 Start massage at a low intensity and build up for safe operation practices.
- 04 Locate the “Pause” and “End” button in case of emergencies.
- 05 Check the time setting for each massage cycle.
- 06 Check for any damaged areas or tears in the cover where loose clothing, hair, or accessories may get caught and cause serious injury.
- 07 Do not connect or disconnect the power cord with wet hands.
- 08 Do not use the device if the body is still wet.
- 09 Check the power status of the device before using.

During Use


- 01 Stop using immediately if you experience any pain or discomfort and consult a doctor.
- 02 Do not let the heating unit or motor come in direct contact with bare skin.
- 03 Be aware of the time remaining for the massage cycle.
- 04 Do not use concurrently with another electronic device or heating pad.
- 05 Always leave the controller in an easily accessible place.
- 06 Do not let more than 2 people operate device concurrently.
- 07 Be aware of accessories worn on areas of the body getting massaged (hair accessories, necklaces, watches, and etc.).
- 08 Operate device for intended use and on intended areas of the body.
- 09 Do not pull aggressively on the controller cord.
- 10 Make sure parts of the body do not get caught in crevices of the device.
- 11 Be aware of individual’s body temperature when using device, especially if individual falls asleep.
- 12 Wait for the device to stop moving before getting up from the device.
- 13 If user steps on the leg unit to get up from the device, the leg unit will beep.
- 14 Adjust speaker volumes before using the brain massage function.
- 15 Beware that anti-squeezing sensor may alert and leg unit may stop when recognizing an object being in the way.
- 16 Growth massage programs are optimized for adolescents between height 130 cm-160 cm and may be of slight discomfort to adults.
- 17 Turn off shoulder airbags by clicking shoulder airbags off button when used by heavily built individuals.
- 18 Use under the supervision of a caretaker when using a child with excessive behavior.
- 19 Do not use for anything other than massage purpose, such as hanging or jumping.



Installation Part 01


STEP 1. Main Body Installation

- 01 Reserve ample space for massage chair installation
(+4,7' ' from the back of the chair and +11,8' ' from the legs part of the body)
- 02 Define the location/direction of the seat.
- 03 Install in the place where the device can operate with ease.



STEP 2. Check the Components and Parts

Check that you have received all necessary components and parts after removing the device from packaging.




STEP 3. Connecting to Power

- 01 Make sure the switch is OFF before connecting the power plug.
- 02 Plug the power cable into the power socket.
- 03 Shift the switch mode to ON.




STEP 4. Transporting


- 01 Find the chair wheels adhered to the body.
- 02 When the back wheels reach the floor surface, tilt the massage chair backwards at an angle of 45°.
- 03 Start moving the massage chair forward hanging on to the front part of a chair.

CAUTION

- 1) The massage chair cannot be transported if the width of the passage is less than 31,5' ' (80 cm).
- 2) Do not transport the chair with a person sitting on it.
- 3) Spread a mat over the floor not to damage the floor surface.

| | Power | Power ON/OFF. Switching off the power while in operation will lead to the full stop of functions and make the massage module return to its original resting position. |
| | Auto Massage | Auto massage button with 4 massaging modes: Neck/Shoulder-Focused, Waist/Back-Focused, Relaxing and Soothing. |
| | Manual Massage | An intensive massage for specific parts of the body (5 modes in total: Kneading > Tapping > Combination > Chopping > Acupressure modes) |
| | Intensity/ Speed | Enables to adjust intensity/speed during manual massage. (3 levels in total) |

| | Still in operation. | Turn off. |
| LED indicators blinking after device is turned off. | Still in operation. | Turn off. |
