## TEST RESULT

No non-compliance noted.

### Calculation

Given 
$$S = \frac{P \times G}{4\pi d^2}$$
 (Equation 1)

Where d = distance in cm

P = Power in mW

G = Numeric antenna gain

S = Power Density in mW / cm<sup>2</sup>

### Maximum Permissible Exposure

EUT Output Power=43.15mW

Numeric antenna gain=1.58

Substituting the MPE safe distance using d=20 cm into **Equation 1** :

The power density  $S = 43.15 \times 1.58 / (4\pi \times 400) \text{ cm}^2 = 0.014 \text{ mW/cm}^2$

(For mobile or fixed location transmitters, the maximum power density is 1.0 mW / cm<sup>2</sup> even if the calculation indicates that the power density would be larger.)
