Diagram

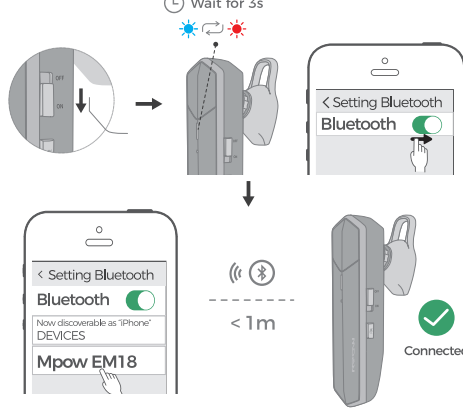

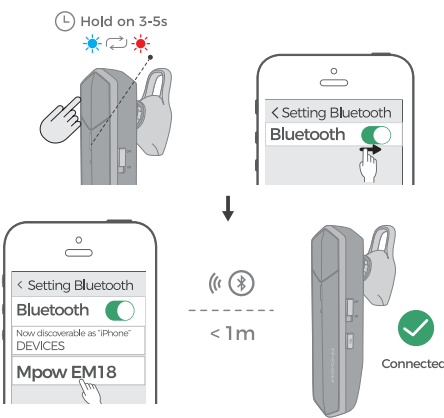


How To Pair

EN

- Slide the side button to "ON", then wait for 3 seconds or so, it will automatically enter into pairing mode in which the LED light will flash red and blue alternately. Then select "Mpow EM18" on your device.
- When the headset has connected with one device, simply keep pressing the MFB button for 3-5 seconds or so, it will automatically enter into pairing mode again in which the LED light will flash red and blue alternately. Then select "Mpow EM18" on your device.

DE

- Schieben Sie die Seitentaste auf „ON“ und warten Sie auf ca. 3 Sekunden. Der Pairing-Modus wird automatisch aktiviert, in dem die LED abwechselnd rot und blau blinkt. Wählen Sie dann "Mpow EM18" auf Ihrem Gerät.
- Wenn das Headset mit einem Gerät verbunden ist, halten Sie einfach die MFB-Taste etwa 3-5 Sekunden lang gedrückt. Das Headset wechselt dann automatisch wieder in den Pairing-Modus, in dem die LED-Anzeige abwechselnd rot und blau blinkt. Wählen Sie dann "Mpow EM18" auf Ihrem Gerät.

- Faites glisser le bouton latéral sur "ON", puis attendez environ 3 secondes. Il entrera automatiquement en mode de couplage dans lequel le voyant LED clignotera alternativement en rouge et en bleu. Ensuite, sélectionnez "Mpow EM18" sur votre appareil.
- Lorsque le kit oreillette est connecté à un appareil, maintenez simplement le bouton MFB enfoncé pendant environ 3-5 secondes. 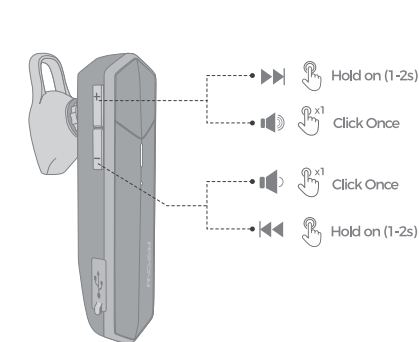

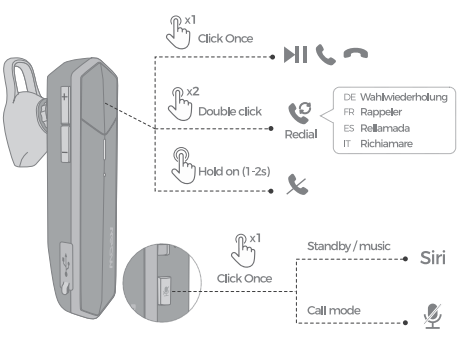

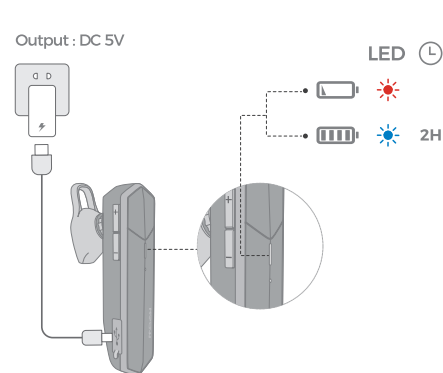
