



## 2. Installation

Pre-condition :

1. Install Gateway APP and Gateway working
2. Enable Smart phone Bluetooth Function .

### Step 1 :

Open APP then Gateway WIFI list will appear on screen , or user can click "Refresh" button to refresh the list .

BE sure of using the same ID name




### Step 3:

Here ,Wifi App has three parameters


1. SSID: the user can use the automatic collection to fill or enter, the input length is limited to 40 characters or less
2. Password: Users must enter their own, the input length is limited to 20 characters or less
3. Type: The security type of the connection Wifi , If the user uses the automatic collection of SSID way, Gateway will automatically detect and bring this project If the user uses the self-input method, this item needs to be re-entered  
No password Wifi fill 0  
Have a password for Wifi Fill 1 (WEP) or 2 (WPA, WPA2)

Most of the passwords are usually Wifi Type 2, APP is the default value of 2



### Step 4:


Confirm the set switch is checked, confirm and click "Setup", set to complete the APP will return to the list screen

#### 3.3 Verify Gateway working status

2. Verify that the WiFi AP does not have any special settings (for example, firewall ..)

Click the System Diagnostics icon


