

1. Safety Instructions

For indoor use only.

Inspect the device and its components before use.

Do not use if it is damaged.

Do not use outdoors or in places where aerosol products (sprays) are used.

Do not use near heat sources such as radiators, stoves, etc.

Keep away from sources of ignition.

Do not immerse in water.


Do not place, store, or use the product near water.

Do not allow moisture to come into contact with electrical parts.

Do not attempt to repair, disassemble, or modify the product yourself.

To avoid hearing damage, you should limit the time you use this sound source at high volume and set it to a safe level. Prolonged exposure to high volume levels can cause hearing damage.

BATTERY CAUTION: Do not disassemble, short circuit, or expose to fire or high temperature. Properly connect specified devices. Recycle battery according to local, state and national regulations.



Connecting the Speaker

Note: Fully charge the battery before first use. This process takes about 1-2 hours. Connect the speaker to a suitable power source using the supplied USB-C cable. Press and hold the power button to turn the speaker on or off.

The speaker will automatically switch to Bluetooth mode.

Check that the smart device and the speaker are within range of each other (<10 m). Open Bluetooth settings on your smart device and select "**WG-BT-SP**" to connect. Control your music via the speaker or your device.

Note: The speaker will automatically reconnect after the first pairing.

4. Connect the two speakers you want to use together.

- Press the same power button twice on each speaker to start pairing.

5. Open the Bluetooth settings on your device.

- Press once to establish a connection.

- Start pairing the speakers over both speakers at the same time.

Note: After the first pairing, the speakers will automatically reconnect as soon as they are switched on.

Maintenance

Always unplug the speaker from the socket and switch off the speaker before storing it for a long period of time.

Store the speaker in a dry, cool place, away from direct sunlight. Clean the speaker with a slightly dampened cloth and wipe it with a soft cloth.

Avoid completely discharging the battery to prolong its life. Charge the speaker regularly.
