Touch Control

1 Tap:
Play/Pause, Answer/End Calls

2 Taps:
Left - Volume Up
Right - Volume Down

3 Taps:
Enable AI Voice Assistant

Long Press 1-2 seconds:
Reject incoming call

Long Press 3 seconds:
Left - Restart track (if you pause and restart the track, you can Long Press 3 seconds to go to the previous track.)

Right - Next track

Long Press 5 seconds:
Power ON/OFF

Pairing

1. Once the case indicator light shuts off to indicate that it is fully charged, open the cover of the charge case and remove the earbuds.
2. The indicator lights on both earbuds will initially flash as they search for each other. When only one earbud is flashing, that indicates that they have paired to each other, and are ready to pair to your device.
3. Once they are ready to pair, go to the Bluetooth settings on your device and look for **BB-BT-EB** in the list of new Bluetooth connections, and tap to pair it.



4. You can now listen to music or make a call.
5. Once you have successfully paired your earbuds to your device as described above, the earbuds will pair automatically every time they are removed from the case.

Phone Calls

When connected to a device capable of making and receiving phone calls, you can single tap either earbud to answer or end a call.

Listening to Music

When the earbuds are turned on and connected to your Bluetooth device, you can open a music player or other audio source and listen.

For a full list of controls, see the Touch Control section.

Using AI Voice Assistants

On either earbud, tap the the control surface three times to activate your device's AI Voice Assistant. The AI Assistant on your device must already be activated prior to using it with these earbuds.

Charging

1. Replace the earbuds in the charging case.
2. Reconnect the Type-C charging cable to the USB power source (if it was disconnected) and to the back of the charging case.
3. See the Getting Started section for more information on charging.
4. The earbuds indicator will be solid red, and the case indicator will be flashing red.

5. When the earbuds are finished charging, their indicator lights will shut off, and when the case is fully charged, its indicator light will be solid red.

6. You should disconnect the case from the power source when charging is complete. When you disconnect the charged case, an indicator to the right of the charge port will glow blue, and then shut off.

Powering Off

The earbuds will automatically power off when placed in the charging case, but you can manually shut them off by long pressing one earbud's control surface for 5 seconds.

Please Note

- Do not abuse this product, and do not squeeze it between heavy objects.
- Keep this product away from high temperatures and humidity.
- Keep this product away from high frequency transmitter equipment as it could affect the signal reception, resulting in breakup, distortion, or disconnection.
- If for any reason you move out of range of the device you are listening to audio from while using the earbuds, the earbuds will disconnect and go into standby mode, but will power down after 3 minutes of no wireless signal to save battery life. You may need to re-pair the earbuds when they are back within the wireless range of the audio source.
