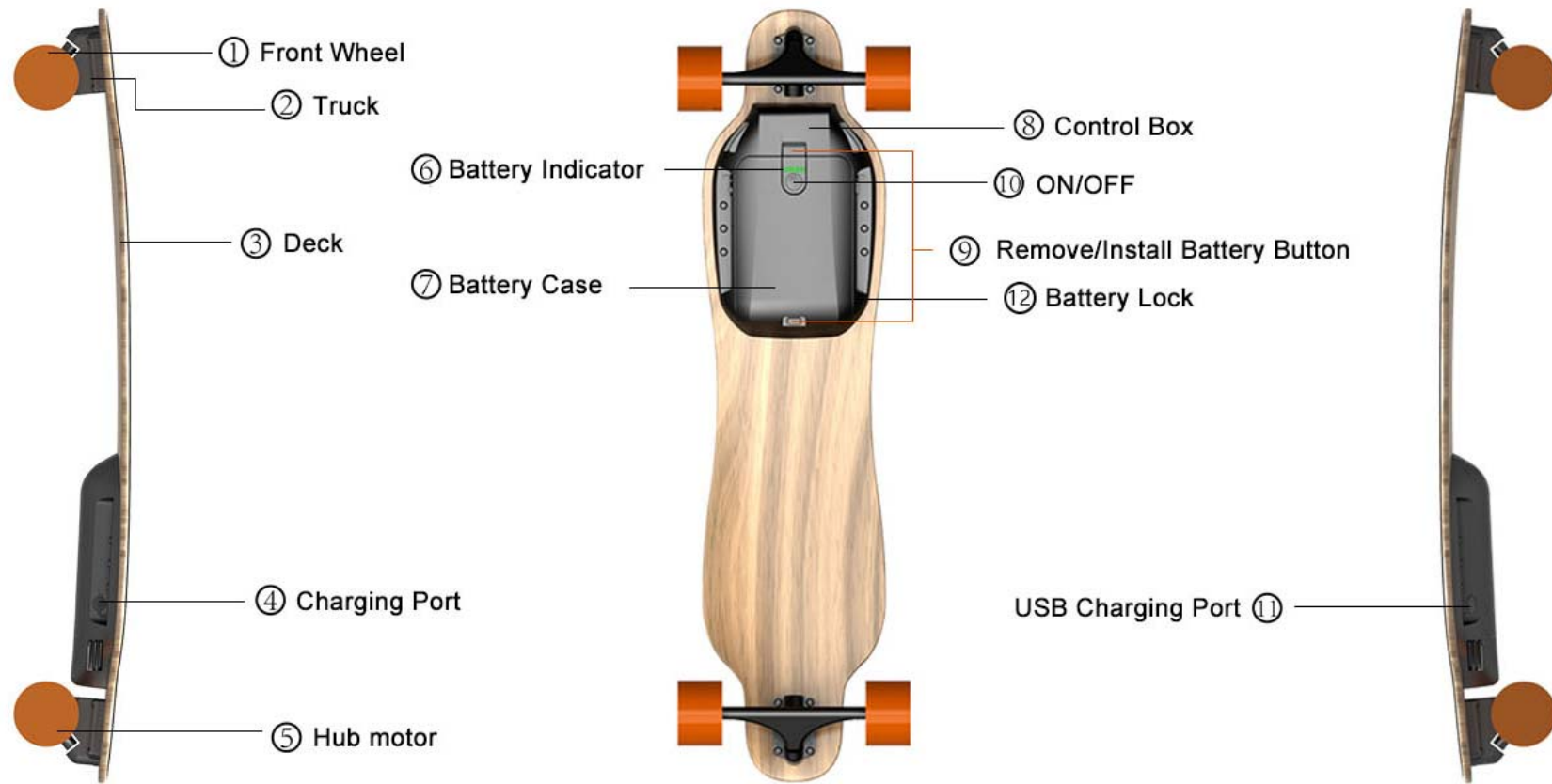

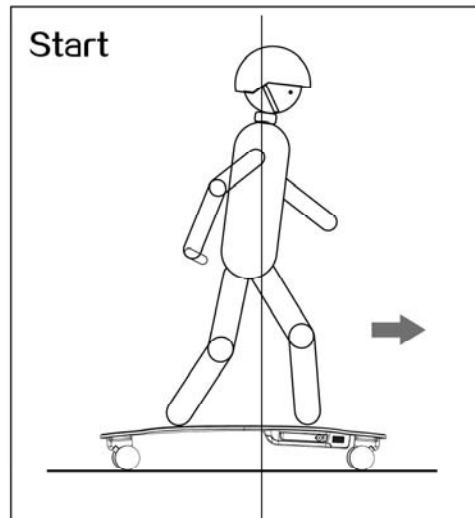

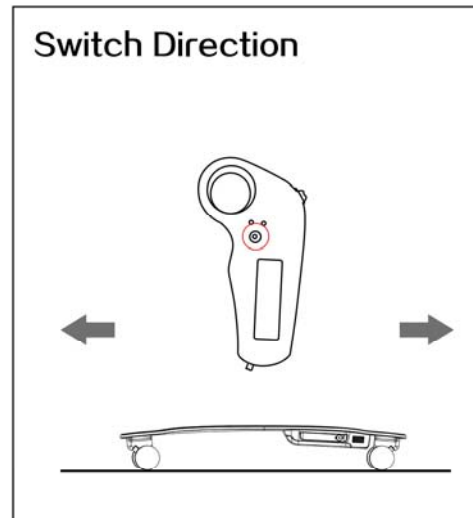
1.2 Bluetooth Remote Controller



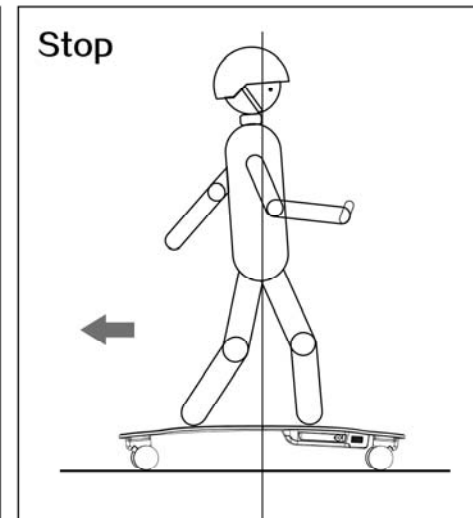
2. Operation



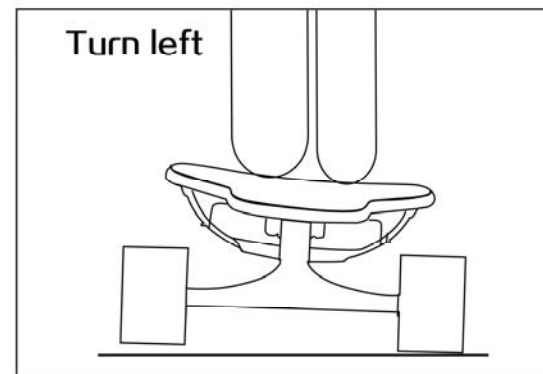
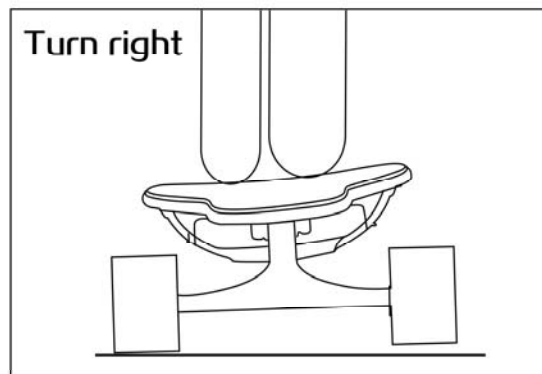
Turn on both P5 and remote controller. Slowly push the accelerator to check the moving direction, Then step on P5 and push the accelerator again to start.



Press the switch direction button then push the accelerator to go forward.



Press the switch direction button then push the accelerator to go forward.



Tilt your body to the left side/right side to turn left/right.

2.1 Turn ON/OFF

⊙P5:

ON : Press the ⑩ON/OFF button about 5 seconds until ⑥Battery Indicator blinks.

OFF : Press the ⑩ON/OFF button on the back about 5 seconds until the red and green lights blink.

⊙Remote controller :

ON : Turn the ② ON/OFF button to left, ②Signal LED blink one time.

OFF : Turn the ② ON/OFF button to right, ②Signal LED off.

2.2 Charging

Please use the original charger only.

⊙P5:

Insert the charger cable to ④Charging Port, ⑥battery indicator lights on from red to green, turn green when full charged, which takes 2-3 hours.

☉ Remote controller:

Connect ⑦Charging Port with ⑦USB Charging Port. ⑦The Charging LED keeps turning red, light off when full, need 1.2hour.

Disclaimer: Must charge and discharge every two months, otherwise battery will be out of work, Supplier won't take responsibility for that.

2.3 Rematch/Reconnect Remote Controller with P5

Rematch with P5 each time you change a new remote controller.

Turn on P5, press ⑩ON/OFF button three times, ⑥Battery Indicator blinks red and green, matching need 20 seconds. Then turn on the remote controller, use tools to press the ⑦Rematch Button 1 time. The ⑦Signal LED will blink if succeed, otherwise failed.

6. Riding Safely

Please well know about following precautions before using.

Attention:

1. Please keep your body balance during riding. Don't hit the brake at a high speed which may cause injury.
2. Please practice P5 at low speed in the open place if you're a new player.
3. Please bear in mind that leave enough time and distance to avoid obstacles and others when you are riding P5.
4. One rider only when riding P5.
5. Please wear protective equipment before you ride such as helmets, knee pads, elbow pads, eye wear, etc.
6. Don't ride P5 in heavy traffics or crowed public place.
7. Prohibit riding P5 on bumpy or wet pavements.
8. Prohibit riding on the ramp over 17°.
10. Prohibit teenagers less than 15 years old and people over 60 years old learning and riding P5. Teenager should use P5 with adult companion.
11. Prohibit those people riding the board after drinking alcohol.
12. Prohibit riding it in rainy days.
13. Don't ride it if self-reasons or other objective factors affect rider not able for riding.

7. After-sales information

Warranty & After sales service

- 1, One year warranty, except the battery and consumables.
- 2, Warranty of Battery and charger is 6 months, and one month for the USB cable.

The following conditions are not included in warranty & after sales service:

- 2, Damage cause by rider's wrong maintenance actions
- 3, The user is not suitable for riding or traffic accidents caused.
