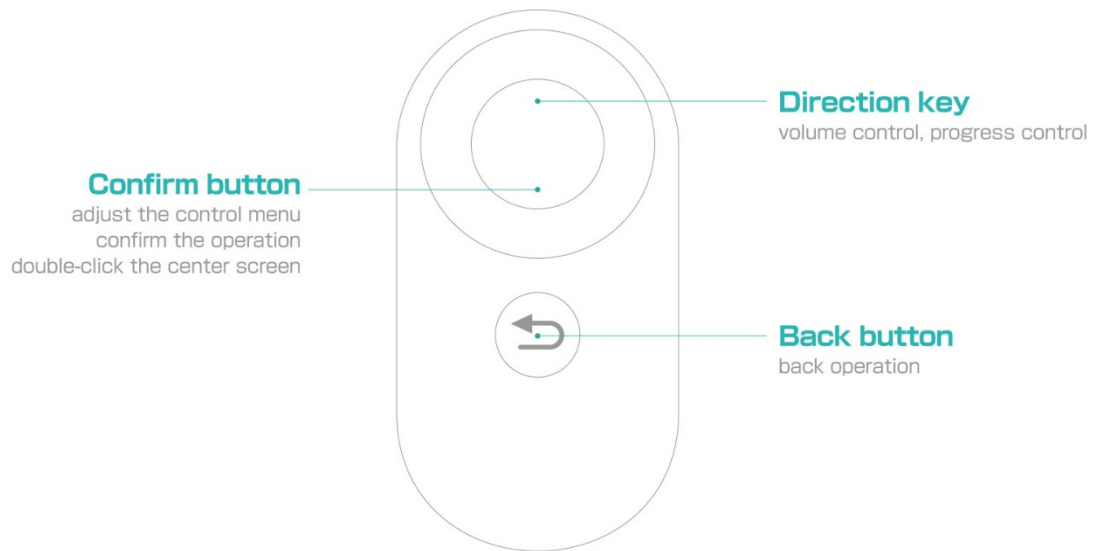

3 Connect PC



After the host successfully connects to the computer, LUCI Home will display the Bluetooth signal that matches the Bluetooth remote control. Click the page to connect according to the prompt. After the connection is successful, you can use the remote control to operate the host.

4 Security reminders
