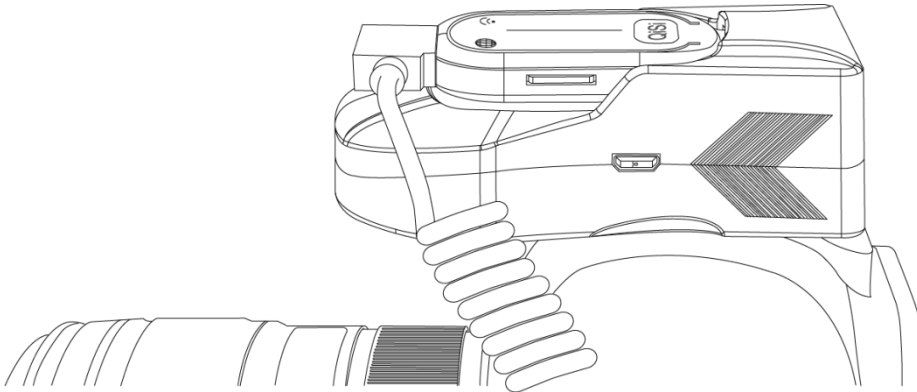


(a) Aurga Dock

Plug the **Aurga**⑤ into to **Aurga Dock**③



**Power On:** Press the Power button ① in 3 seconds, the battery LED ② and Wi-Fi LED ⑦ should be on.

**Power Off:** If the Aurga Docker is on, press the power button ① in 3 seconds,

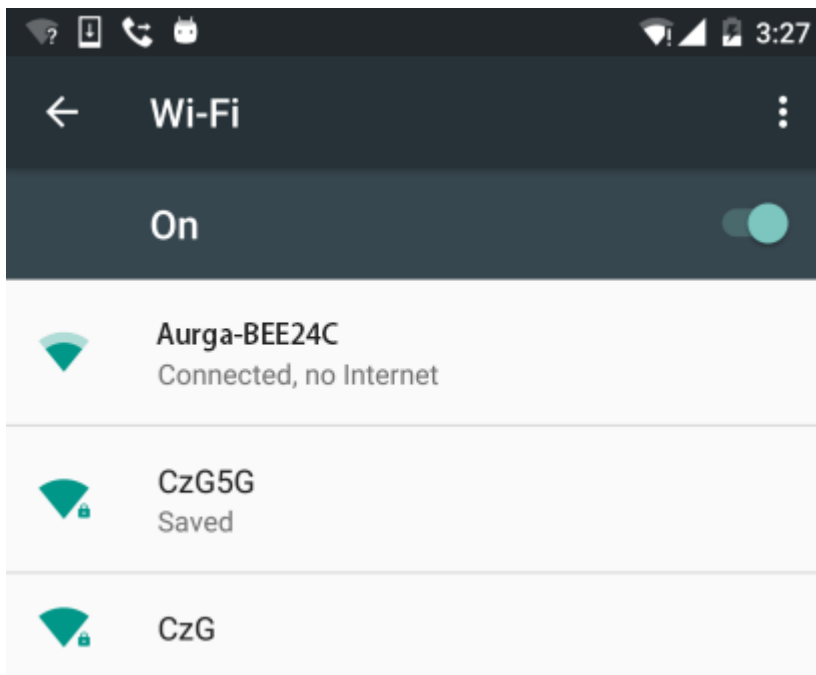
**Charge:** Use phone adapter (5V USB output) as the charger, connect the charge cable to ④

**Connect phone/tablet to Aurga:**

In iOS, go to Settings -> Wi-Fi, connect the Hotspot Aurga-xxxxxx,



In Android, go to Settings -> Wi-Fi, connect the Hotspot Aurga-xxxxxx.



Run the mobile app Aurga on Android or iOS.
