





 Audio FM Transmitter: Intergrated the Bluetooth-FM transmitter in the Smart Pillow and controlled by App.



Fasten the Buckle Belt after pull up the headrest of car seat.



Fix the velcro of Pillow Belt firmly with Buckle Belt, then connect the USB Cable to USB power supply. (More information in the Tracebird App)

6 Storage and maintenance

- ▶ Do not unbuckle USB cable from cable slot, which could lead to cable or circuit failure:
- ▶ Clean the Smart Pillow with a soft dry cloth.
