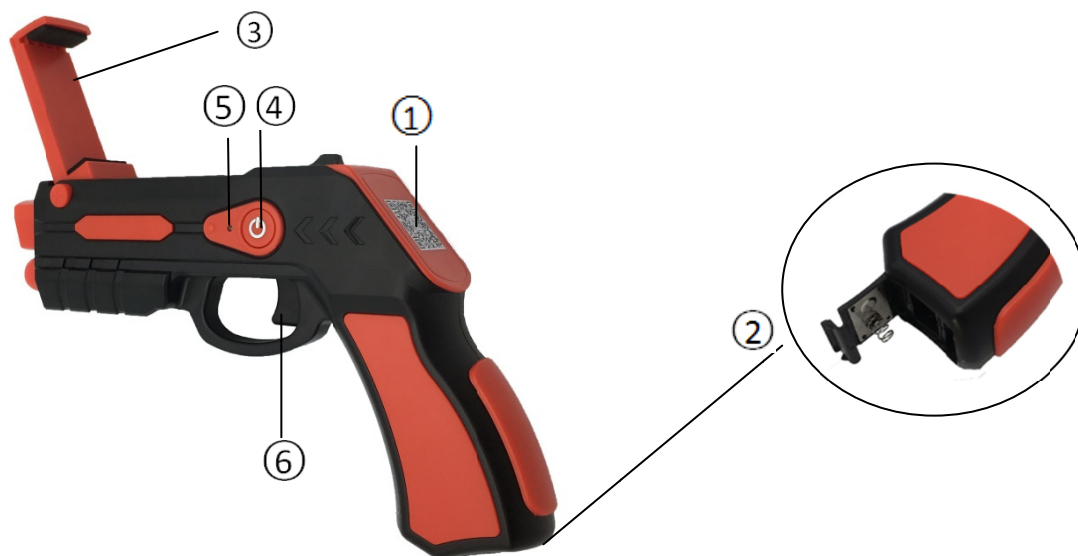

USER GUDIE:

1. Scan the QR code on item to download APP"AR GUN" (Also can download APP at Appstore or Google)



2. Put on 2pcs AAA battery in the AR gun.
3. Turn on the Bluetooth on your phone device.(No need pairing, APP will connect Bluetooth automatically)
4. Press the switch button 3 seconds until the indication light flash in blue light. (And when press trigger, can see strong blue light)
5. Open the mobile phone holder on the gun and fix our phone on the phone holder.
6. Turn on the APP"AR GUN", Pull the trigger and it will be connected automatically
7. Star the game.
