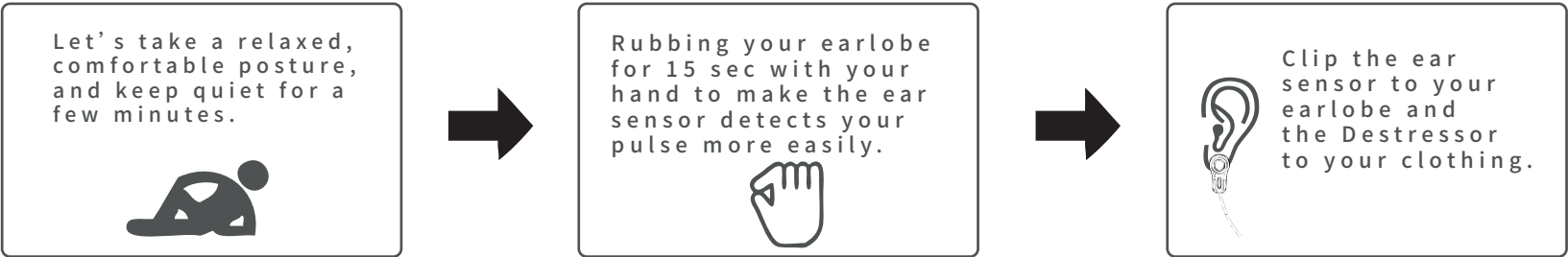
What are the LED status indicators on the Eureka Destressor?
