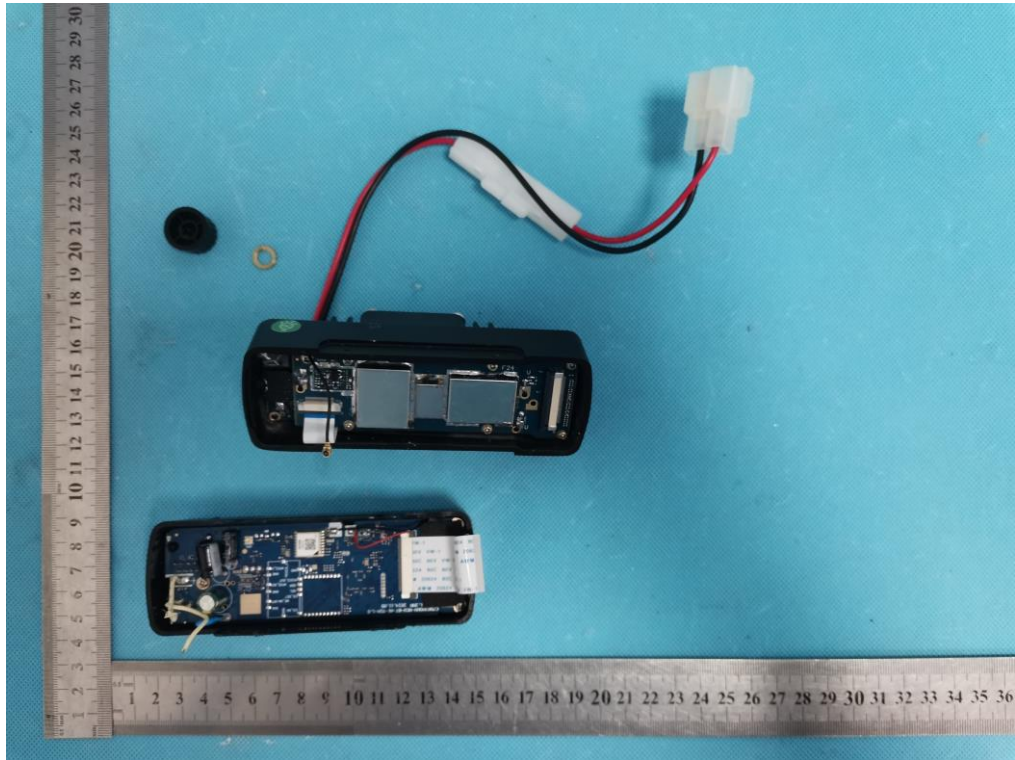
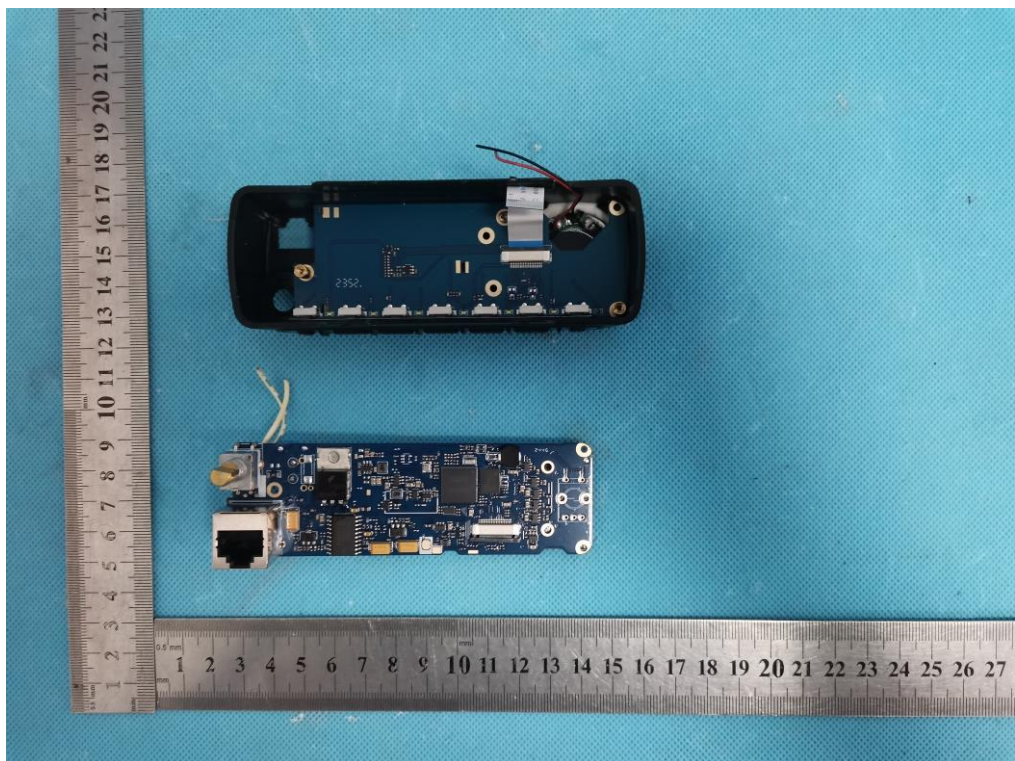

OPEN VIEW OF EUT(FIGURE 1)

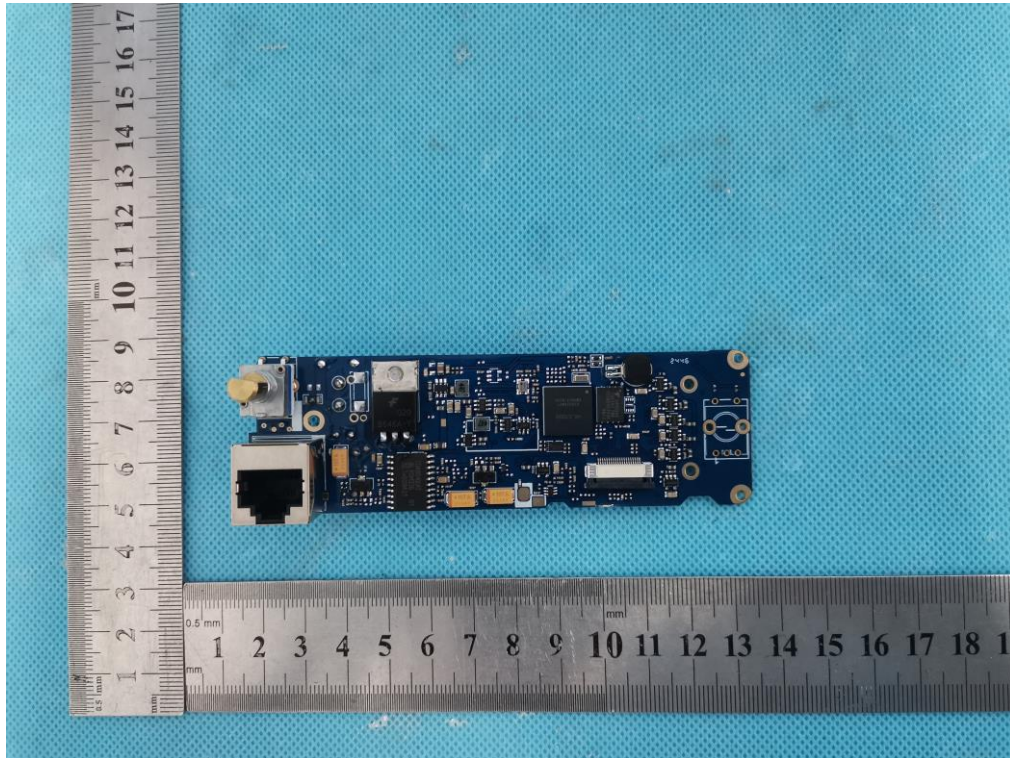


OPEN VIEW OF EUT(FIGURE 2)

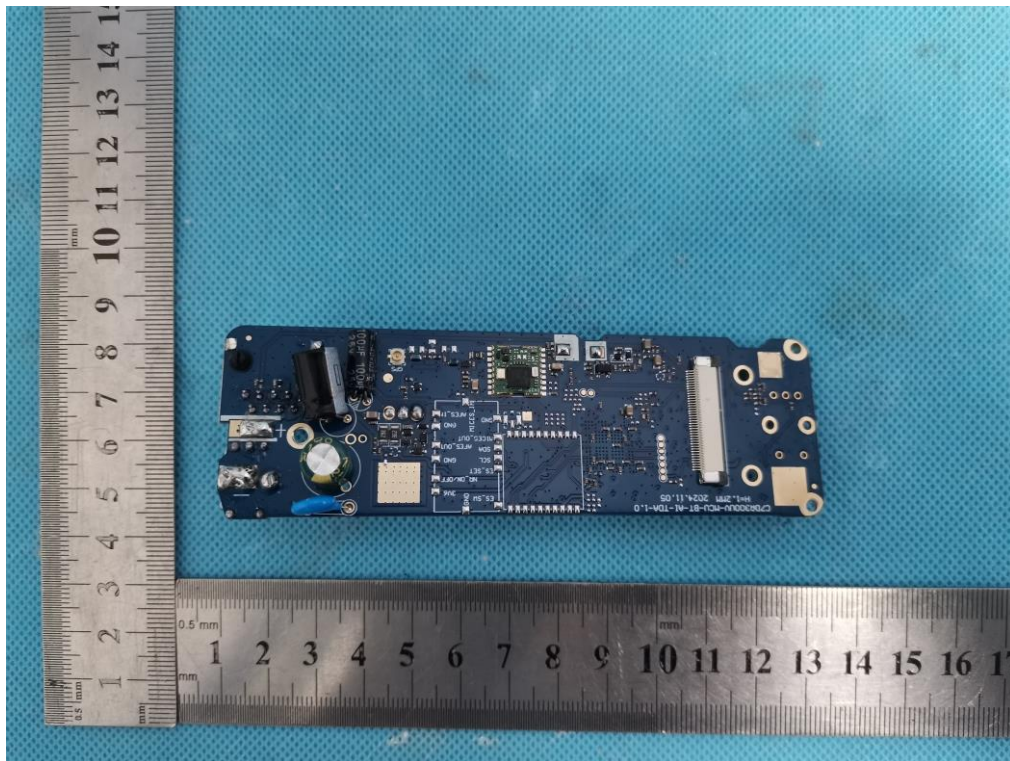

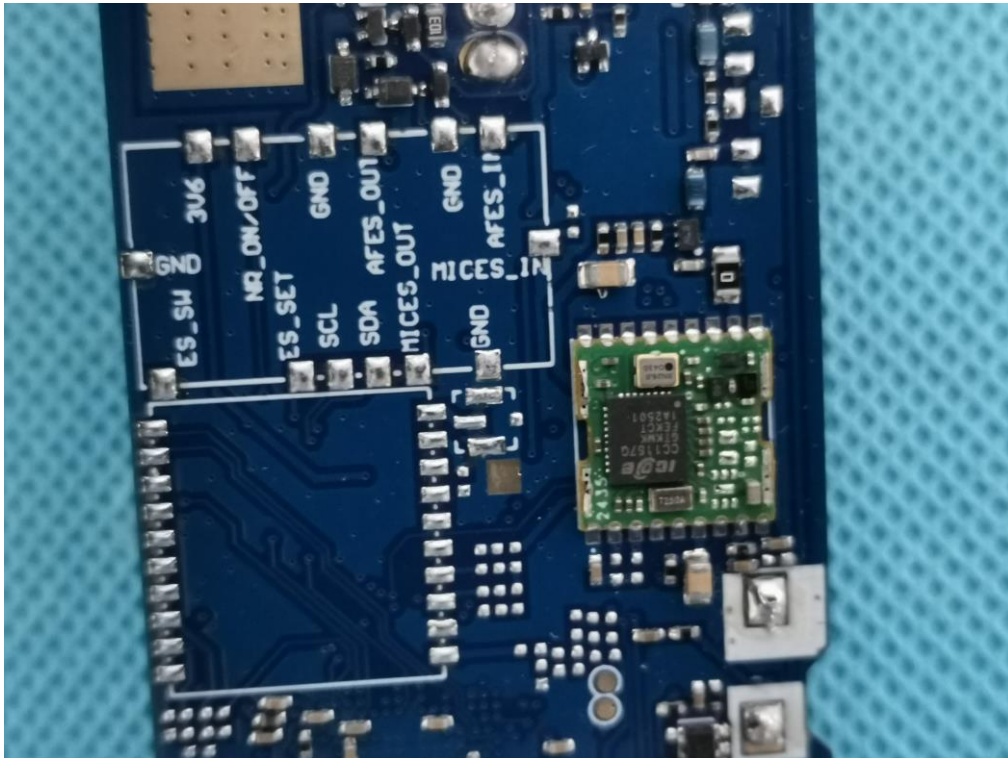

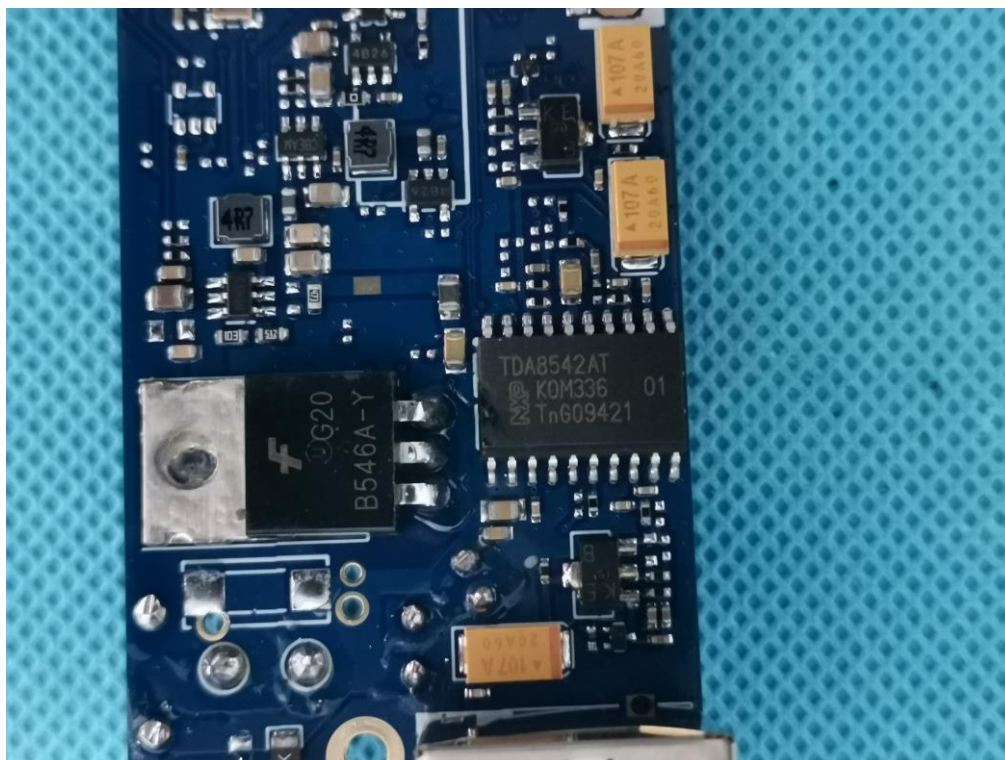

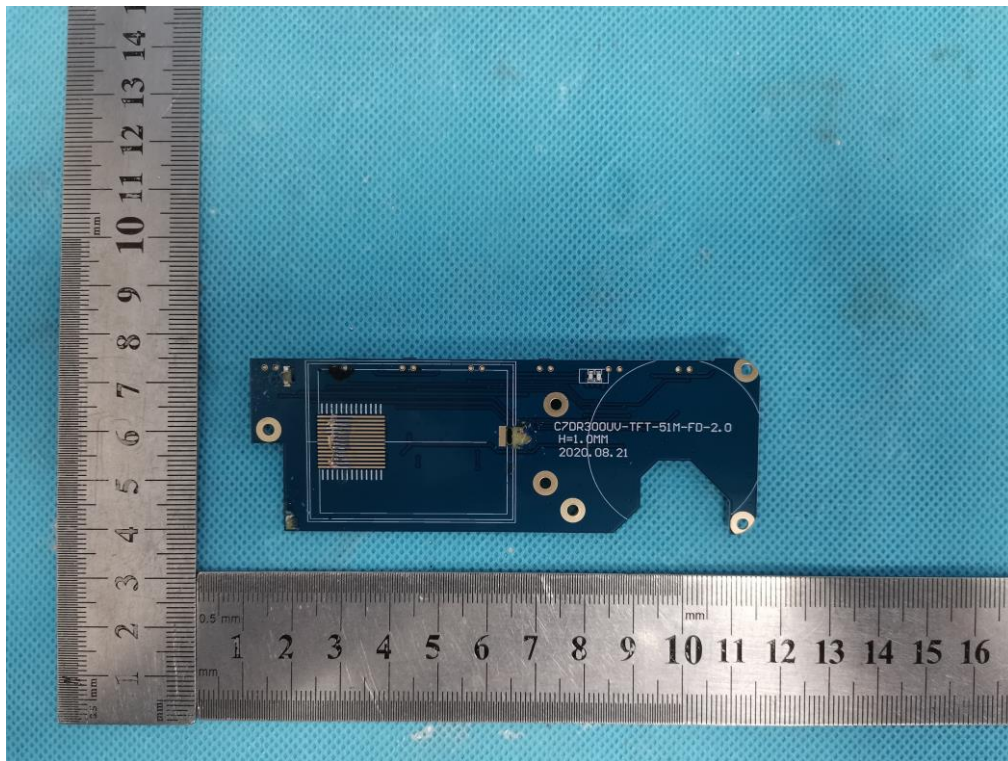

INTERNAL VIEW OF EUT(FIGURE 5)



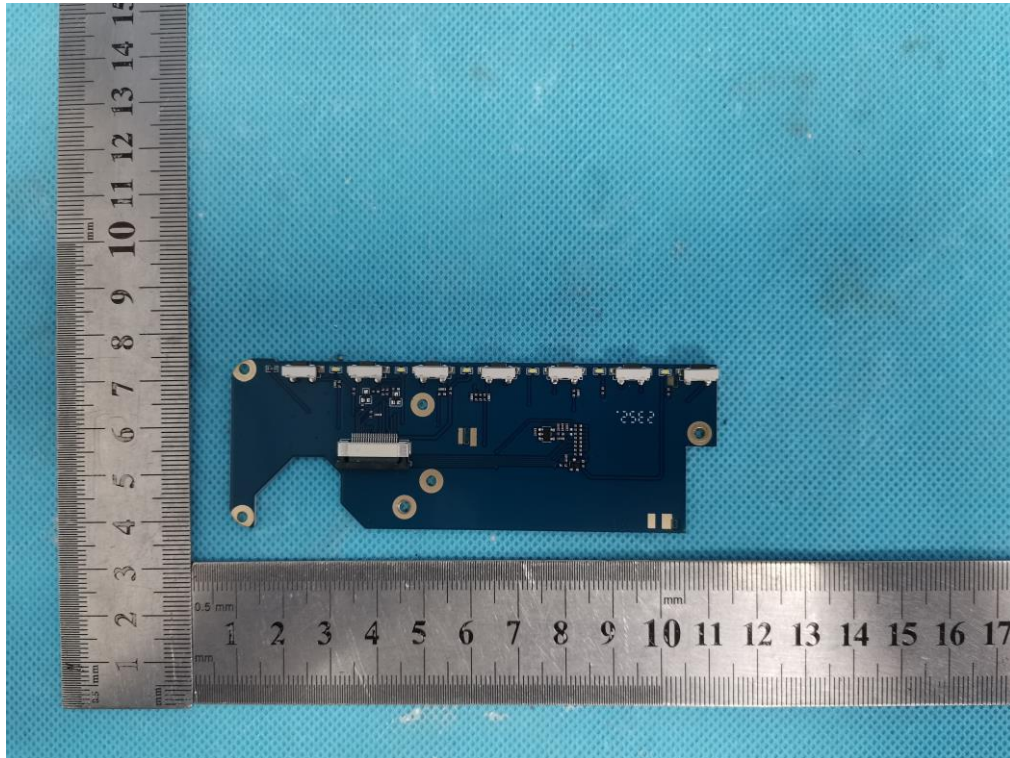

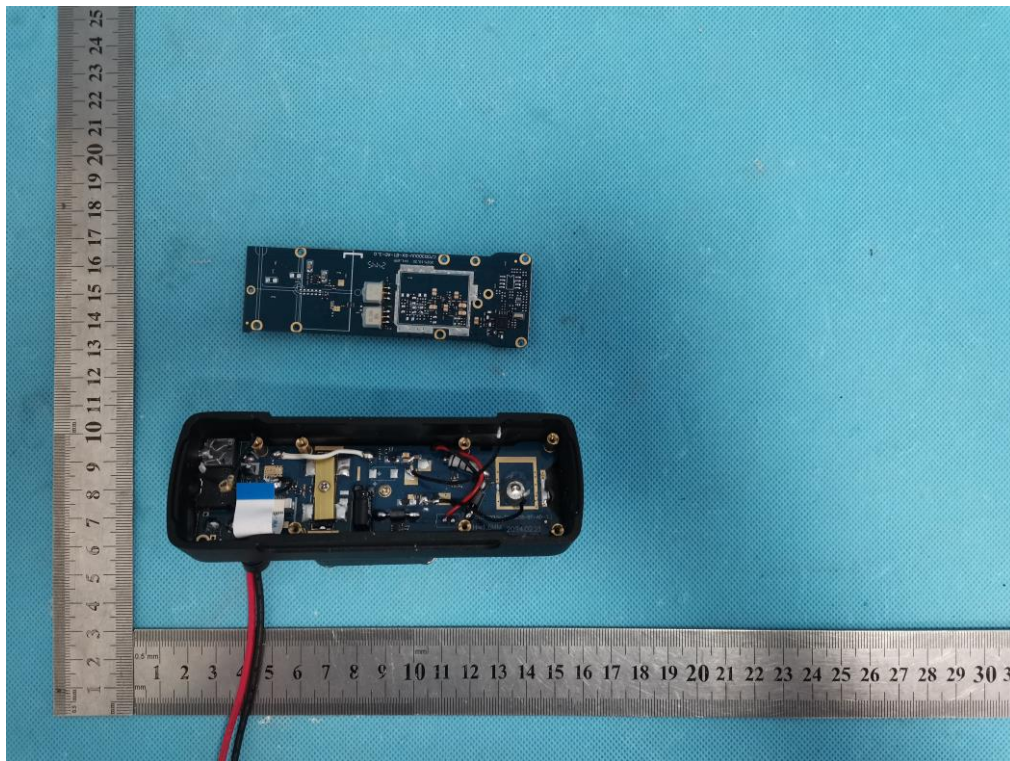

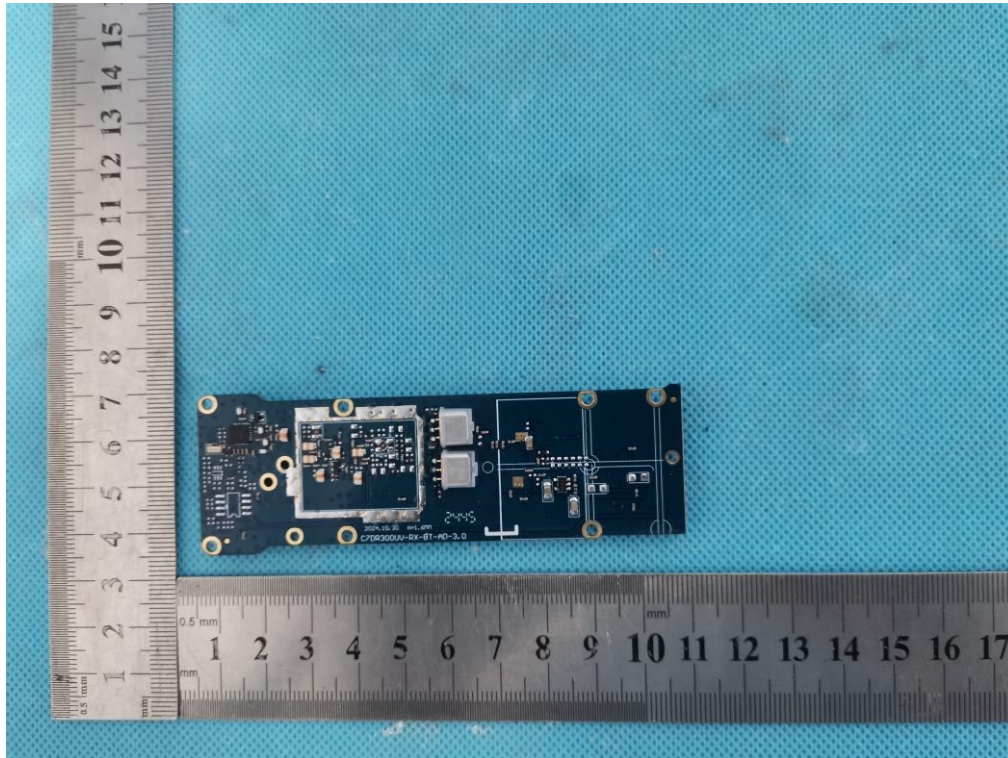


INTERNAL VIEW OF EUT(FIGURE 8)

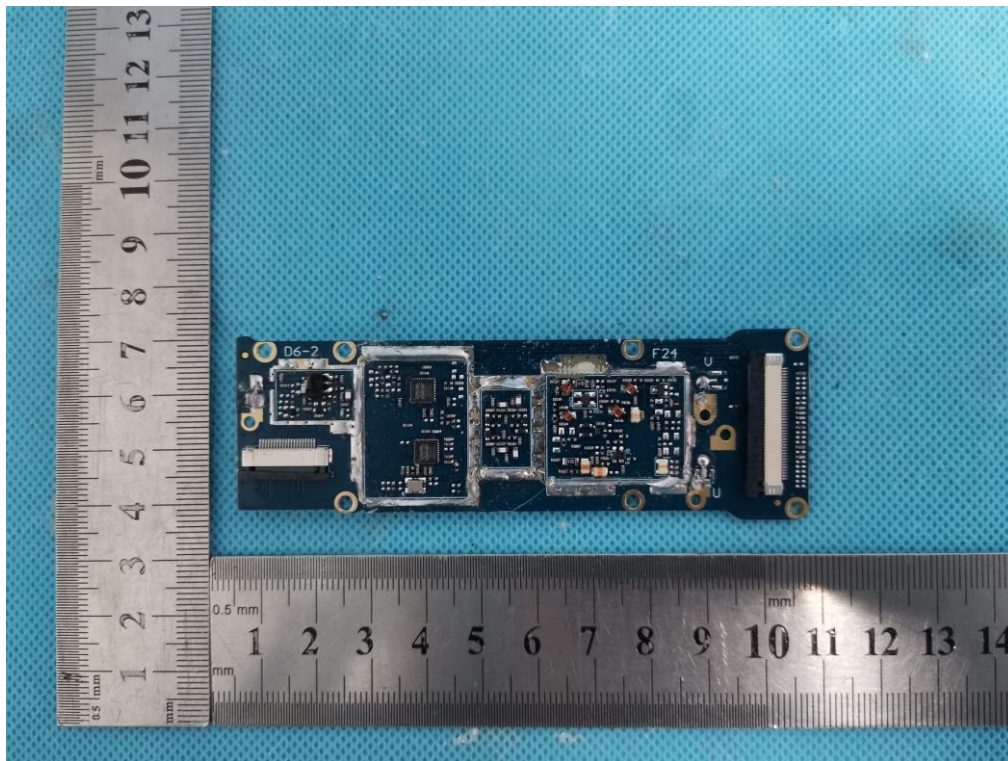

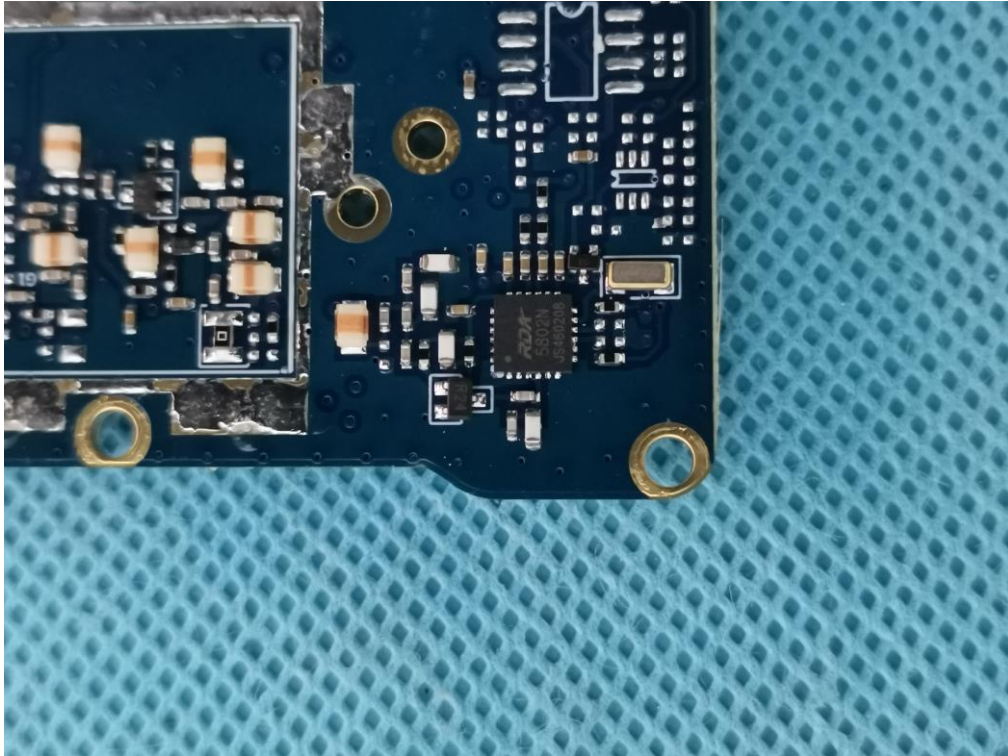

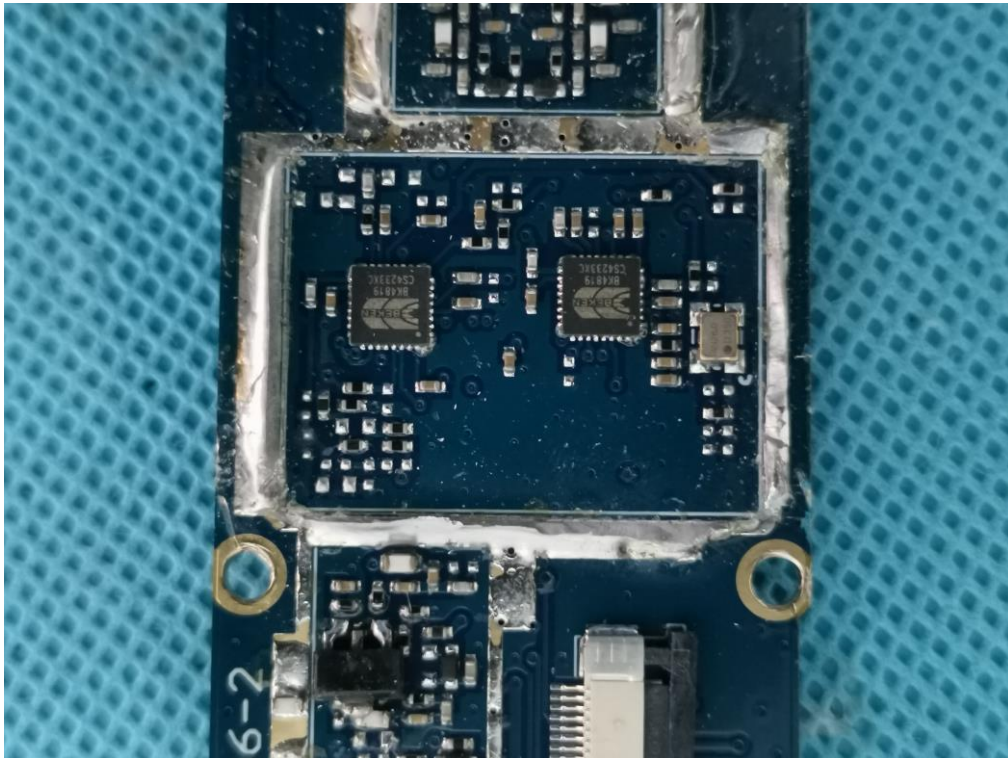

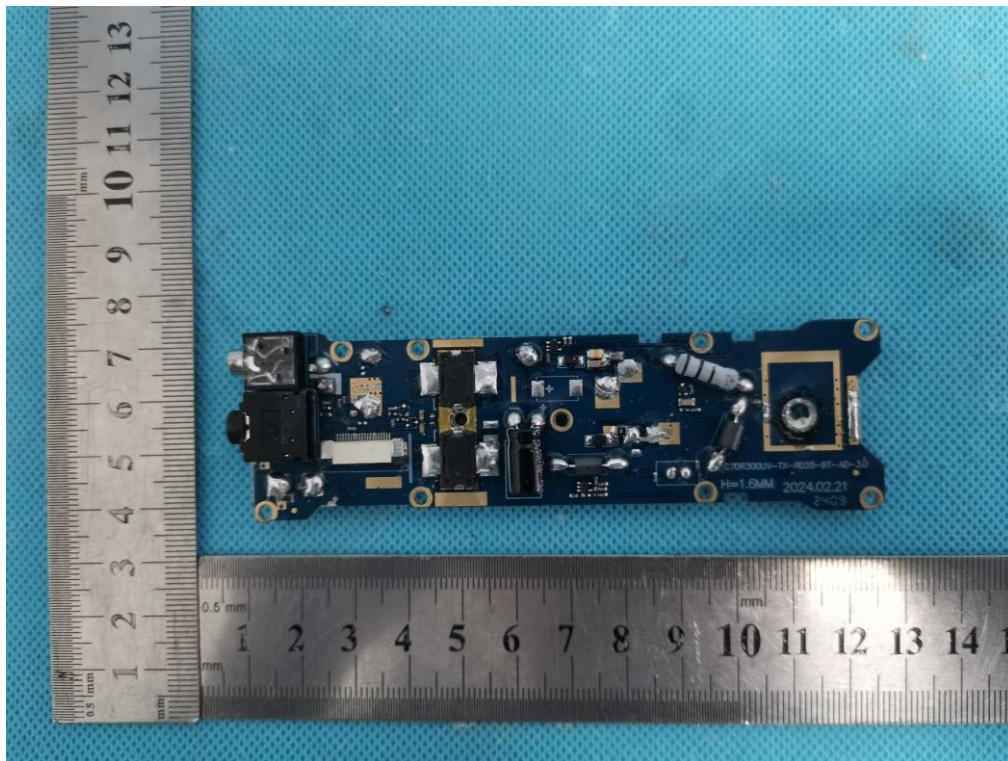

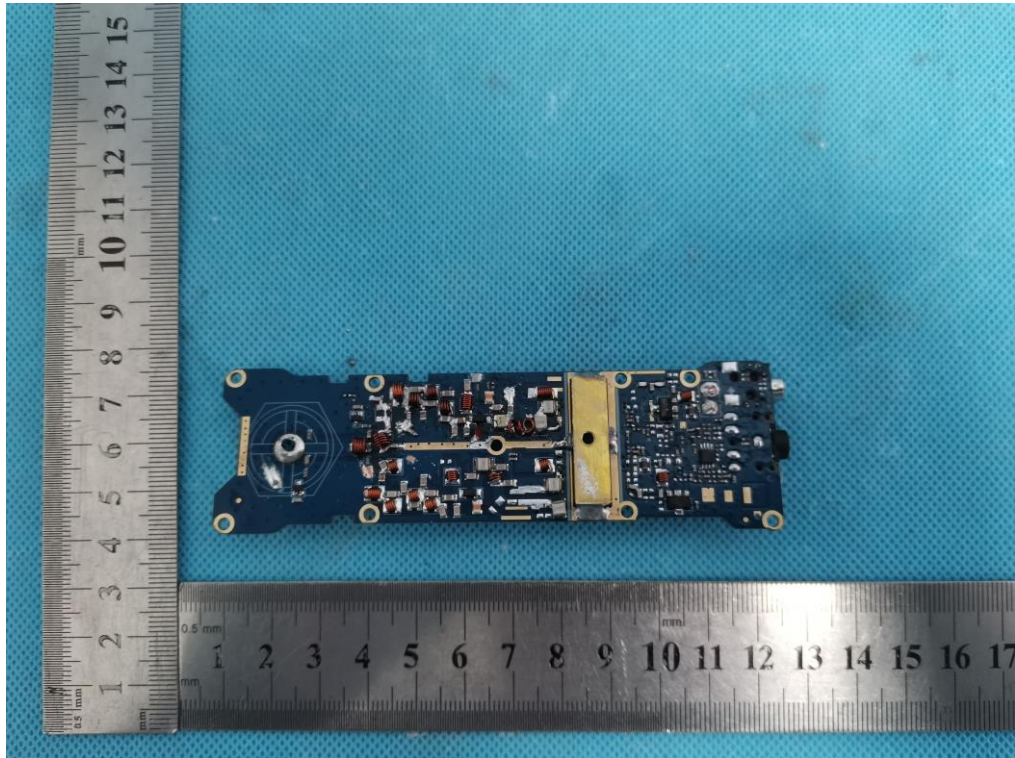

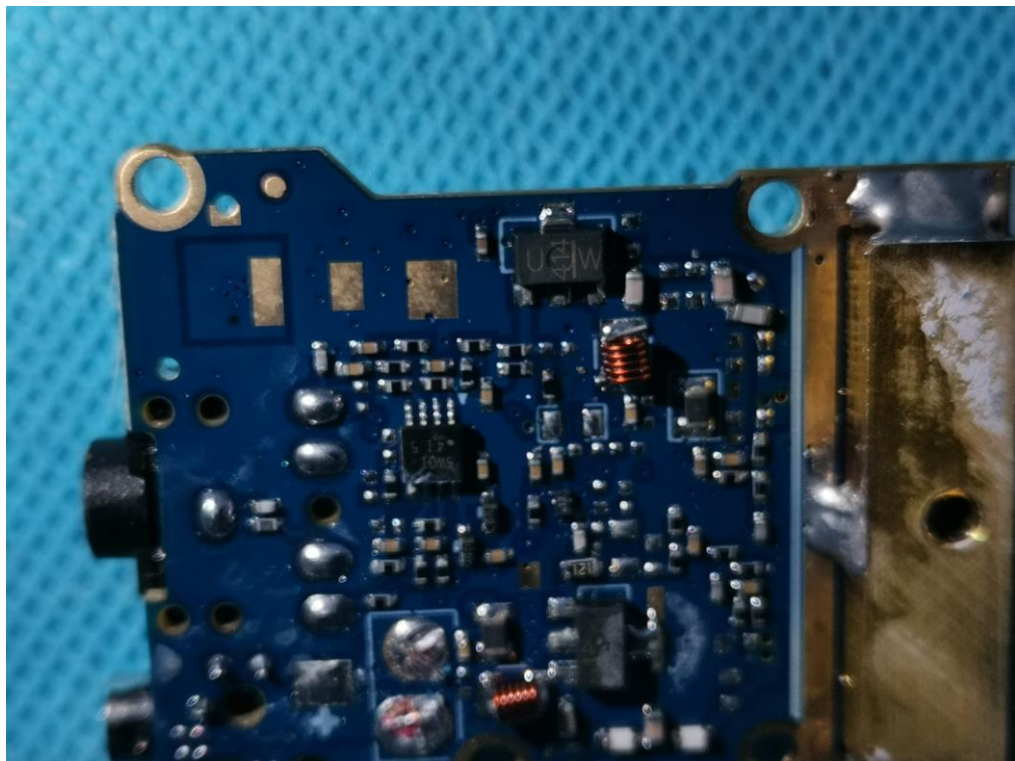

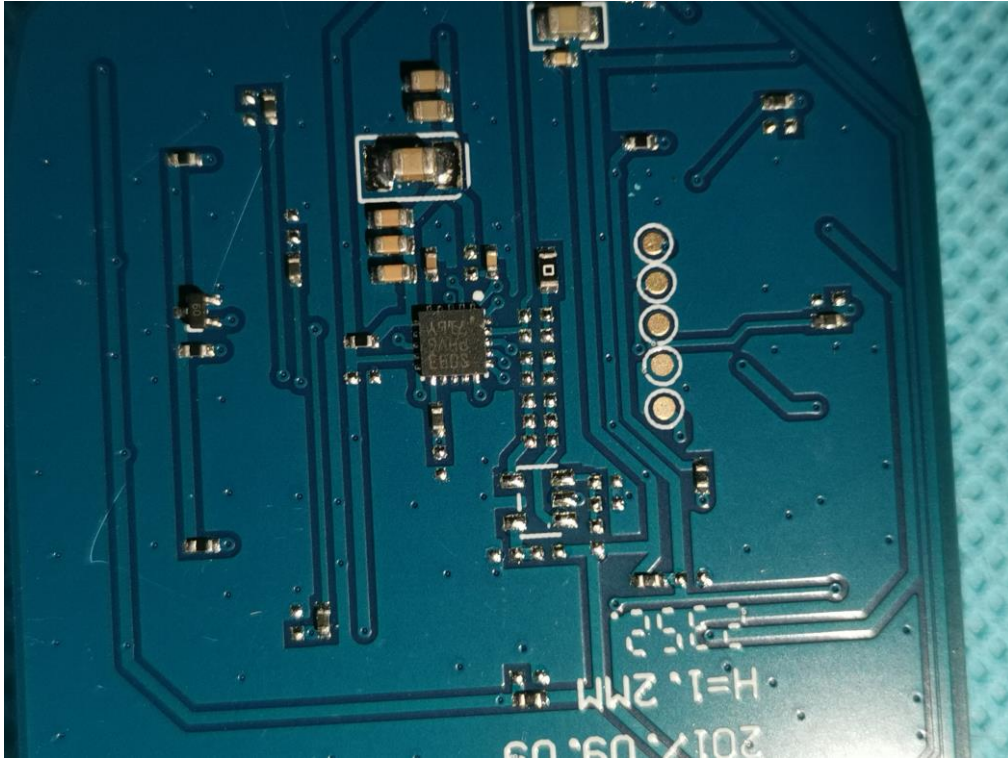

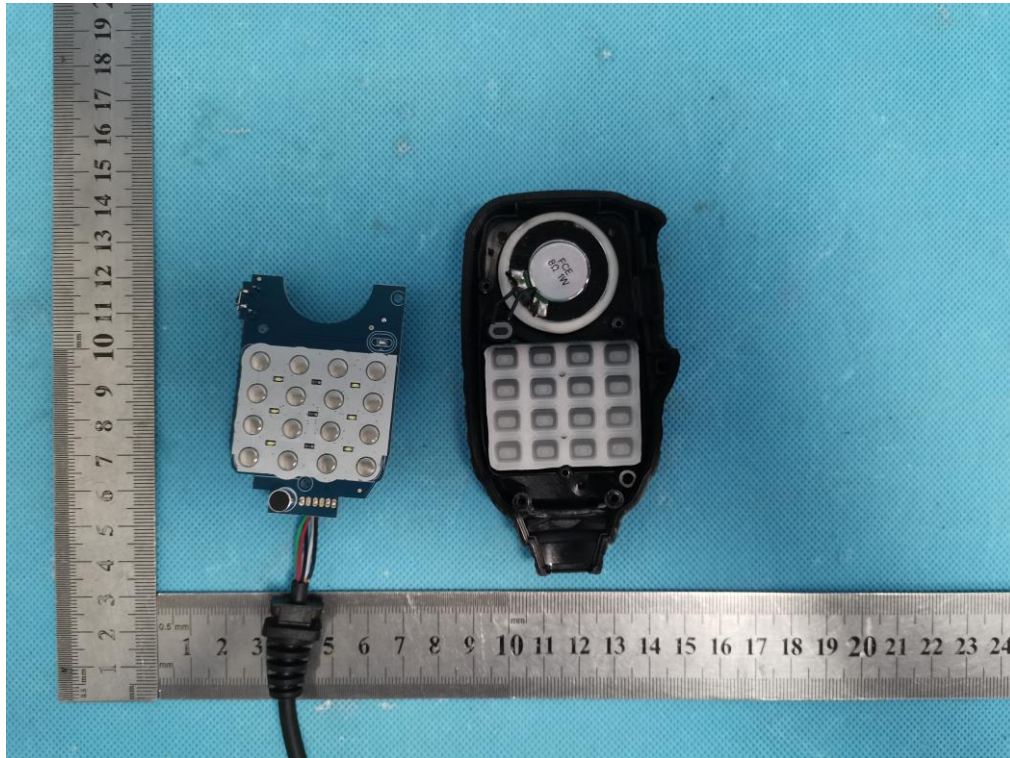

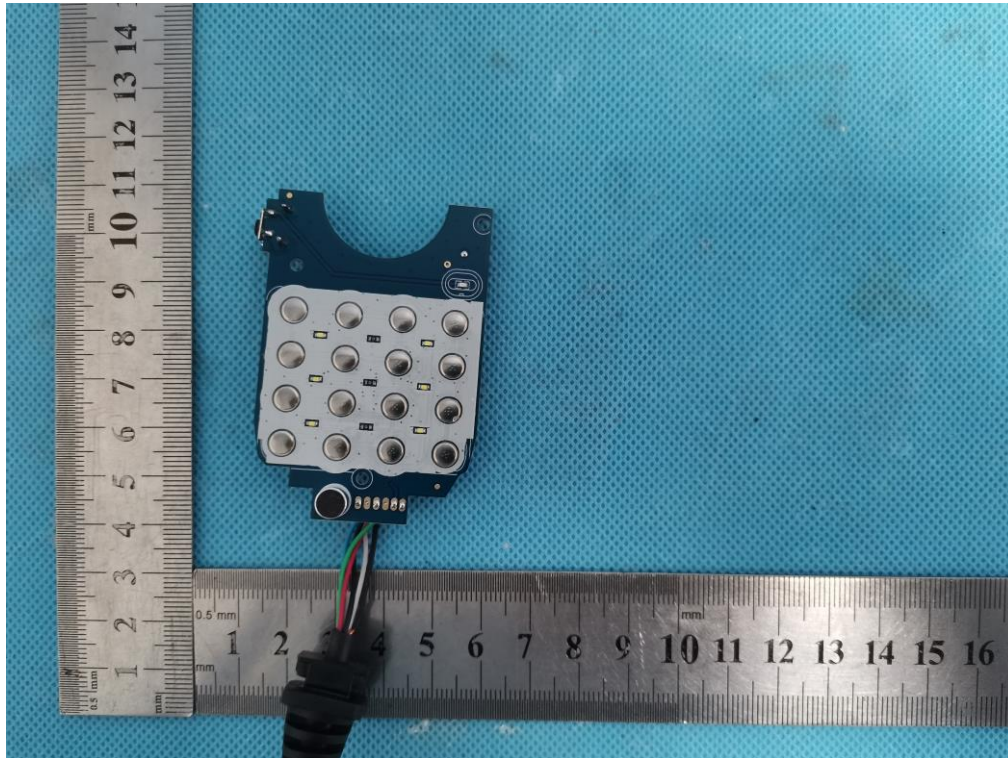
