1.10. Duty Cycle of EUT

Regarding to KDB 558074 D01 DTS Meas Guidance v04, 6.0, the maximum duty cycles of all modes were investigated and set the spectrum analyzer as below:

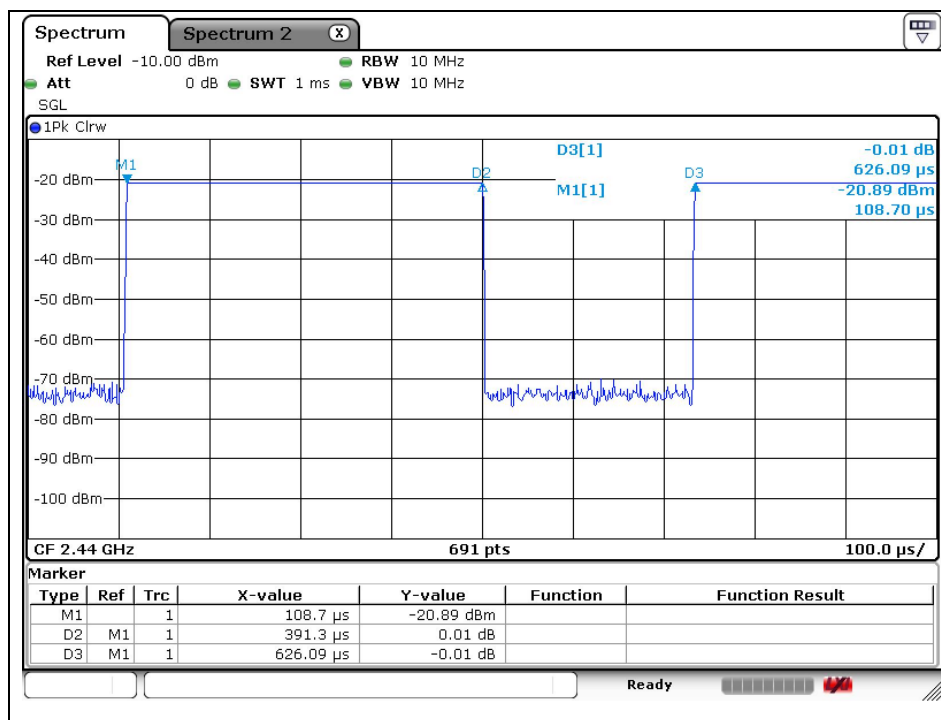
Set RBW \geq OBW if possible; otherwise, set RBW to the largest available value. Set detector = peak or average. The zero-span measurement method shall not be used unless both RBW and VBW are $> 50/T$ and the number of sweep points across duration T exceeds 100.

Duty cycle (%)	62.50
Correction factor (dB)	2.04

Remark:

1. As measured duty cycles of EUT, all of mode and data rate keep constant period and are converted to log scale (power averaging) to compensate correction factor to result of average test items.

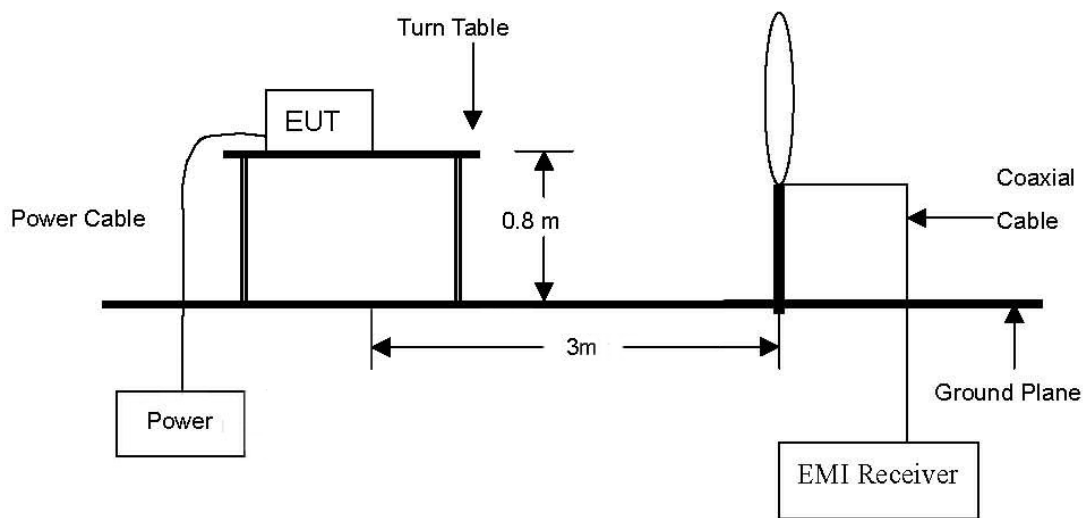

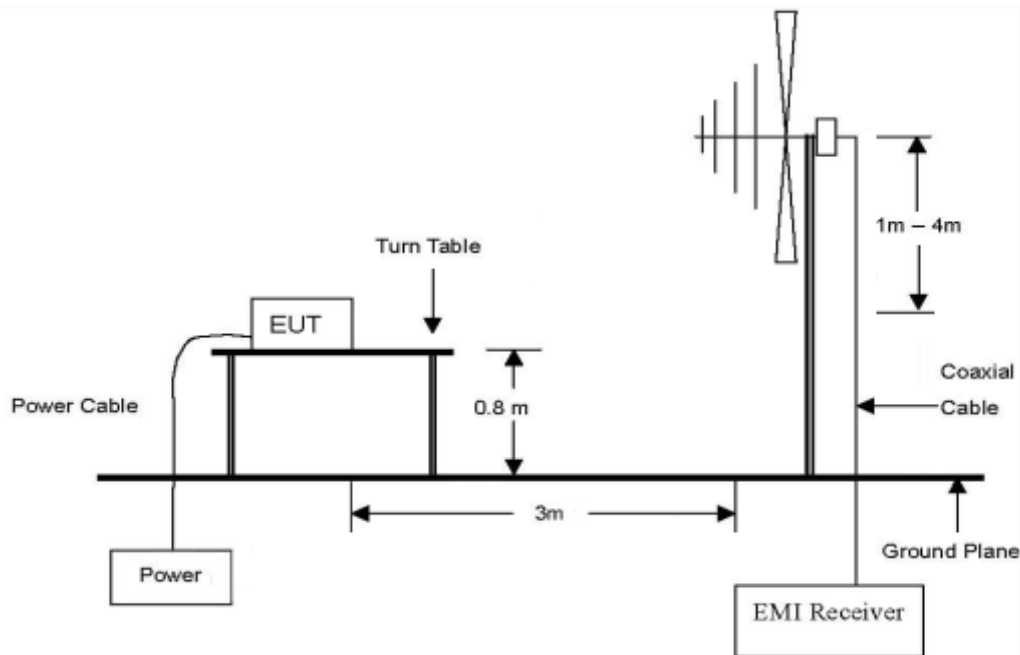

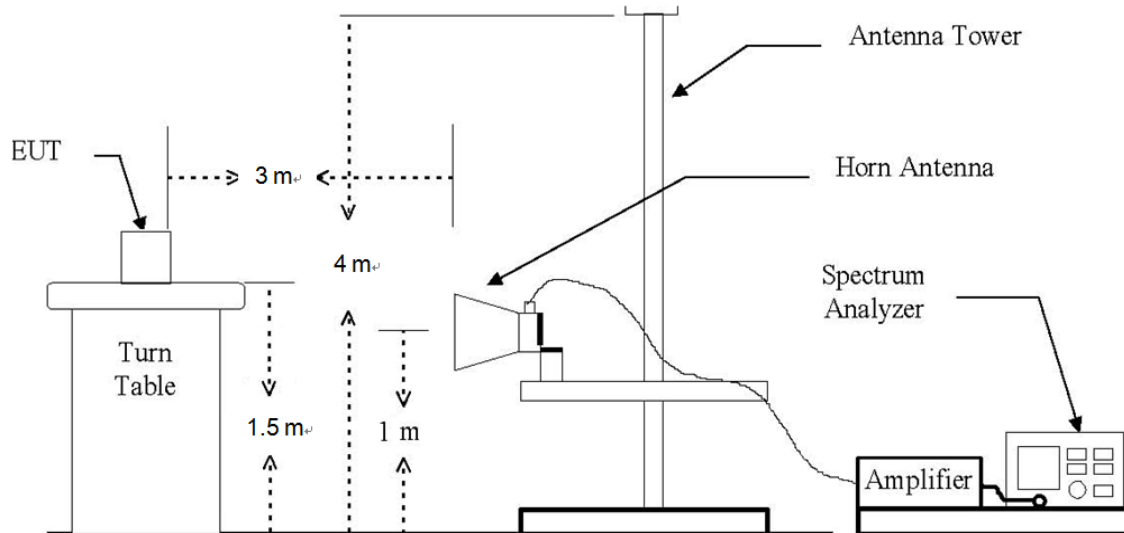

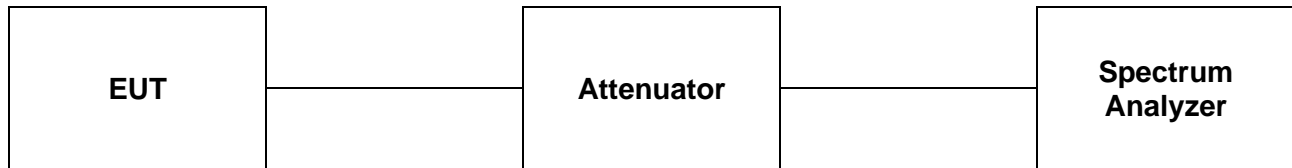

2.2. Limit

2.2.1. FCC

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which fall in the restricted bands, as defined in section §15.205(a), must also comply with the radiated emission limits specified in section §15.209(a) (see §15.205(c)).

According to §15.209(a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

However, operation within these frequency bands is permitted under other sections of this part, e.g., §§15.231 and 15.241.

2.2.2. IC

According to RSS-247 Issue 1 5.5, in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

According to RSS-Gen Issue 4 8.9, except when the requirements applicable to a given device state otherwise, emissions from licence-exempt transmitters shall comply with the field strength limits shown in Table 4 and Table 5 below. Additionally, the level of any transmitter emission shall not exceed the level of the transmitter's fundamental emission.

If an average limit is specified for the EUT, then the peak emission shall also be measured with instrumentation properly adjusted for such factors as pulse desensitization to ensure the peak emission is less than 20 dB above the average limit.

Note: Transmitting devices are not permitted in restricted frequency bands unless stated otherwise in the specific RSS.

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates in section 11.0 & 12.0 of KDB 558074 D01 DTS Meas Guidance v04 and ANSI C63.10 2013.

2.3.1. Test Procedures for emission below 30 MHz

1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
3. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
4. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum Hold Mode.

Note;

Although these tests were performed other than open field test site, adequate comparison measurements were confirmed against 30 meter open field test site. Therefore sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 414788 D01 Radiated Test Site v01.

2.3.2. Test Procedures for emission from above 30 MHz

1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site below 1 GHz and 1.5 meters above the ground at a 3 meter anechoic chamber test site above 1 GHz. The table was rotated 360 degrees to determine the position of the highest radiation.
2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meter away from the interference-receiving antenna.
3. The antenna is a bi-log antenna, a horn antenna and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
5. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
6. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE;

1. Unwanted Emissions into Non-Restricted Frequency Bands

- The Reference Level Measurement refer to section 11.2

Set analyzer center frequency to DTS channel center frequency, SPAN ≥ 1.5 times the DTS bandwidth, the RBW = 100 kHz and VBW $\geq 3 \times$ RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold.

- Unwanted Emissions Level Measurement refer to section 11.3

Set the center frequency and span to encompass frequency range to be measured, the RBW = 100 kHz and VBW $\geq 3 \times$ RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold.

2. Unwanted Emissions into Restricted Frequency Bands

- Peak Power measurement procedure refer to section 12.2.4

Set RBW = as specified in Table 1, VBW $\geq 3 \times$ RBW, Detector = Peak, Sweep time = auto, Trace = Max hold.

-Average Power measurements procedure refer to section 12.2.5.2

The EUT shall be configured to operate at the maximum achievable duty cycle.

Measure the duty cycle, x, of the transmitter output signal as described in section 6.0.

Set RBW = 1 MHz, VBW $\geq 3 \times$ RBW, Detector = RMS, if span / (# of points in sweep) \leq (RBW/2).

Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied then the detector mode shall be set to peak.

Averaging type = power (i.e., RMS).

As an alternative the detector and averaging type may be set for linear voltage averaging.

Some instruments require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used. Sweep time = auto, Perform a trace average of at least 100 traces.

A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:

- 1) If power averaging (RMS) mode was used in step f), then the applicable correction factor is $10 \log(1/x)$, where x is the duty cycle.

3. To get a maximum emission level from the EUT, the EUT is manipulated through three orthogonal planes (X, Y, Z). Worst orthogonal plan of EUT is **Y – axis** during radiation test.

2.3.3. Test Procedures for Conducted Spurious Emissions

Per the guidance of KDB 558074 D01 DTS Meas Guidance v04, section 11.1 & 11.2 & 11.3, the reference level for out of band emissions is established from the plots of this section since the band edge emissions are measured with a RBW of 100 kHz. This reference level is then used as the limit in subsequent plots for out of band spurious emissions shown in section 2.4.3. The limit for out of band spurious emission at the band edge is 20 dB below the fundamental emission level measured in a 100 kHz bandwidth.

1. Conducted Emissions at Band Edge

- The Measurement refer to section 11.2

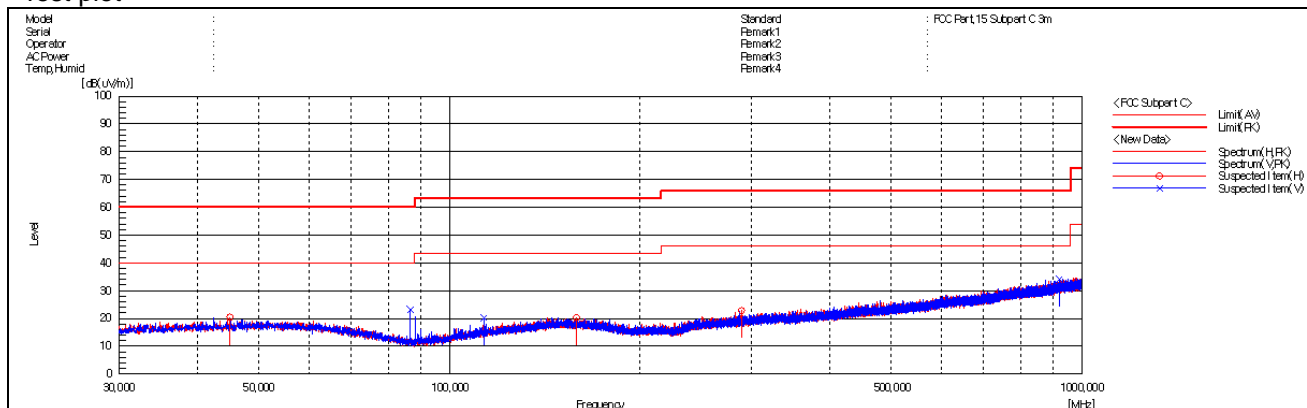

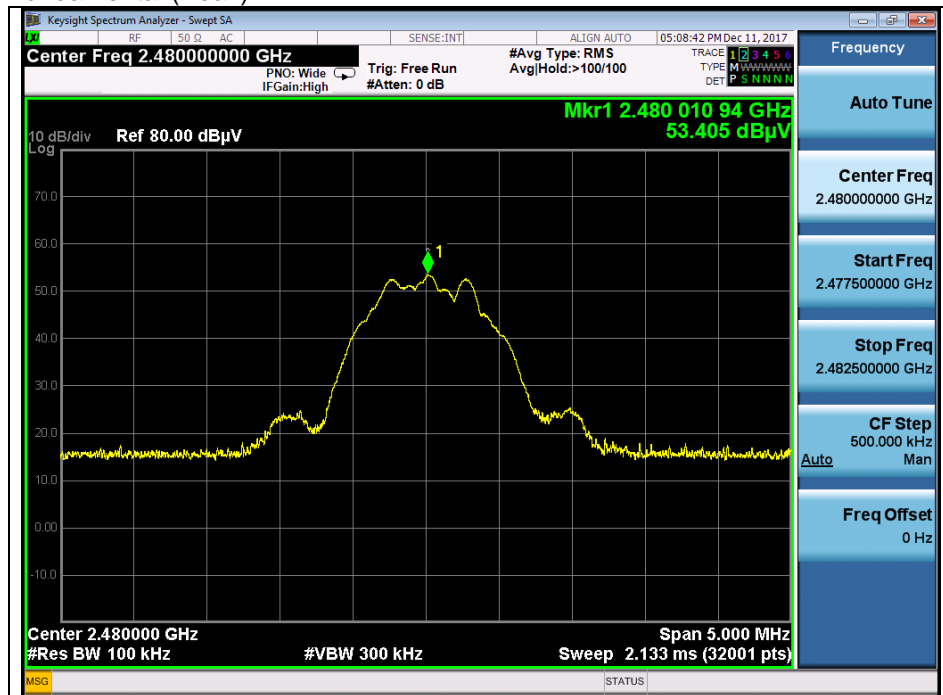


Middle Channel Fundamental (Peak)

Low channel 3rd harmonic (Peak)

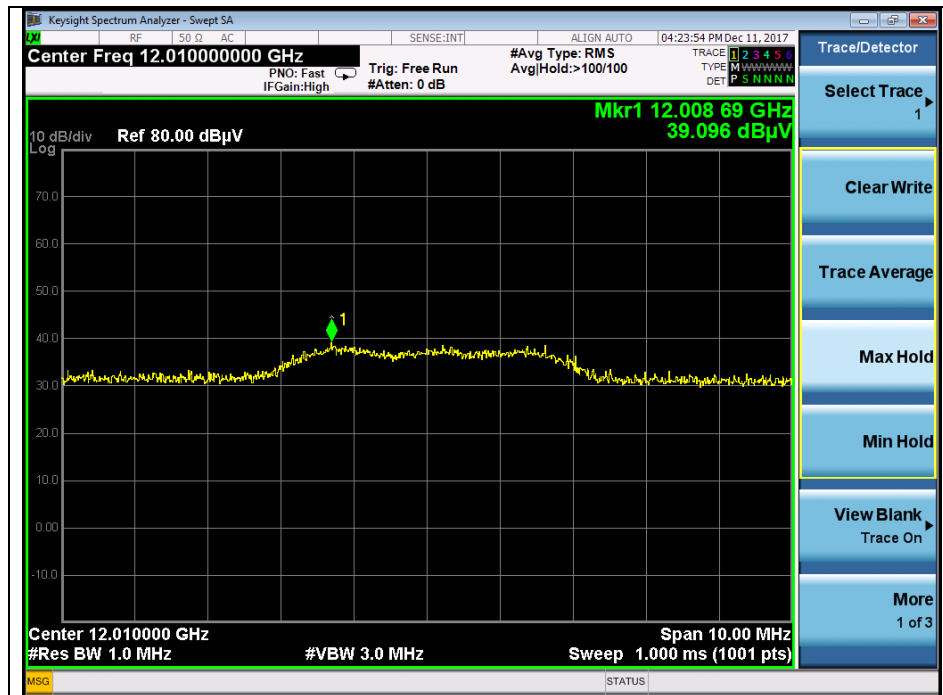


Low channel 4th harmonic (Peak)

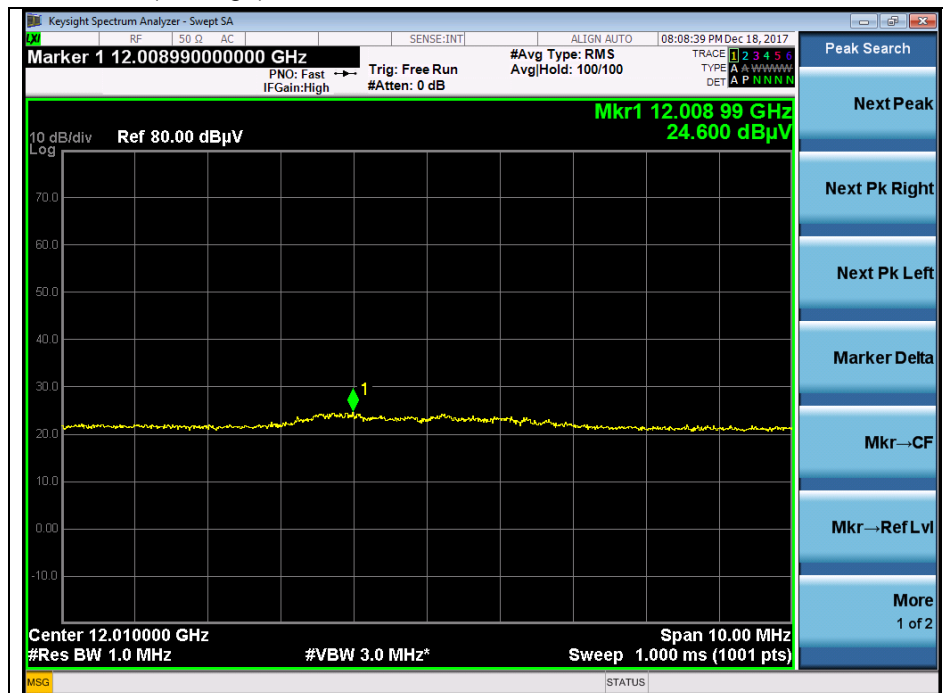

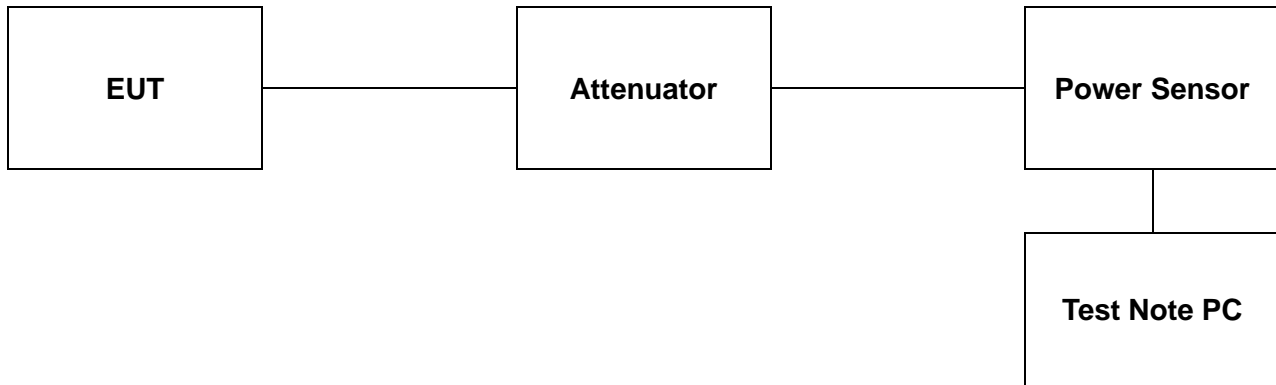

4.2. Limit

4.2.1. FCC

According to §15.247(b)(3), for systems using digital modulation in the 902-928 MHz, 2 400-2 483.5 MHz, and 5 725-5 850 MHz bands : 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4), the conducted output power limit specified in paragraph (b) of this section is based on the use of antenna with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraph (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

4.2.2. IC

According to RSS-247 Issue 2, 5.4 (d), for DTSs employing digital modulation techniques operating in the bands 902-928 MHz and 2 400-2 483.5 MHz, the maximum peak conducted output power shall not exceed 1 W. The e.i.r.p shall not exceed 4 W, except as provided in section 5.4(e),

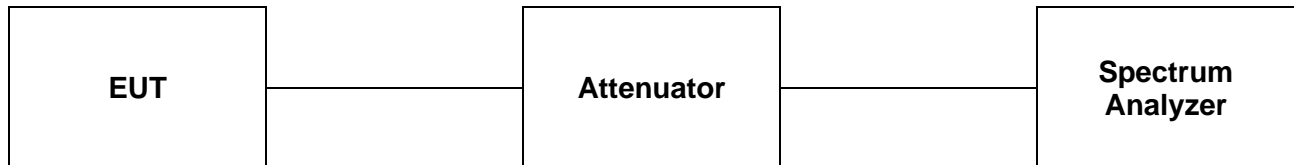

5.1. Test Setup



5.2. Limit

5.2.1 FCC

According to §15.247(e), for digitally modulated system, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

5.2.2 IC

According to RSS-247 Issue 2, 5.2 (b), the transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of section 5.4(d), (i.e. the power spectral density shall be determined using the same method as is used to determine the conducted output power).

5.3. Test Procedure

The measurements are recorded using the PKPSD measurement procedure in section 10.2 of KDB 558074 D01 DTS Meas Guidance v04.

- This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance, and is optional if the maximum conducted (average) output power was used to demonstrate compliance.

1. Set analyzer center frequency to DTS channel center frequency.
2. Set the span to at least 1.5 times the DTS bandwidth.
3. Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
4. Set the VBW $\geq 3 \times \text{RBW}$.
5. Detector = Peak.
6. Sweep time = auto couple.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.
9. Use the peak marker function to determine the maximum amplitude level within the RBW.
10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

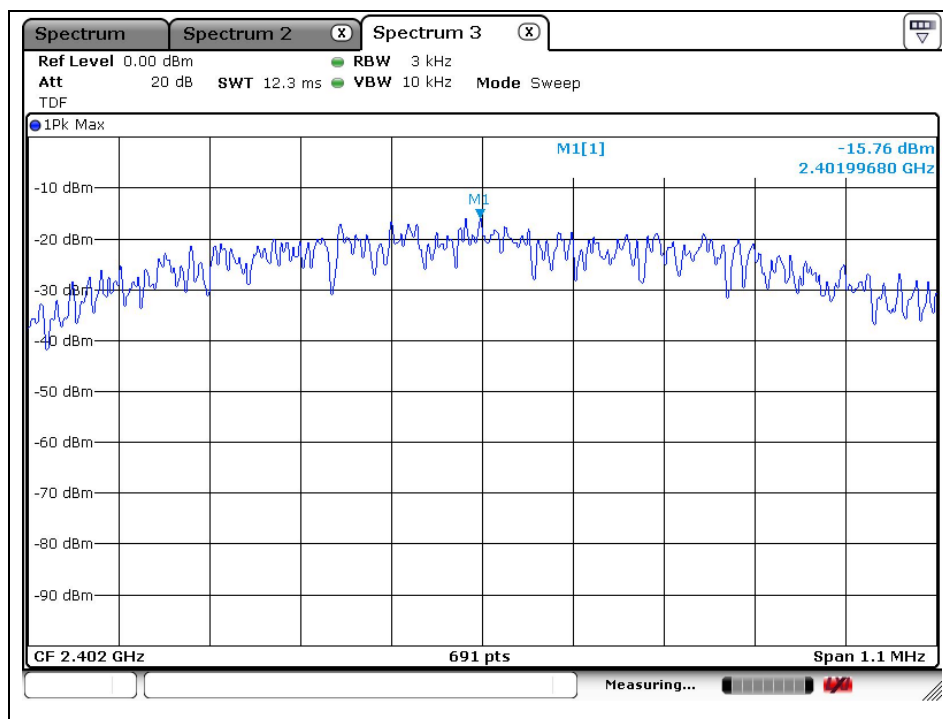

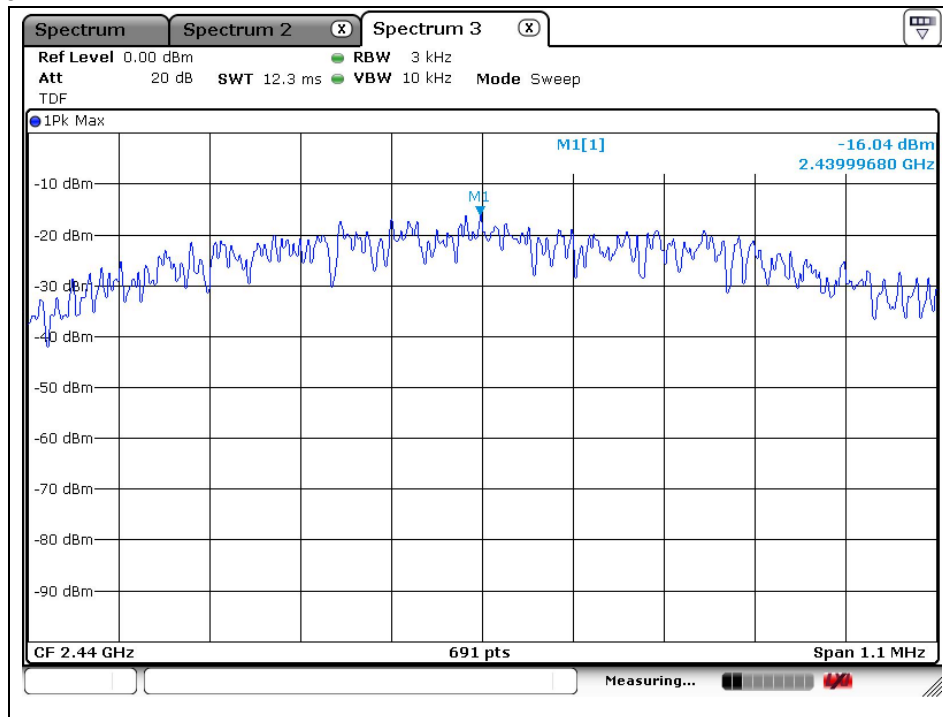

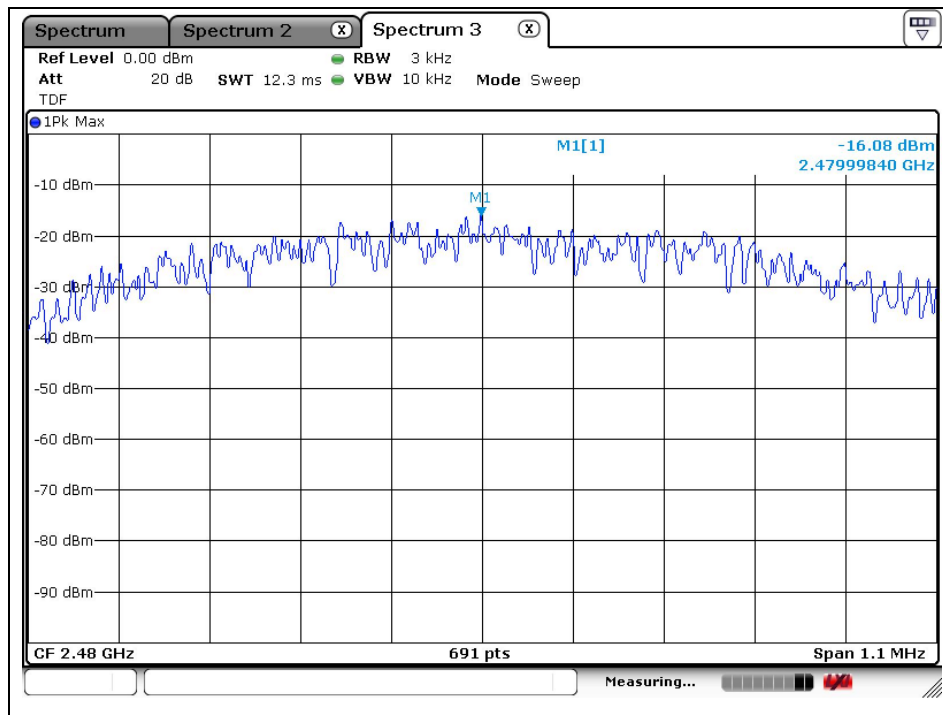
