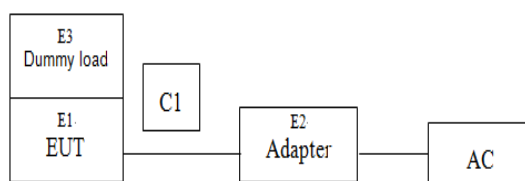

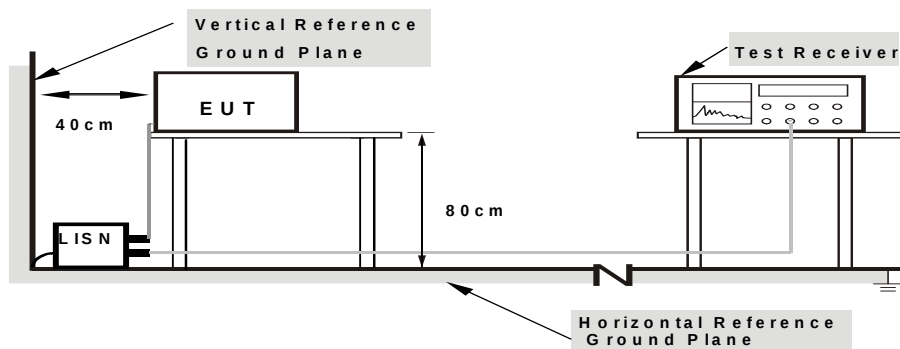

5.4.EUT Configuration on Test

The following equipments are installed on conducted emission test to meet FCC Part 15.207 requirement and operating in a manner, which tends to maximize its emission characteristics in a normal application.

5.5.Operating Condition of EUT

5.5.1.Setup the EUT and simulators as shown in Section 5.1.

5.5.2.Turn on the power of all equipments.

5.5.3.Let the EUT work in test modes (EUT Working) and test it.

5.6.Test Procedure

The EUT is put on a table of non-conducting material that is 80cm high. The vertical conducting wall of shielding is located 40cm to the rear of the EUT. The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.). A EMI test receiver (R&S Test Receiver ESR3) is used to test the emissions form both sides of AC line. The bandwidth of EMI test receiver is set at 9kHz.

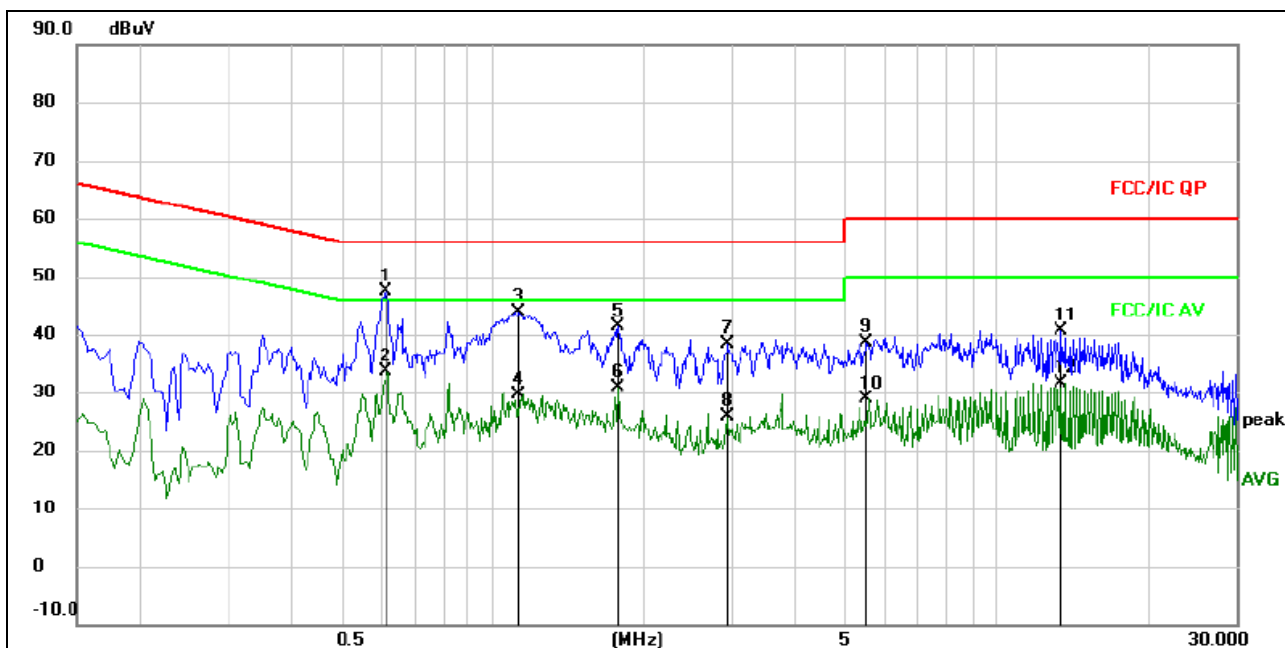
The bandwidth of the test receiver (R&S Test Receiver ESR3) is set at 10KHz.

We pretest AC 120V and AC 240V, the worst voltage was AC 120V and the data recording in the report.

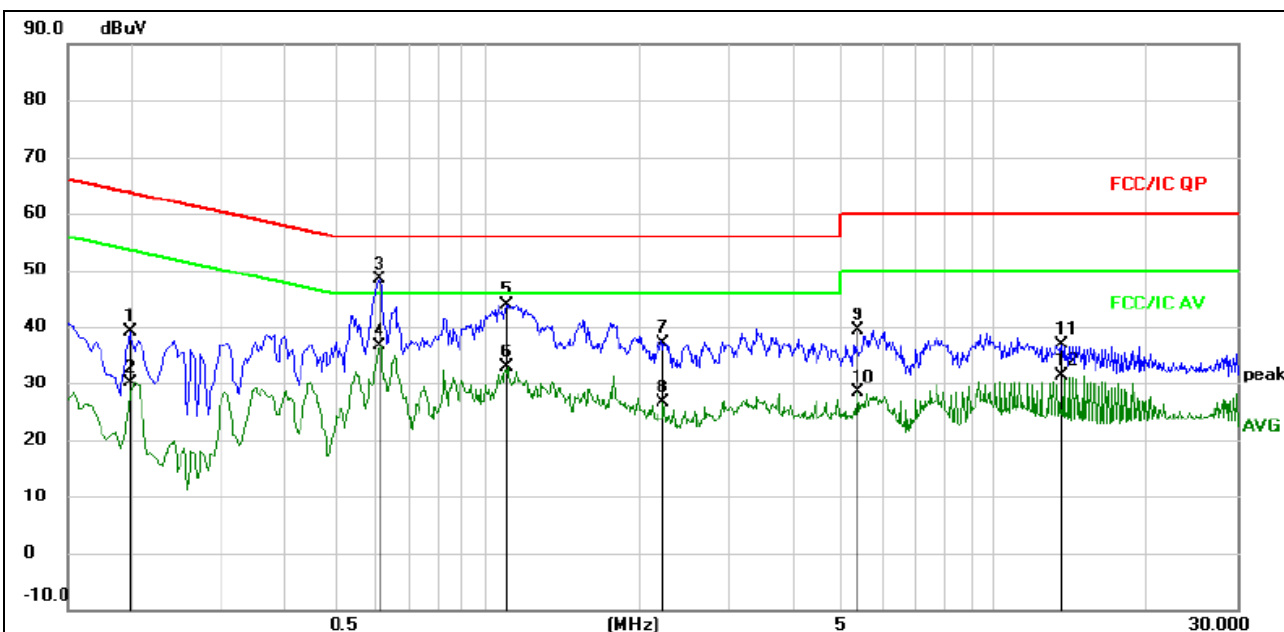

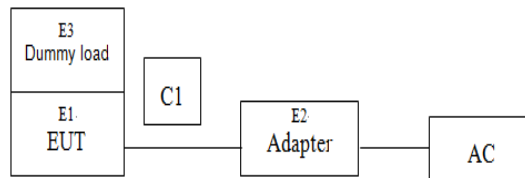

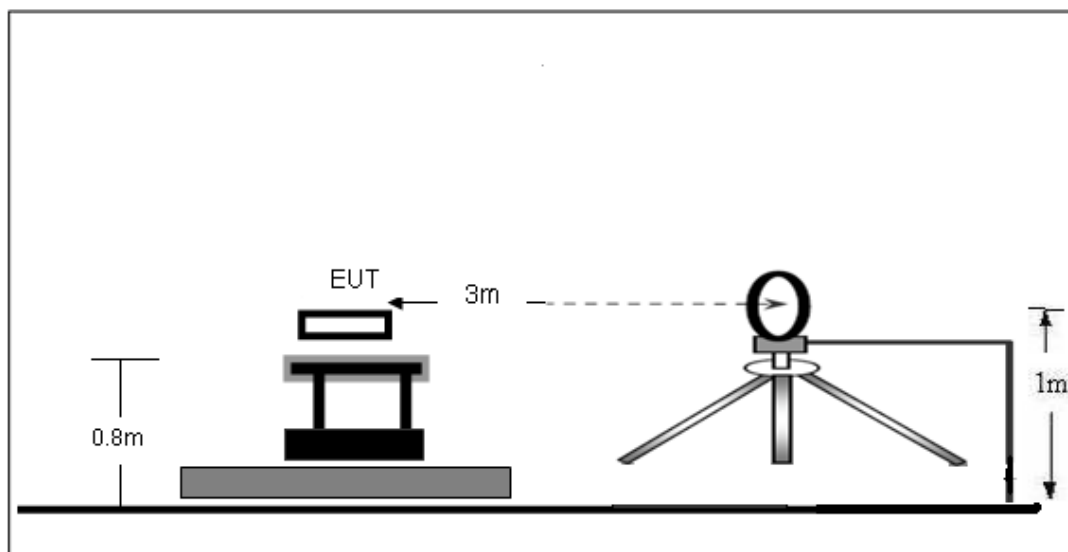

6.1.1. Block Diagram of connection between the EUT and the simulators

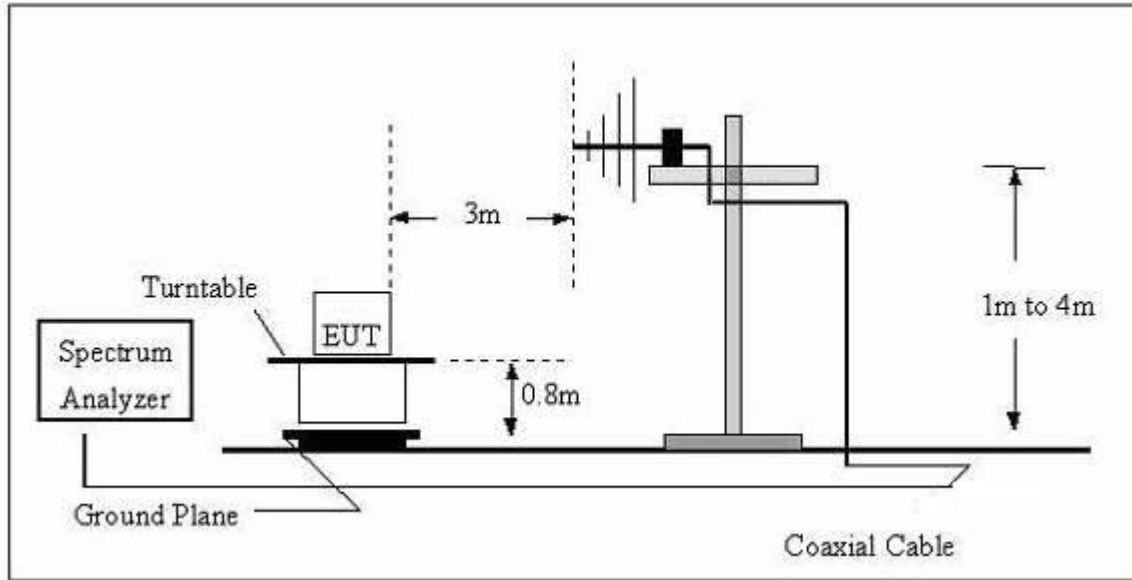


6.1.2. Anechoic Chamber Test Setup Diagram

6.3.EMI Test Receiver Setup

The system was investigated from 9kHz to1GHz.

During the radiated emission test, the EMI test receiver setup was set with the following configurations:

Note: For the frequency bands 9-90 kHz and 110-490 kHz, the test was based on average detector.

6.4.Test Procedure

The EUT is placed on a turn table which is 0.8 meter above ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. The EUT is set 3 meters away from the receiving antenna which is mounted on a antenna tower. The antenna can move up and down between 1 to 4 meters to find out the maximum emission level. Broadband antenna (calibrated by dipole antenna) are used as a receiving antenna. Both horizontal and vertical polarization of the antenna are set on measurement.

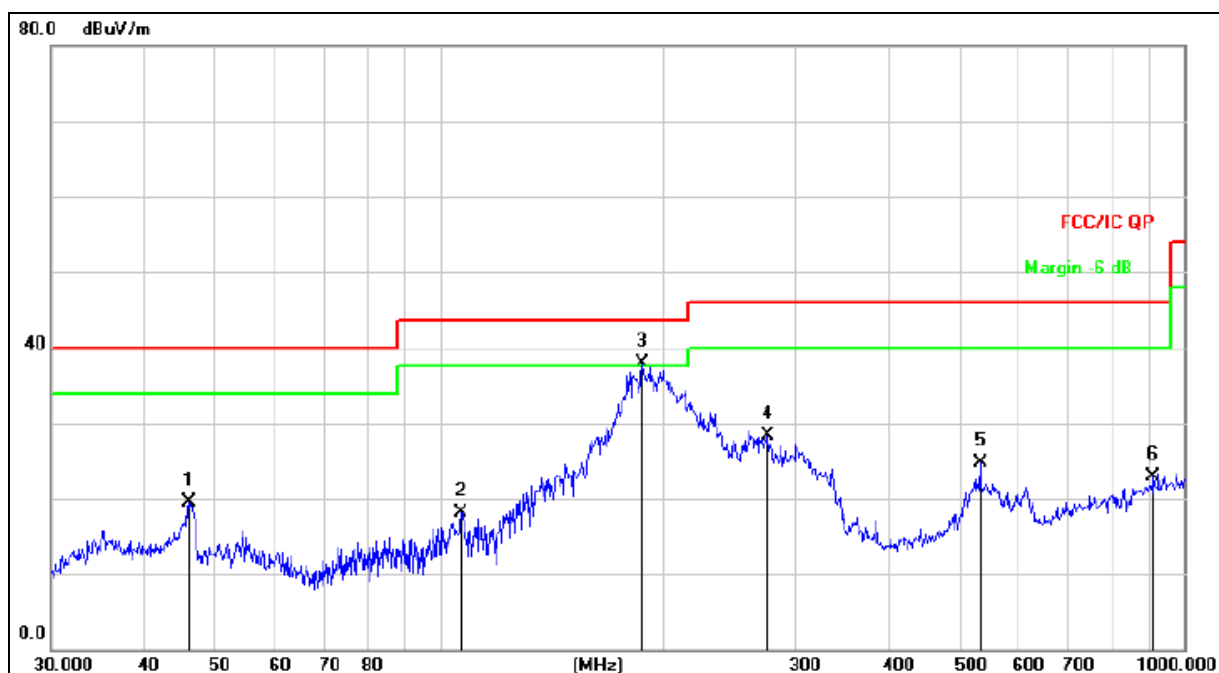

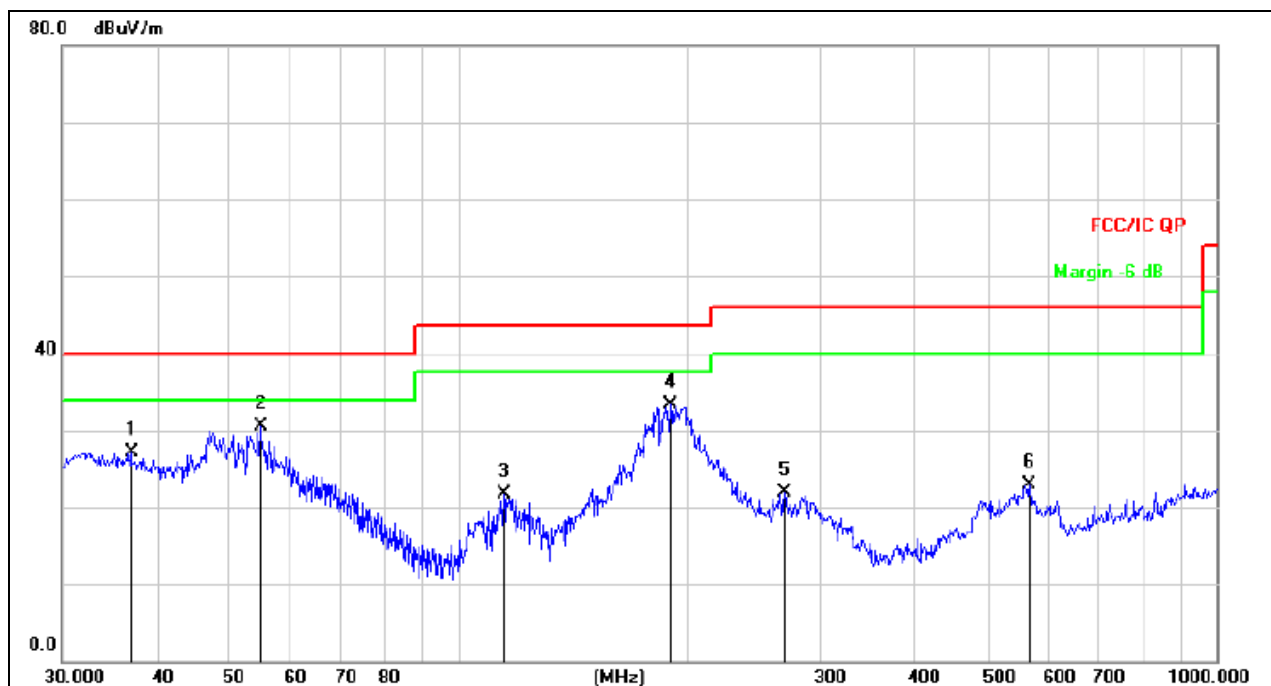

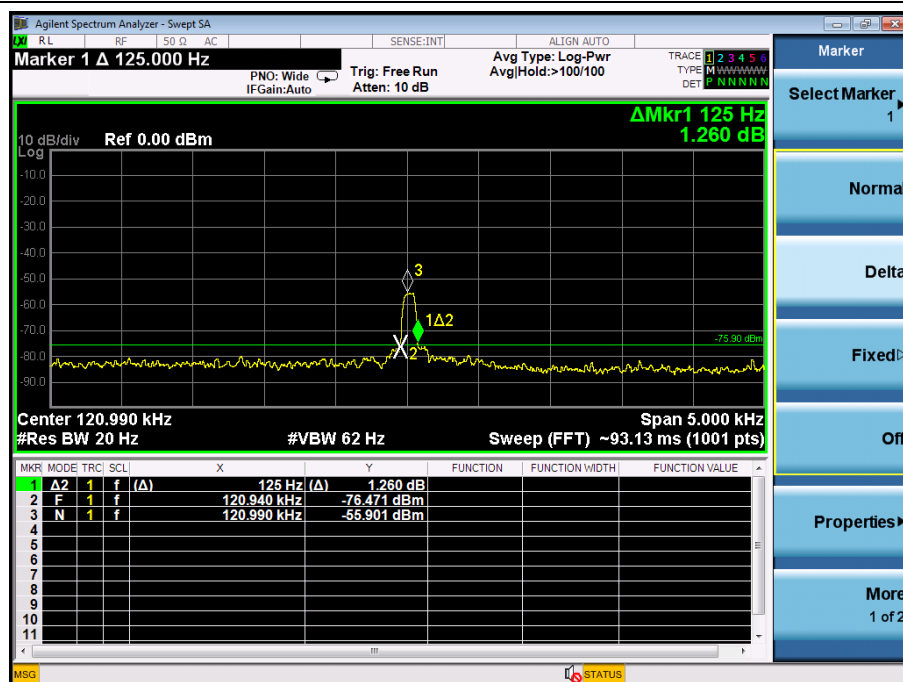
7. BANDWIDTH TEST

1. Set RBW = 200Hz.
2. Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
3. Detector = Peak.
4. Trace mode = max hold.
5. Sweep = auto couple.
6. Allow the trace to stabilize.
7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 20 dB relative to the maximum level measured in the fundamental emission.

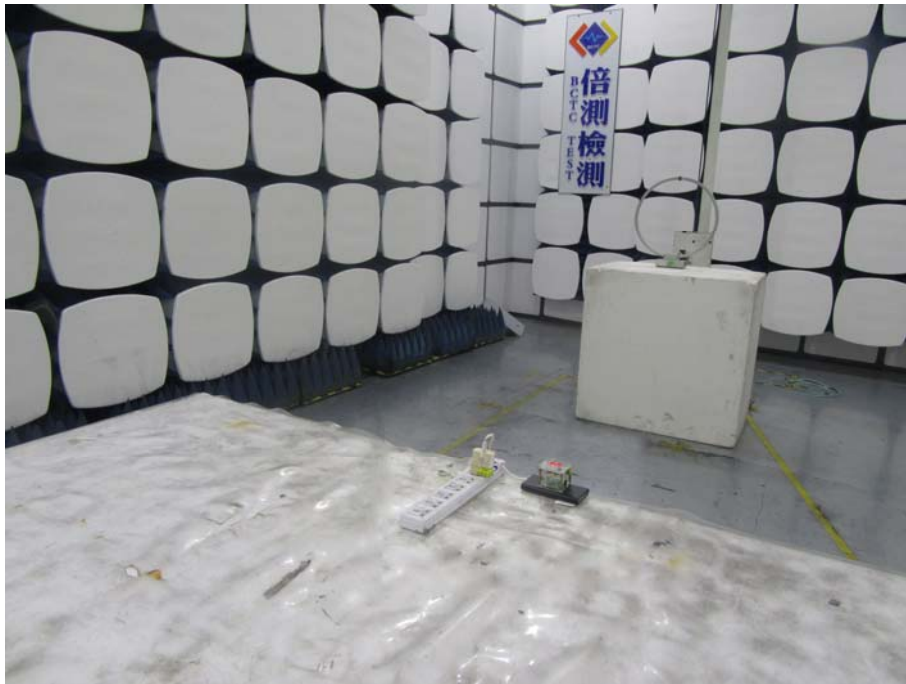

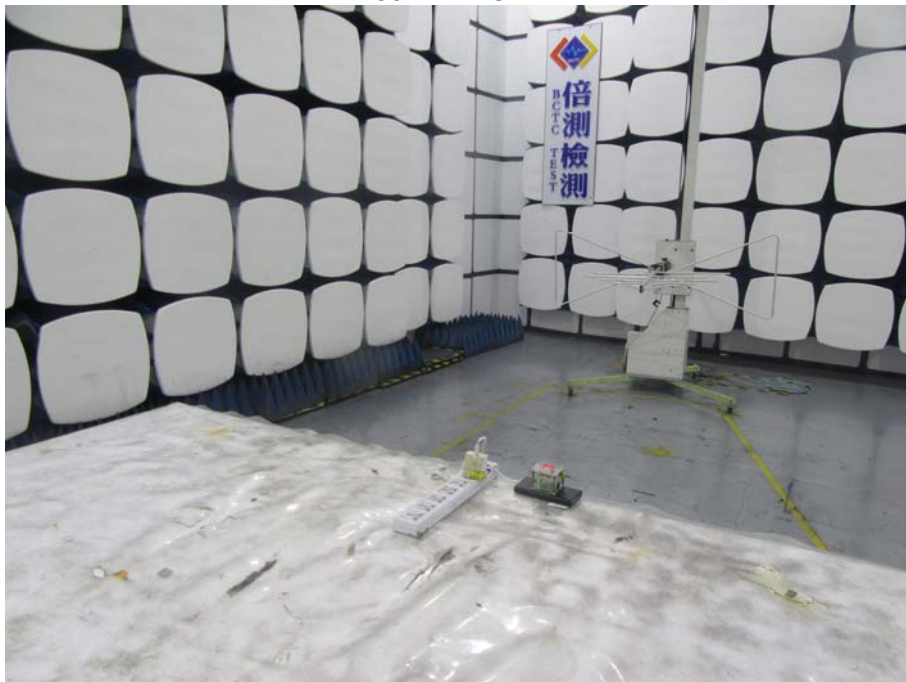


Radiated Measurement Photos

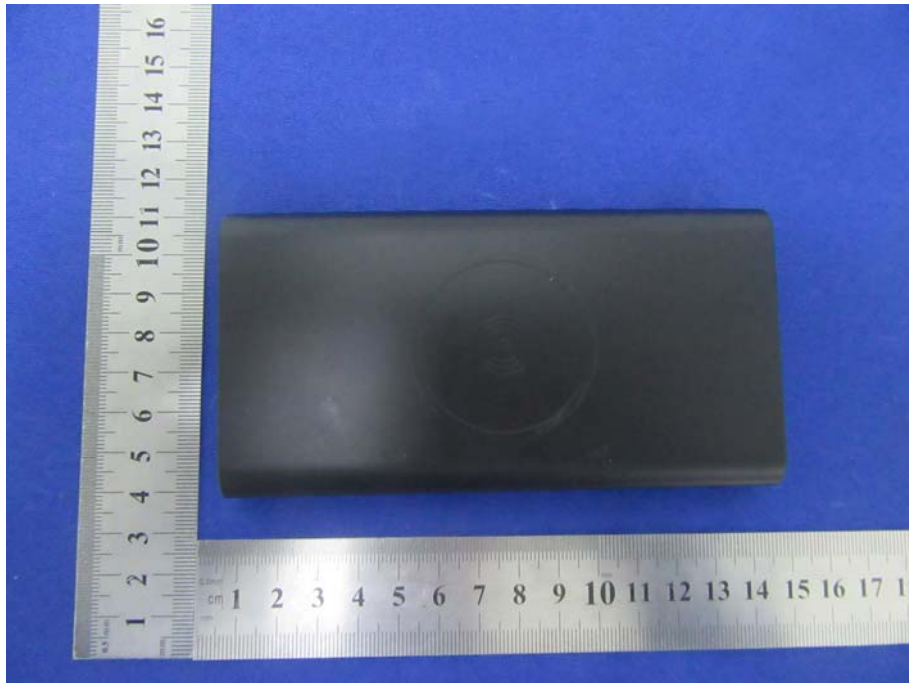


30MHz-1GHz
