RE: LONG-TERM CONFIDENTIALITY REQUEST

To whom it may concern:

This letter serves as long-term confidentiality request under CFR 47 § 0.457(d) and § 0.459, and per KDB 726920 D01 Confidentiality Request Procedures. We request that:

- Schematics
- Block Diagram
- Parts List & Placement / Bill of Materials (BOM)
- Tune-Up Procedure
- Operational Description / Theory of Operation
- Internal Photos
- User Manual

that are required for submission with this application be permanently withheld from public review.

In the bulleted list above, we request that the internal photos be withheld from public view. The circuit board is in an enclosure secured by fasteners with Loctite. Thus, the circuit board and internal components are not accessible to users.

Urban Canyon Flight Inc has spent substantial effort in developing this product and it is one of the first of its kind in industry. Having the subject information easily available to “competition” would negate the competitive advantage we have achieved. Not protecting this information would result in financial hardship.

Furthermore, we request the above be withheld from public inspection in accordance with § 0.457 and § 0.459 of the Commission’s Rules based upon:

- The products in question is a non-consumer device
- The product is located in such a way that it is not accessible to the general public
- The product is only used by professionals
- The product information above will only be available to customers during/past customer purchase
- This information is not (and will not be) publicly available unless violation of Non-Disclosure Agreement (NDA)
- *Urban Canyon Flight Inc* prevents this sensitive information not disclosed to unauthorized parties via NDA.



- All customers to *Urban Canyon Flight Inc* must agree upon / sign such NDA
- Information covered by such NDA is considered by *Urban Canyon Flight Inc* to be confidential commercial information and is not known to the public nor to competitors. Such information can, if disclosed, be used by competitors to obtain commercial/technical gain.
- *Urban Canyon Flight Inc* operates in a very fierce competitive market. This competition is very intense and a less advanced solution/design could get an unfair advantage by accessing product related information (not known to the public nor to competitors) easily from an open domain with world wide access.
- The product in question is the most advanced in the world of its type. We strongly believe that the information is sensitive from a trade secrets point of view and should be held long-term confidential, preventing access from unauthorized parties (e.g. competitors).

EXHIBIT A: NON-DISCLOSURE AGREEMENT CLAUSE

1.0 PROPRIETARY INFORMATION

For the purpose of this Agreement, PI shall mean the following types of information, whether in tangible or intangible form:

1.1 Technical Data and Information

PI shall include all technical data and information, including but not necessarily limited to: inventions; ideas; methods; techniques; processes; designs; drawings; diagrams; schematics; formulae; analyses; know-how; trade-secrets; software source code; products and services; equipment; models; pre-prototypes, prototypes and first articles; samples; data sheets; configurations; specifications; bills of materials;
