PSD 100kHz Plot on Channel 39





Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.





3.5 Radiated Band Edges and Spurious Emission Measurement


- 1. The testing follows ANSI C63.10-2013 clause 11.11 & 11.12
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.




For radiated emissions below 30MHz



3.7 Antenna Requirements




