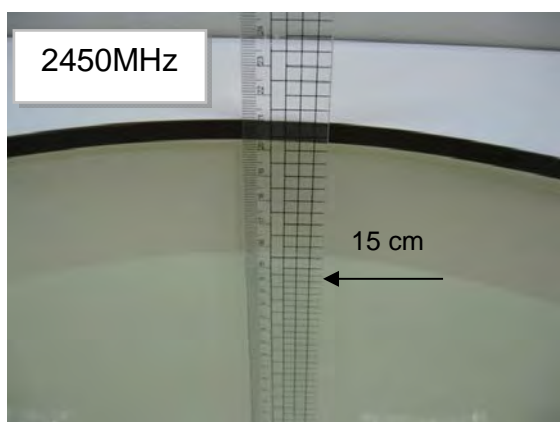
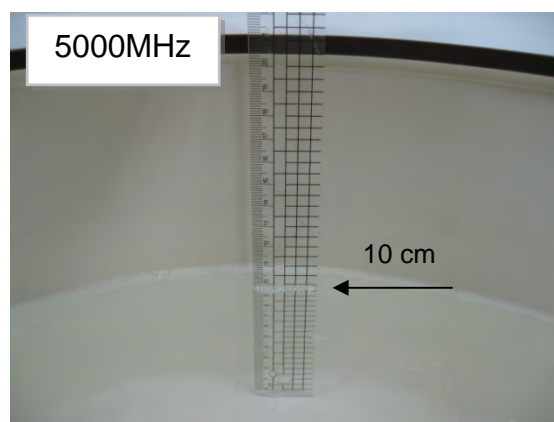

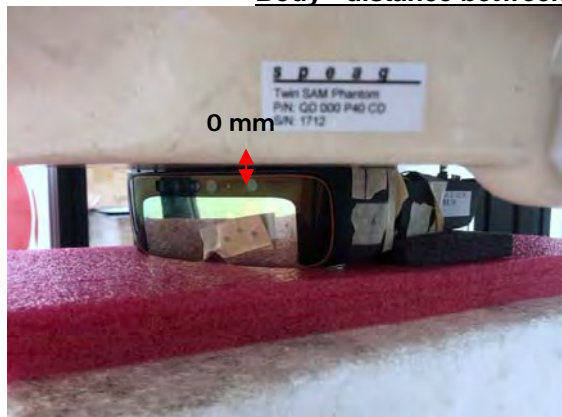


Fig.6 EUT 5 to flat phantom

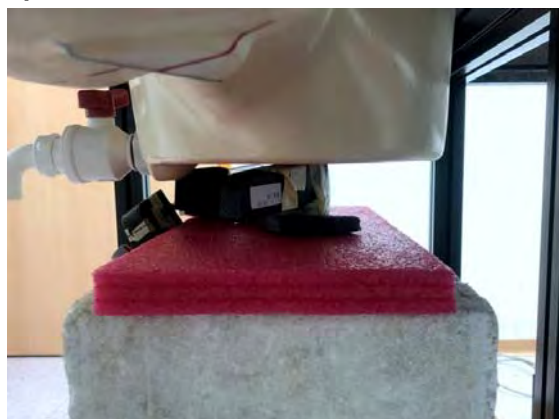


Fig.8 EUT 8 to flat phantom

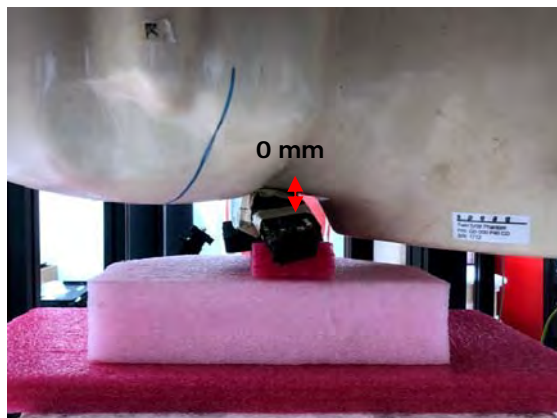


Fig.10 EUT 7 to flat phantom

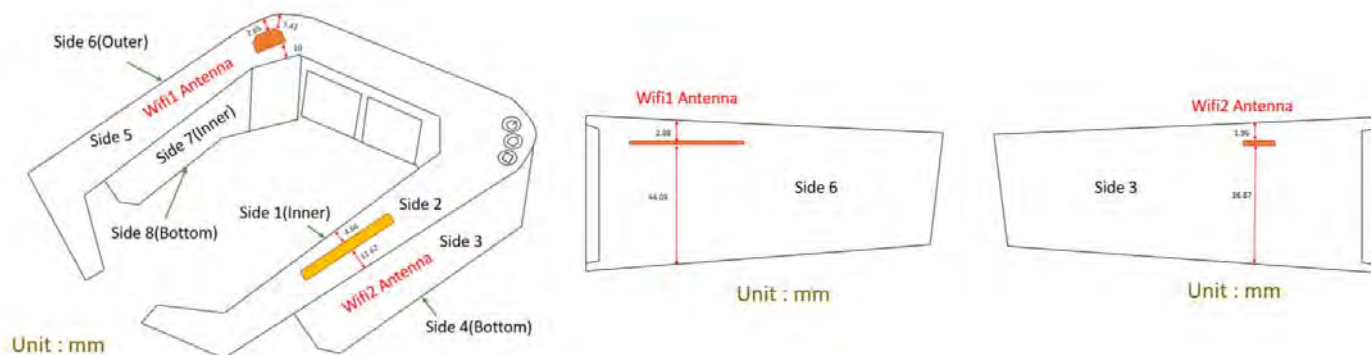


Fig.13 Antenna position of EUT
