Overview of the X2 MR Glasses:

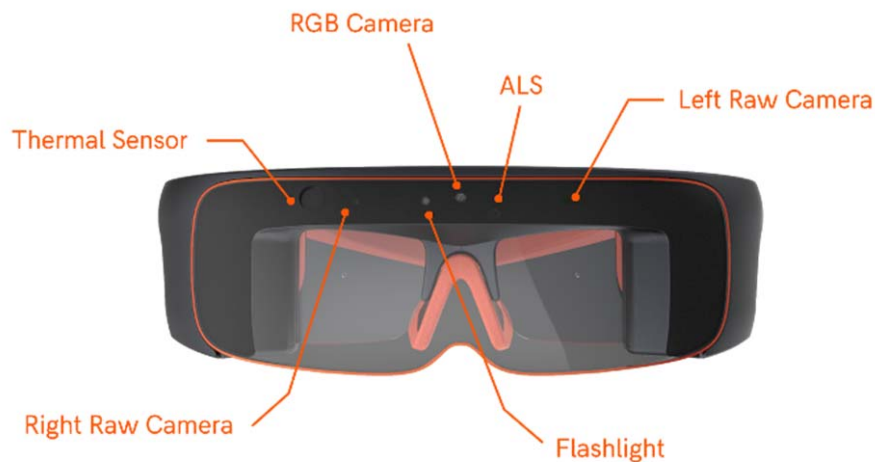
Top View

Main Buttons Controls:

The Three Buttons are “Power”, “Home/Back”, and “Select”

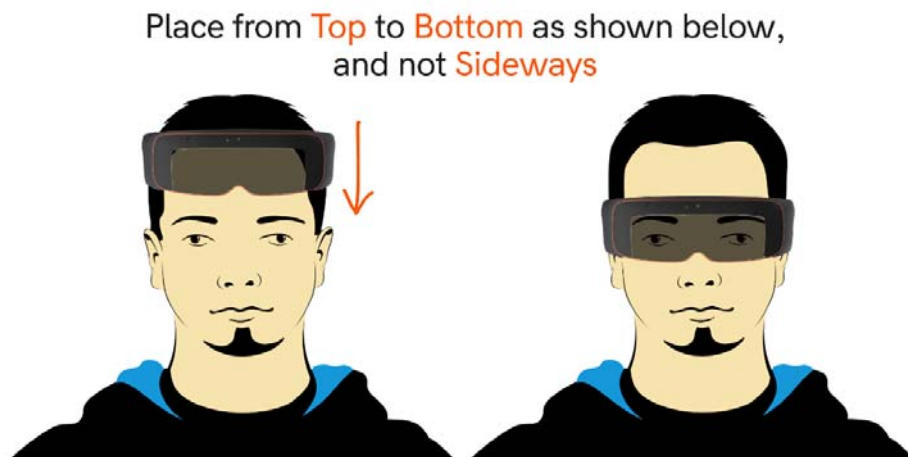
- 1.) **Power On:** Short Press (click) the Power button to turn on. You will see the White LED light turn on immediately & hear the haptic buzzer make a noise. The X2 displays will turn on a few seconds later. If the white LED or displays do not turn on that means battery is low- connect to your provided Charger.
- 2.) **Enter Sleep Mode:** While your X2 displays are on, short press the Power Button to enter sleep mode. The displays turn off in Sleep mode. In Sleep mode, the device is not off only the displays are.
Exit Sleep Mode: Short Press the Power button again to exit Sleep mode.
- 3.) **Power off:** While your X2 is on, long press (click & hold for ~3 seconds) On/Off (Power) button to turn the system off. You will see a pop-up with the message “Shutting Down” indicating the X2 is shutting down automatically.
- 4.) **Power Reset:** Press and hold the Power button for ~30 seconds to force a power reset. When doing a hard power reset do a hard power reset that the device can't be plugged in to a charger or computer at that time

- 5.) **Home/Back:** Press the Home/Back button to return to the previous screen or home screen.

Turning on the X2 MR Glasses for the first time:

The first time you turn on the X2 MR Glasses, you will be taken through a brief setup process. Please follow the below steps.

1. Put on the X2 from top down (see below picture). Attach the head strap to the head strap notch if necessary.



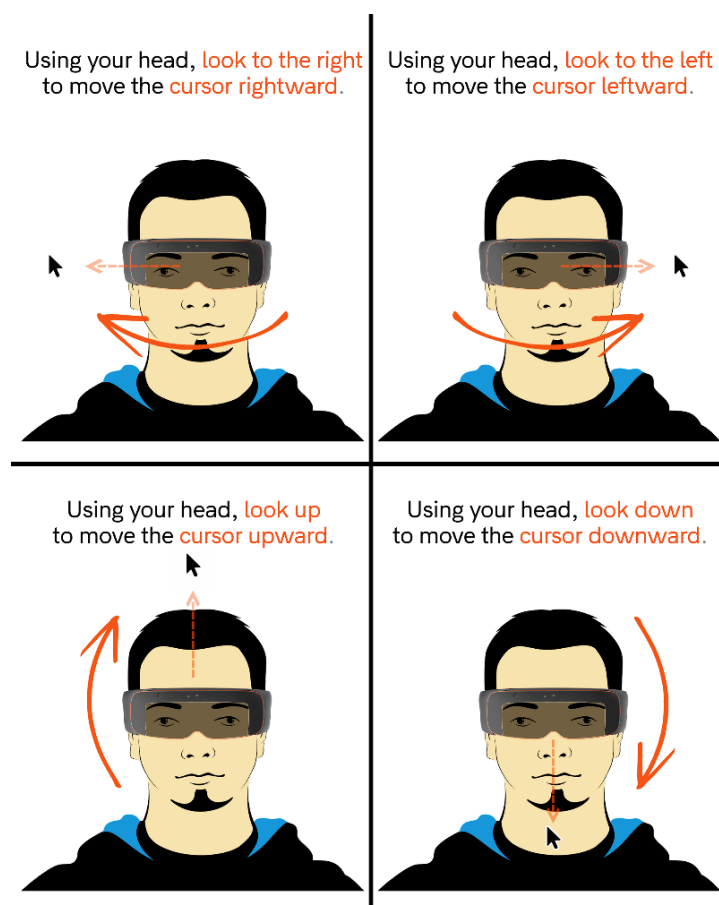
2. Turn on the X2 by pressing and holding the Power button. You will hear the haptic buzzer audio sound immediately after pressing the power button & the white LED will turn on immediately as well to indicate that the X2 is on. It takes a few seconds after pressing the Power button for the displays to turn on with the ThirdEye logo. If the white LED or displays do not turn on that means battery is low- connect to your provided Charger and press the power button- you will see a battery charge icon if battery is low. After charging for some time, press and hold the power button and the ThirdEye logos will display for the normal power up process.

3. Once the displays are on, you will be taken to the home screen. If the screen or icons seem blurry, this may be because the X2 is not positioned properly on your face. Adjust it up/down on your nose, modify the flexibility of the nosepiece if needed, and use the head strap if necessary to position properly on your face until you can view the full screen properly.
4. On the home screen you will see tutorial .apks for the Gaze/Audio/Gesture controls. Look at the Tutorial with your head to move the cursor and click by pressing the physical “Select” button or via the automatic head motion Gaze click. The tutorial will go through how to use the different User Interface methods and control/activate/deactivate them.

Head Motion “Gaze” UI Controls

There are multiple methods of User Interface (UI) Controls on the X2 MR Glasses.

1. **Move/Click/Drag & Drop/Long Press:** Using your head look Up, Down, Left and Right to move the Cursor along with your head motion. Upon looking at an icon, the Gaze UI cursor automatically “clicks” by just staring at the icon for a couple seconds. You can drag and drop an icon by looking at an icon and pressing/holding the “Select” button. To “Long Press”, press & hold the “Select” button.



2. **Gaze UI Tab:** The Gaze UI controls tab is located at the top left. Each UI button corresponds to a different function. You can move this UI controls tab anywhere else on the home screen by looking at the UI tab and pressing and holding the “Select” button to drag & drop the UI Controls tab to a different section of the screen.

3. **Settings:** The “Settings” gear on the UI controls tab allows you to customize the Gaze UI per your individual preference. Below are some of the customizations available:
 - i. **Enable/ Disable auto-click:** If you want the automatic clicking to stop, scroll down to the “Disable auto-click”. After disabling this, to click on something you have to look at the icon and press the “Select” button.
 - ii. **Change color/size of UI tab & cursor:** To change the color, scroll to the color tab and drag and drop it to whichever color you prefer. There is also an option to change the size of the UI tab from Small, Medium and Large per your preference.
 - iii. **Change Speed of cursor auto-click:** Increase or decrease the speed of how fast the cursor automatically clicks when above an icon.
 - iv. **Change speed of cursor movement:** You can increase or decrease how fast the cursor moves with your head motion speed.
 - v. **Enable/Disable Gaze UI:** You can disable the Gaze UI (for example if you just want to use a wireless Bluetooth Controller or audio). Note: if you disable the Gaze UI, you will need to use some other form of UI control (either audio, gestures, a bluetooth controller device, or Vysor app on a computer.) to re- enable the Gaze UI by clicking on the Gaze UI app.
 - vi. **Restart Gaze UI tutorial:** You can always redo the initial tutorial by clicking on the Tutorial apk or via the Gaze UI settings tutorial button

4. **Remove UI Tab from top:** To minimize the UI Tab, click on the “ThirdEye” logo next to the “Settings” icon in the UI tab. This will minimize the UI tab. To reopen the UI tab, look at the “ThirdEye” logo on the bottom right and click on it. You can move the minimized UI tab anywhere on the screen via the same “Drag & Drop” Method- just remember where you moved it so you can reopen it later.
5. **Previous Screen (Back/Home) functionality while Gaze UI is on:** If the Gaze controls are enabled, to go back to the previous screen, you can click on the “Back” icon on the Gaze UI controls or press the physical “Back” button.

Audio UI Controls

The X2 supports Audio commands in English using a custom Speech Recognizer. The X2 uses the latest technology for advanced noise cancellation and speech recognition works in various environments.

- The wakeup word is "**Okay ThirdEye**" to enter Audio command mode.
- You can say "**Stop Listening**" to go back to wakeup mode anytime.

Upon saying the wake-up word, the X2 will make an audible “ring” sound & display a text command on screen to let you know the X2 is listening for audio commands. You can say multiple audio commands in a row- however if you are going to be talking in the meantime that could trigger commands unintentionally.

Upon saying “Stop Listening”, the X2 will make an audio “ring” sound to let you know it has resumed listening for the wake-up word.

You can say “Show Commands List” to get a scrolling list displayed of all the audio commands in case you forget any.

ThirdEye Global Audio Commands:

The below audio commands are Global Commands meaning that they can be used on any screen after saying the wake-up word. They will work on the home screen and in any 3rd party app unless the 3rd party app developer specifically deactivated a Global Command.

Global Audio Commands	Meaning
Sleep Mode	X2 Sleep Mode.
Show Commands List	Provides user a list of currently active voice commands in its own activity screen.
Wake Up	Return from Sleep Mode to the previous screen.
Shutdown ThirdEye	Android Turn Off – X2 shuts down
Back Button	Mimics the Android Back button. Navigates to the previous or home screen.
Home Screen	Navigates to Home Screen of X2
Open Camera	Opens built-in Android Camera App.
Take Picture	Takes a picture and saves it to Gallery. Can be used at any time.
Start/Stop Recording	Starts recording a video, displays a preview window on the top left corner of the screen. Stops recording a video, hides the preview window. Saves the video to the Media Gallery. Can be used at any time.
Open Store	Opens ThirdEye App Store app.
Open Workspace	Open ThirdEye Mixed Reality Workspace application.
Gallery	Opens Media Gallery application.
Files App	Opens File Manager application.
Open/Close Thermal	Opens and Closes the Thermal Sensor Feed application.

Take Thermal Picture	Takes Thermal Feed picture and saves it into Media Gallery.
Flashlight On/Off	Turns on/off Flashlight (Android Torch functionality).
Screenshot	Takes screenshot of Android Screen and saves it into Gallery.
Volume Up/Down	Increases/Decreases the Volume one step.
Brightness Up/Down	Increase/Decrease the Display Brightness level by 10%
Brightness High/Max	Sets Display Brightness Level to High.
Brightness Medium	Sets Display Brightness Level to Medium.
Brightness Low	Sets Display Brightness Level to Low.
Rotation On/Off	Turn on/off sensor-based Screen Rotation.
Mute Sound/Off	Mute on/off.
Cursor Up/Down/Left/Right	Moves the System Cursor/highlight.
Cursor Select	Selects the currently highlighted object.
Head Motion On/Off	Head Motion UI Controls appear/turned off.
Gaze Click On/Off	The Automatic Stare Clicking starts/the Automatic Stare Clicking stops. Only Physical Clicking via Back or Select Button will click.
Motion Select	“Clicks” whatever the Head Motion Pointer is over.
Voice Commands Off	Turns the Audio Command off completely. To turn them back on, click on the “VUI On” icon on the Home Screen.
System Settings	Goes to Android Settings.
Wireless Settings	Goes to Android WiFi Settings.
Bluetooth Settings	Goes to Android Bluetooth Settings.

Recent Apps	Open applications running in the background.
Close App	Closes the highlighted application in Recent Apps Screen.
Internet	Opens up system level Internet Browser (Firefox App)
Android Debugging On/Off	Turns Debug Mode on or off.
Launcher Dark Mode	Makes background Home Screen black “transparent”.
Launcher Light Mode	Makes background Home Screen light
My Applications Open App Drawer	Opens up “My Applications” Folder on the Home Screen.
Show Desktop Close App Drawer	Returns to the simplified applications desktop screen.
About ThirdEye Device	Opens “About Device” in Android Settings.
Check ThirdEye Update	Automatically checks for updates.
Download ThirdEye Update Now/Later	If update exists and if device battery is 50% or more or connected to charger, OTA update will commence. If less than 50%, text box comes up saying “Connect to charger – battery percent for OTA must be at least 50%”.
Install ThirdEye Update Now/Later	Will install the OTA update now or at a later time.
Scroll Up/Down/Left/Right	Scrolls the screen up/down/sides.
Voice Typing	Activates the Voice Keyboard. (Note: The soft keyboard must be visible on-screen to accept voice typing commands.)

Opening User-Installed Apps:

User-installed apps are automatically added to the global command list when they are installed. Say “Open” + the app’s label to open it. For example, to open an app called “Strike Force”, simply say “Open Strike Force”.

Voice Typing:

When the Voice Keyboard is activated, the following commands are made available.

Voice Typing	Activates the Voice Keyboard. (Note: The soft keyboard must be visible on-screen to accept voice typing commands.)
Commands	Meaning
Spacebar	Adds a single space.
Enter	Presses the Enter key.
Backspace / Delete	Deletes the last character.
Clear Text	Clear the text.
Caps On	Uses Capital Letters.
Caps Off	Switches to lowercase letters.
Clear Text	Clears text in the active text edit box.
Cursor Left	Moves the text cursor one character to the left.
Cursor Right	Moves the text cursor one character to the right.
Cursor Home	Moves the text cursor to the beginning of the text box.
Cursor End	Moves the text cursor to then end of the text box
Typing Letters/Numbers/Symbols	To type a letter, you can either use the NATO alphabet (“Alpha” for A, “Bravo” for B, etc.) or say “Letter A/B/C/...” for letters or use a combination of both. For Numbers, you can say “Number 1/2/3”. For symbols you can say the name of the symbol. - For example to type “hello :-) 123”: "Okay ThirdEye" (system is awake). "Voice Typing" (Voice keyboard is activated). "Hotel, Letter E, Lima, Letter L, Letter O, Space, Colon, Minus, Closed Parenthesis, Space, Number One, Number Two, Number Three" would result in: “hello :-) 123”.

Stop Typing	Disables voice typing (says “System Commands Available”) and returns to Voice Command Mode looking for the “Voice Typing” activation word.
Next Field	Move cursor to the next available text field.

ThirdEye App Commands:

The following commands are available to use in each app as defined below. To use them in 3rd party apps, 3rd party app developers will have to integrate them into their app using the audio SDK (see number 5 below).

Commands	
Camera App	Camera Zoom In Camera Zoom Out Take Photo/Picture
PDF Viewer App	Scroll Up/Down/Left/Right – scrolls the PDF

Other Audio Information:

1. During OTA firmware updates of the X2, the database of audio commands may increase. The update will inform you if there are any changes in the text update of the OTA. Future changes may include more audio commands, changes to the SDK, speech to text recognition and other features.
2. The voice accuracy success rate depends on many factors such as surrounding noise & accent. For greater accuracy, you can attach an external Mic (see the ThirdEye Forum website page for some Mic recommendations). On some screens, certain voice commands will not work for increased accuracy. For example, if you are on a web browser, “Take Thermal Picture” audio command will not function.
3. Currently English is the only supported language. You will receive an update if other languages are available.
4. **Disabling Audio:** Note if you turn off the Audio commands, any app that uses the audio SDK will also be off so audio commands will not work throughout device until they are reactivated. If you say an audio command that is already enabled i.e. saying "Head motion on" when

the Gaze controls are already on, nothing will take place. To re-enable audio, click on the Audio .apk on home screen.

Disabling Wake Up: The way the system is currently set up, you only have to say the wakeup word once, then can follow up with as many commands as you like. User can then say "Stop Listening" to go back to Wake Up mode.

5. **Developers:** To create your own custom voice commands using the audio SDK, please refer to the Developers section.

The Home Screen:

After completing the tutorial, you can enter the X2 Home Screen. The X2 has a custom launcher Home Screen so that the background is transparent and only a few apps are shown for easy accessibility.

The default Home Screen has the following apps:

- 1.) **ThirdEye App Store:** This is the official ThirdEye App Store. You can create an account and download any free or paid app available. If you are interested in submitting your own app, please refer to the Developers section of the user guide.
- 2.) **ThirdEye MR Workspace App:** The ThirdEye enterprise software application. For more information refer to the ThirdEye MR Workspace section of the user guide.
- 3.) **Settings:** This is the main Android settings tab. You can choose your WiFi, Bluetooth settings and other settings features.
- 4.) **Camera:** This is the built-in standard RGB Camera feed. More info about the RGB camera is listed later on in the guide.
- 5.) **UI Tutorial apps:** This is the Tutorial app that allows the user to learn how to use the Gaze/Audio/Gestures. There are 3 UI tutorial apps for Audio, Gaze & Gestures.
- 6.) **My Applications:** This is a folder on the home screen that hosts the below other system level apps as well as any other app that is newly downloaded.

Thermal Sensor: This lets you click on the Thermal Sensor and view the thermal feed view from the Thermal sensor integrated. If you want more info on how to develop software using the thermal sense, please refer to the Developers section.

Flashlight: This lets you click on the Flashlight and turn on/off the built-in flashlight. If you want more info on how to develop software using this, please refer to the Developers section.

Gallery: This is the Gallery where pictures/videos are stored.

File Manager: This is where you can view downloaded Files.

VisionEye SLAM Apps: Apps that showcase the ThirdEye VisionEye SLAM capabilities.

“VisionEye SLAM” - The VisionEye SLAM system app should not be deleted

“ThirdEyeSLAMdemo” - A SLAM demo app that showcases various SLAM features.

For more info on VisionEye SLAM, visit the VisionEye SLAM section.

Audio & Gaze & Gesture UI: 4 system level UI .apks. Vui Off allows for the user to deactivate audio commands by clicking on the app.

OTA: For wireless Over the Air updates.

Internet Browser: This allows user to access the internet.

PDF/Document Reader: User can view PDFs & other document formats in this app

Device Management App: User can register their device using this app

3rd party applications: These are any other pre-installed or new downloaded apps.

Download Apps from the ThirdEye App Store:

- 1.) Go to the home screen and click on the icon for the ThirdEye App Store.
- 2.) You will be taken to the App Store login page.
- 3.) The first time you visit the App Store you will need to create a ThirdEye User Account if you don't already have one. Click on SIGN UP, and then complete the required fields. You can also create an account on the ThirdEye Website, App Store Website or Workspace app and use the same login info.
- 4.) Once you have created your ThirdEye User Account you can login.
- 5.) Now you have access to all of ThirdEye App Store apps.
- 6.) The following custom ThirdEye Voice Commands work within the App Store.
 - a.) "Move up/down/left/right" to move the highlighted icon. Highlight refers to what is selected (not what the cursor is over)
 - b.) "Show <category>" i.e. "Show Games" and only the Games apps would appear.
 - c.) "Select <app>" selects the app that is highlighted
 - d.) "Scroll up/down"
 - e.) "Download app" if on an app install page, this would start the download process
 - f.) "Complete login" would login after user types in username password
 - g.) "Forgot password" would open the forgot password
 - h.) "Show <Categories/My Apps/Account>"

Some apps may not be free. Before you can download these you will have to enter your payment details in the App Store.

ThirdEye MR Workspace

The ThirdEye MR Workspace app is a powerful AR/MR software platform that comes with your X2 MR Glasses.

The Workspace has many AR/MR features for you to use. Create an account to get started. You can also create an account in the ThirdEye App Store or Workspace app and use the same login info to create a Free Workspace Account.

ThirdEye remote configuration from web browser (Mobile Device Management)

If you require your device to be registered using the ThirdEye MDM platform please follow the below steps:

1. Open a Web browser in your computer to thirdeyegen.com/configure
2. Click the 'Configuration' button on the page and then 'First Time Setup'. (Note: you can also click the 'Configuration' link on the top navigation bar)
3. Select the desired language and click 'Next'. You will need to select the world region first, then the time zone.
4. The 'Set Automatically' checkbox will default to checked with the values from your computer or phone. If you desire different settings, uncheck the box and change any values necessary.

5. When the Date & Time values are set, click 'Next'. • Optional: Enter the WiFi access point name (or SSID) and password to setup the Wi-Fi network for your ThirdEye device.

Note: most simple WiFi networks use WPA/WPA2 PSK security.

6. Click 'Generate Code'. A QR code will display on the computer screen.

7. On the ThirdEye device open the MDM App. Say or click on "NAVIGATE HOME" then "MY APPLICATIONS" then "CONFIGURATION". The device will display "Scan Code"

8. Scan the QR code by pointing the ThirdEye camera so the QR code is within the target outline on the display.

9. When the QR code is scanned a notification will be displayed and you will be returned to the previous screen.

10. Once the WIFI setup is done, you will need to register the device the MDM platform.

11. Login MDM web interface, you will get the QR code on the dashboard.

12. Click "Register Device" button the MDM app. Scan the QR code by pointing the ThirdEye camera so the QR code is within the target outline on the display. It will verify and register the device to the MDM Platform.

13. Go to DEVICE section on the MDM Web Interface to view the registered devices.

Congratulations- your ThirdEye device is now registered into the device management platform. For more info, contact your Company Admin or refer to the MDM page on the ThirdEye website.

The ThirdEye X2 MR Glasses has its own proprietary VisionEye SLAM SDK (Simultaneous Localization and Mapping) built into the Glasses.

The VisionEye SLAM allows for the X2 to understand its environment and create powerful MR apps. Furthermore, the VisionEye SLAM SDK offers developers a platform to create immersive AR/MR applications.

Other X2 Hardware Features

1.) Thermal Sensor

The X2 has a built-in Thermal sensor. It is low resolution 64 pixels and can be activated by clicking on its app or using audio commands. You can resample it to get a little more for presenting to the screen, but it is primarily for detecting things. For more details please visit the Developers section of our website.

2.) LEDs

There are two LEDs lights on the top right side (see Overview picture). LEDs allow you to understand the status of the X2 without needing to put it on.

- a.) Orange LED shows when the X2 is charging (i.e. connected to an outlet or laptop or other power source)
- b.) Orange LED starts blinking when battery is low ($\sim < 25\%$ battery)
- c.) White LED shows whenever the X2 is turned on.

3.) Flashlight

The X2 has a built-in Flashlight. This can be turned on by clicking on its app or using audio commands. The Flashlight can be used in low lighting situations to brighten your surroundings. For more details please visit the Developers section of our website.

4.) Ambient Light Sensor (ALS) Sensor

The X2 has an ALS sensor to detect the lighting/brightness of its surroundings. The screen brightness of the X2 automatically adjusts based on the brightness of the surrounding environment. You can turn this feature on/off. For more details please visit the Developers section of our website.

5.) RGB Camera

The X2 has a high resolution 13 megapixel RGB camera. It refers to open camera 0 in android. For more details please visit the Developers section of our website.

6.) 2 Wide Angle Cameras

The X2 has two other wide angle Global Shutter cameras that capture the raw image feed. For more details please visit the Developers section of our website.

7.) Audio

The X2 has (a) an auxiliary audio jack to plug in a standard wired earphone (b) an internal 91 dB loudspeaker speaker (c) audio via Bluetooth so you can connect your wireless earphones. d) 3 built-in microphones with active noise cancellation.

8.) Battery & Charger

The X2 utilizes USB Type C Power Delivery for more efficient Quick- charge capability.

a.) Plug the charger into a wall socket and connect it to the USB Type A-C port shown. Make sure you hear the “click” of the USB Type A-C cable into the port. The X2 also supports Type C-C cables.

b.) While the X2 is charging, you can see the battery percentage % charging status are also always displayed on the home screen (top right) and in “Settings”.

Unplug the charger from the electrical plug and the device when not in use. Do not allow children to play with this device or its accessories. Keep it out of their reach. 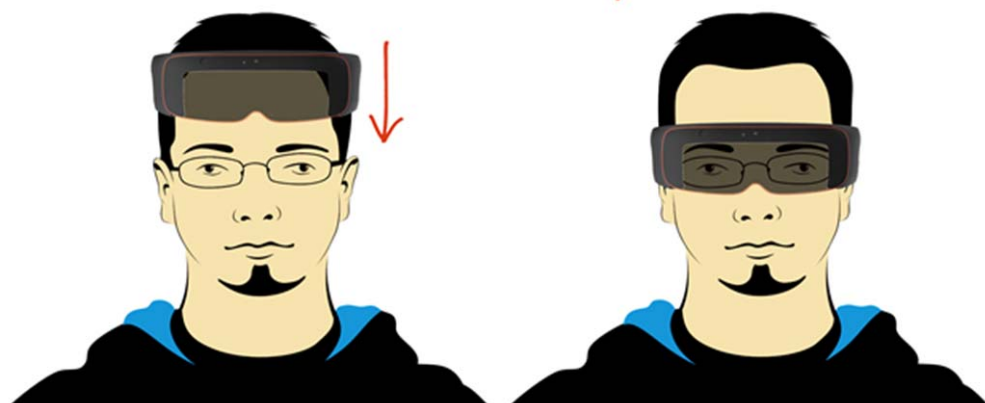

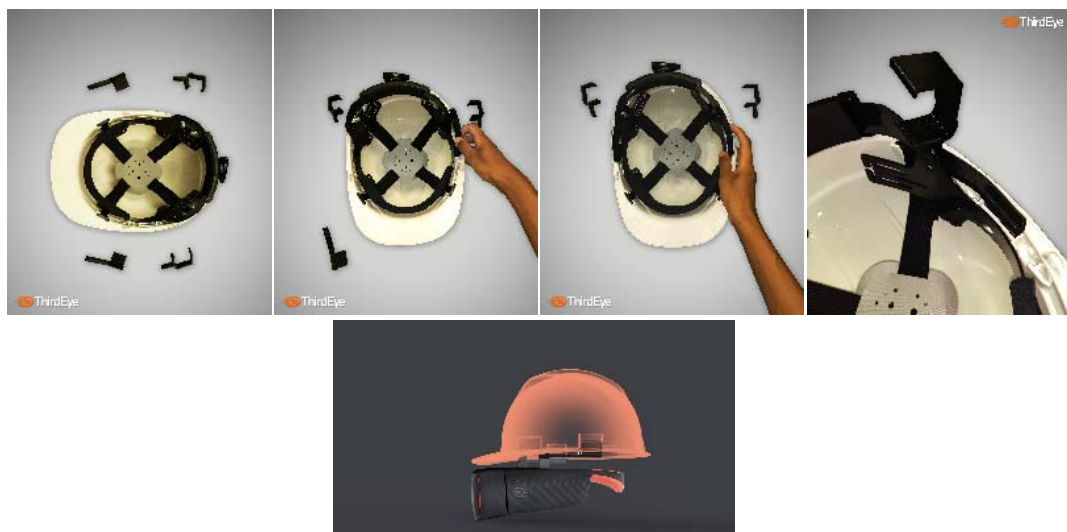

Stereo 3D Display vs Cloning Display options

The ThirdEye X2 MR Glasses displays have two modes of operation, cloning, and stereo to switch between 2D and 3D content.

Cloning Mode

Cloning mode is the default mode. In cloning mode, the left and right display show the same 720p HD display (1280x720). When you look through the glasses, it will seem like a single display to your brain. This mode is useful for running standard applications that may have already been developed. For example, in Android studio, a developer would design for a display size of 1280x720. This is the most common view of the displays.

Stereo 3D Mode

In stereo mode, the left and right display contents are different. There is a single unified display buffer at the Android level that is 2560x720. If a developer draws content on the first 0px – 1280px section, it will show up in the left eye, and if they draw on the second 1280px – 2560px section it will appear in the right eye. This feature enables a developer to draw completely different content to the left and right eye. For example, an application that wanted to render stereoscopic 3D content could use this to display the left and right views.

To switch between Cloning and Stereo Mode go to “Settings” -> “Display” and you will be able to switch in there. If an app is already developed for

Stereo on the X2, then you may not have to switch modes and the app should automatically come up in Stereo 3D (i.e. a 3D movie).

Over the Air Update (OTA)

OTA Update Requirements: Ensure that there is at least 50% charge or that the X2 is connected to a power source before starting the OTA process.

The X2 has built-in OTA for wireless updates of the OS. Occasionally you may receive a notification on your X2 asking you to update. The notification will indicate what is being updated via a text box. It is recommended that you update when you receive an OTA notification. You can ignore the OTA update & the update popup will come back later. You can also use the audio commands for OTA.

Adding/Removing Icons & Application Search

You can remove non system level apps via “long press” upon which you will see the “uninstall” option.

You can set an X2 passcode for increased security via the Android settings application. Setting a passcode means anytime you turn the X2 on/off or exit sleep mode, you will be required to re-enter your passcode.
