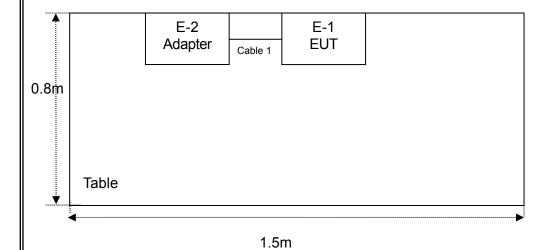
- (1) Software used to control the EUT for staying in continuous transmitting mode was programmed. After verification, all tests were carried out with the worst case test modes as shown below.
- (2) BLE(GFSK) Mode: Channel (2402/2442/2480 MHz) with 1Mbps data rate were chosen for full testing.
- (3) By preliminary testing and verifying three axis (X, Y and Z) position of EUT transmitted status, it was found that "X axis" position was the worst, then the final test was executed the worst condition and test data were recorded in this report.



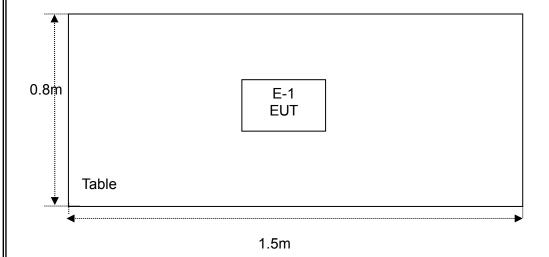

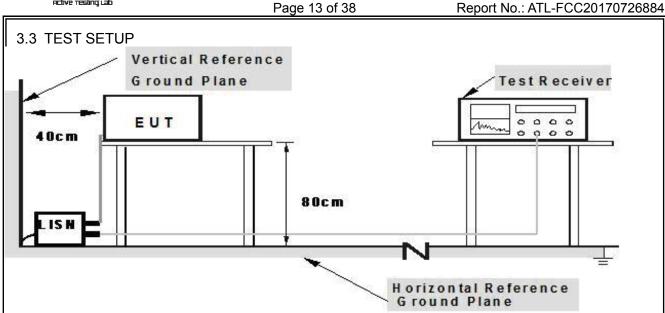

3.2 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.

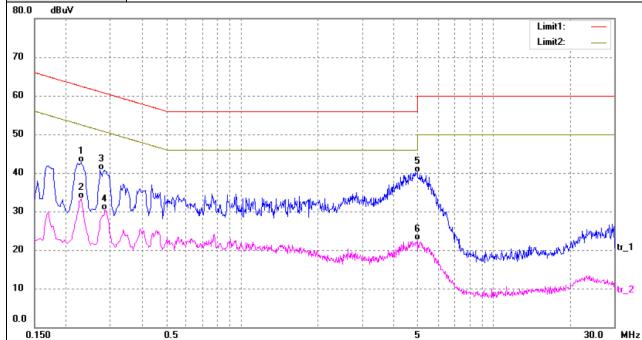

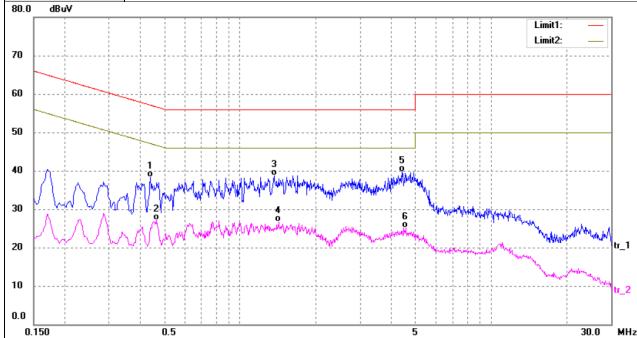

4.2 TEST PROCEDURE

- a. The measuring distance of at 3 m shall be used for measurements at frequency up to 1GHz. For frequencies above 1GHz, any suitable measuring distance may be used.
- b. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.



- c. The height of the equipment or of the substitution antenna shall be 0.8 m; the height of the test antenna shall vary between 1 m to 4 m. Both horizontal and vertical polarizations of the
- antenna are set to make the measurement.
 d. The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured, above 1G Average detector mode will be

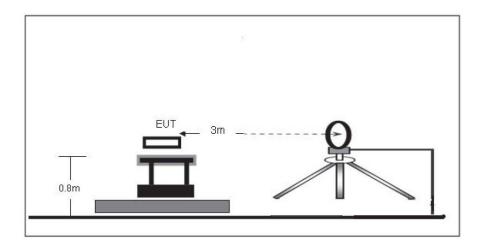

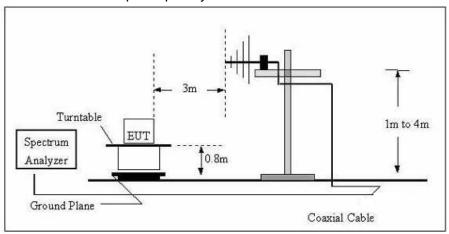

(A) Radiated Emission Test Set-Up Frequency Below 30MHz

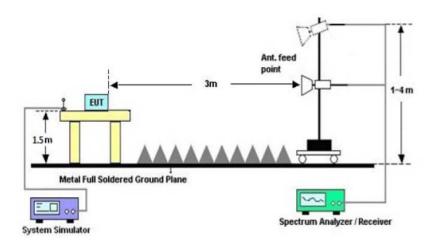


(B) Radiated Emission Test Set-Up Frequency Below 1 GHz

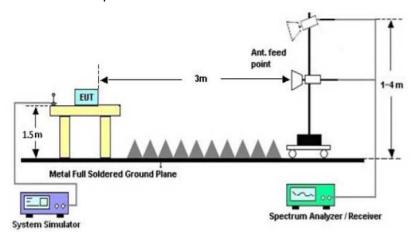

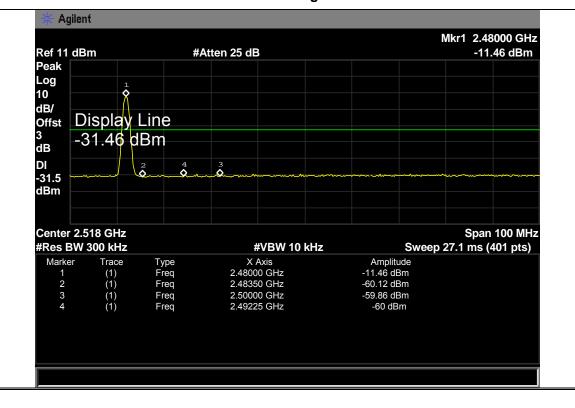




Bandedge(Conducted Emission)

9. ANTENNA REQUIREMENT

9.1 REQUIREMENT

Antenna Requirement (15.203)	An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.
