Thank you for choosing the **PIC® Pest Free Living Insect Trap** for your pest-free needs. Please read the instruction manual carefully to ensure use of this product complies with all safety regulations. The unit is equipped with UV-A and LED lighting functions designed to attract a wide range of flying insects. The trap portion has a powerful fan that pulls flying insects inside the trap, containing insect debris as a result of the rotating blades. The bright LED lantern is suitable for illuminating the surrounding area. The unit charges electronics via micro USB and plays streamed music through the bluetooth speaker system.

It is recommended that you place the unit away from you when using as a trap to draw the insects towards the light and away from you in an effort to have a pest-free experience indoors or outdoors.

### OPERATION:

The unit should be fully charged using the micro USB cord that was included with your purchase before use. Plug the Micro USB end of the cord into your unit, and the USB end of the cord into any USB port; additional equipment is not required. The indicator light on your device blinks when charging and stops blinking when ready to use.

**1. To turn the trap ON**, simply slide the switch located on the side of the unit to the right.

**2. To turn the dimmable lantern ON**, rotate the dial on the front of the unit to the right. To dim the light, rotate back to the left.

**3. To turn the bluetooth speaker ON**, first turn the bluetooth function on your phone or tablet on. Then, simply press and hold the button on the top of the unit next to the speaker until the unit speaks, "Connected. Bluetooth on." Begin streaming music from your electronic device. Bluetooth will automatically disconnect when not in use, or when your electronic device is too far away to connect. Disconnect manually by pressing and holding the button on the unit, or by turning off the bluetooth function on your electronic device.

**4. To hang the unit**, pull the hook upwards and out of the handle.

**5. To clean the unit**, ensure the unit is **OFF** by sliding the switch located on the side of the unit to the left. Unscrew the base of the unit and gently shake free any accumulating debris, or use dry, forced air to blow debris out of the unit.

It takes 7 hours for the product to charge completely. On a full charge with the trap function running only, the product will last approximately 10 hours until needing to charge again. Lantern only lasts approximately 8 hours. The trap and lantern together lasts approximately 5 hours. For optimal use of these functions, it is recommended to not charge your electronics from the power bank for any long length of time and to only use in an emergency.

CAUTION – Power off unit before servicing.

CAUTION – Collected insects may be a fire hazard. Clean dead insects from the unit frequently.

WARNING – Skin or eye damage may result from directly viewing the light produced by this apparatus.

CAUTION – ELECTRICAL SHOCK HAZARD MAY EXIST IF WATER FROM A GARDEN HOSE IS DIRECTED AT UNIT WHILE IN OPERATION.

CAUTION – Do not stick foreign objects, metal objects or fingers into the unit.

CAUTION – Do not tamper with or modify unit.

CAUTION – Do not clean unit while it is powered on.

CAUTION – Do not clean or spray the unit with water, cleaning spray, or any other liquid. Do not use or leave in rain.

CAUTION – Do not submerge unit in water or any liquid.
