3.1. Installation Instructions

Switch off the power, then fix the smart adaptor into the normal lamp holders, then fix the lamp into the smart adaptor, turn on the power switch.

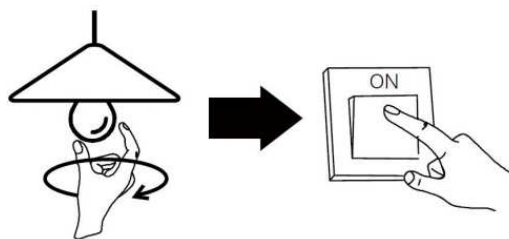

3.2. Download and Install livsmart APP

Way 1

1. AppleOS enter the App Store, Android enter GooglePlay.

2. Search "livsmart", download installation program.

Way II:

3.3 APP manual

1. Adding equipment:

Press the button "+" to add equipment.

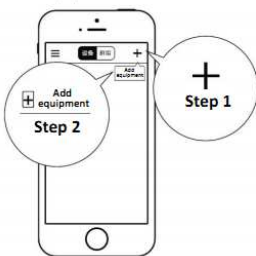


Diagram 3: APP adding equipment instruction

Remark: When first connected to the electric network and started the equipment, the lamp will flicker, that is showing the equipment is in the status as delivered, could be found and added by the APP.

2.Group setting

This equipment is using the latest Bluetooth MESH networking technology, through the group controlling function it can control multi-devices. If there are different equipments in one group, the color modulation and contextual model can't be used. If they are the same, then all the functions can be used perfectly.

3.Sharing equipment

In order to avoid the vicious operation of the equipment, one equipment can be only added one time by one mobile phone, if needed to be controlled by the other mobile phone, please use the APP sharing function.

3.4 Reset guidance

If need to re-install the APP or the equipment is deleted from APP, and need to re-add the equipment, it could be realized through the reset. When needed to restore the factory settings, you can activate this function through turning on and off the power continuously for six times. But we suggest this process should not be too fast. You should wait for the light on before you press the power off button. And when you see the light flickers, it is restored.
