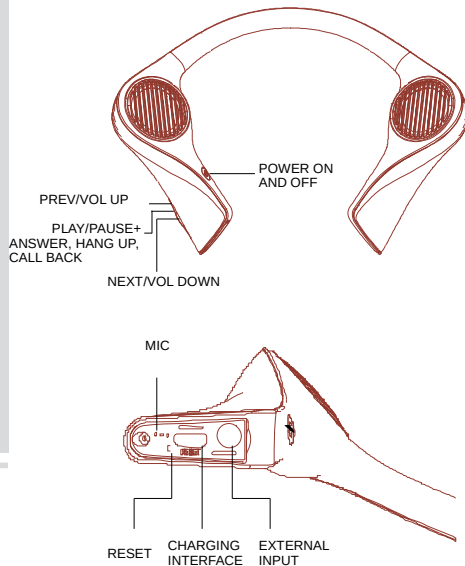


Hi-Fi Wearable Music Bluetooth Speaker Instructions

Button Operation Instructions



Main Specifications

1. Speaker: Diameter 36mm
2. Impedance: 4 Ω
3. Sensitivity: 98dB
4. Frequency response range: 20-20KHz
5. Rated Power: 2.5W+2.5W
6. Battery: Polymer 600mAh
7. Bluetooth: 3.0
8. Connection distance: about 10m
(depends on the external environmental disturbance)

Connection

Start: take out the machine from the package, press the switch key to power on, wait until the sound of "the bluetooth connecting", this machine has been switched on and entered the pairing mode

Key Point

1. If a crash occurs (all buttons operation failed), insert the elongated tool into the reset hole, and then restore the machine to normal use.
2. If the machine does not do any operation after starting, the machine will automatically shut down after 5 minutes.

Function Introduction

- Support caller ID voice reporting, automatic Voice reporting when an incoming call, avoid to missing important calls.
- Support voice alarm function to report state to the user in real time, such as bluetooth Connecting, bluetooth connect successfully, bluetooth disconnect, audio input, maximum volume, shutdown and so on.
- Support cell phone power display, support display the current power of bluetooth headset on the phone to consider whether to charge the headset.

Call and Music Control

When answering the phone or end the call: pressed the PLAY/PAUSE button once.

Refuse the call: Long press "PLAY/PAUSE" once.
Dial: press "PLAY/PAUSE" two times continuously (only support callback the last call number)

Play or pause music: press "PLAY/PAUSE" once.

Volume Adjustment: Press "+" button continuously to turn the volume up, Press "-" button continuously to turn the volume down.

Change the play track: short press "+" or "-" button, will change the play track.

Shutdown: Long press 2 seconds "shutdown button", the device will close after the voice prompt "shutdown".

Safety Cautions

Do not remove or modify the unit for any reason, otherwise may cause the machine to fail or burn down, Please send this machine to the authorized service center for repair or replacement of the battery.
Use this machine when driving, please observe the regulations of the country or region.
Do not store this machine in a high temperature (50 / 122) environment (For example An overheated car or direct sunlight), otherwise it may affect its performance and shorten the service life of the battery.

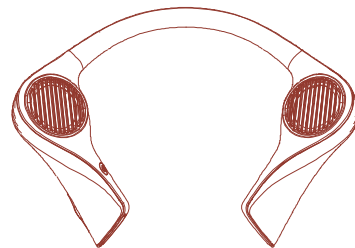
