## 5.2 MPE Calculation

The Max Conducted Average Output Power is 19.86mW;

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

For FCC:

According to the formula  $S = \frac{PG}{4R^2\pi}$ , we can calculate S which is MPE.

Note:

- 1) P (Watts) = Power Input to antenna =  $10^{\frac{dBm}{10}} / 1000$
- 2) G (Antenna gain in numeric) =  $10^{\frac{Antenna gain in dBi}{10}}$
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

$$S = \frac{PG}{4R^2\pi} = \frac{19.86 \times 1.58}{4 \times 400 \times 3.14} = 0.0062 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
