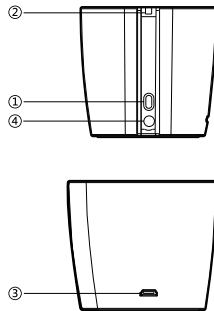

### Boot/shutdown/connection

Boot state: please turn the power switch to "ON", and then we will hear the melodious prompt tone of "POWER ON" from the sound box with the flashing of indicator



light of blue-tooth at the same time.  
Shutdown state: please turn the power switch to "OFF", with the blue-tooth indicator light going out at the same time.

### Blue-tooth connection

After the power is turned on, the speaker automatically enters Bluetooth search state, the Bluetooth indicator light flashes red and blue alternately, it will automatically shut down if without phone pairing for 5

minutes, and you can hear the voice broadcast "POWER OFF".

Select "hoox-s01" and click pairing in the Bluetooth devices list to automatic pair, the Bluetooth devices will prompt whether to pair, after successfully connected, you will hear the sweet tone "YOUR DEVICE IS PAIRED" while blue light flashes. If not successfully connected, you will hear a voice broadcast "YOUR DEVICE IS DISCONNECT".

The device which has been successfully paired will automatically connect when started next time.

#### **Charge for using:**

The data lines of USB of standard configuration are inserted into the mini USB holes of sound boxes, and the USB at another end is inserted into the power supply equipment, such as: computer, general 5v USB adapter, etc. When charging, the red indicator lights are on. After the batteries are charged fully, the blue indicator lights are on.

#### **Music play:**

The audio lines provided are inserted into audio jacks of music players such as audio input interface of speakers of AUX and

computers etc respectively, and then players begin to play. The music will sound immediately in this machine, players controlling the volume size and choice of songs, etc.

#### **Matters needing attention:**

In order to correctly use the magic cup blue-tooth speaker for users, it ensures that the performance of the magic cup blue-tooth speaker is good, please read carefully and comply with the matters needing attention:

- Be sure not to impact the host seriously.
- Be sure not to contact chemical drugs such as benzene and thinner, etc.
- Please don't get close to strong magnetic field and electric field.
- Please keep away from direct light or heating apparatus.
