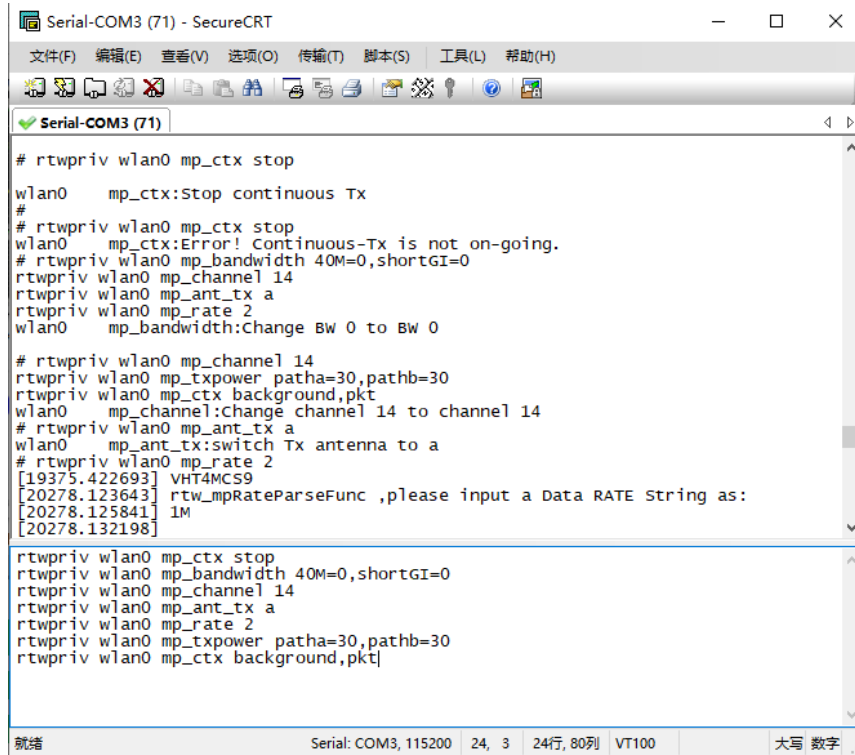

Test_Graph_802.11b_ANTA_2412_1Mbps_OBW

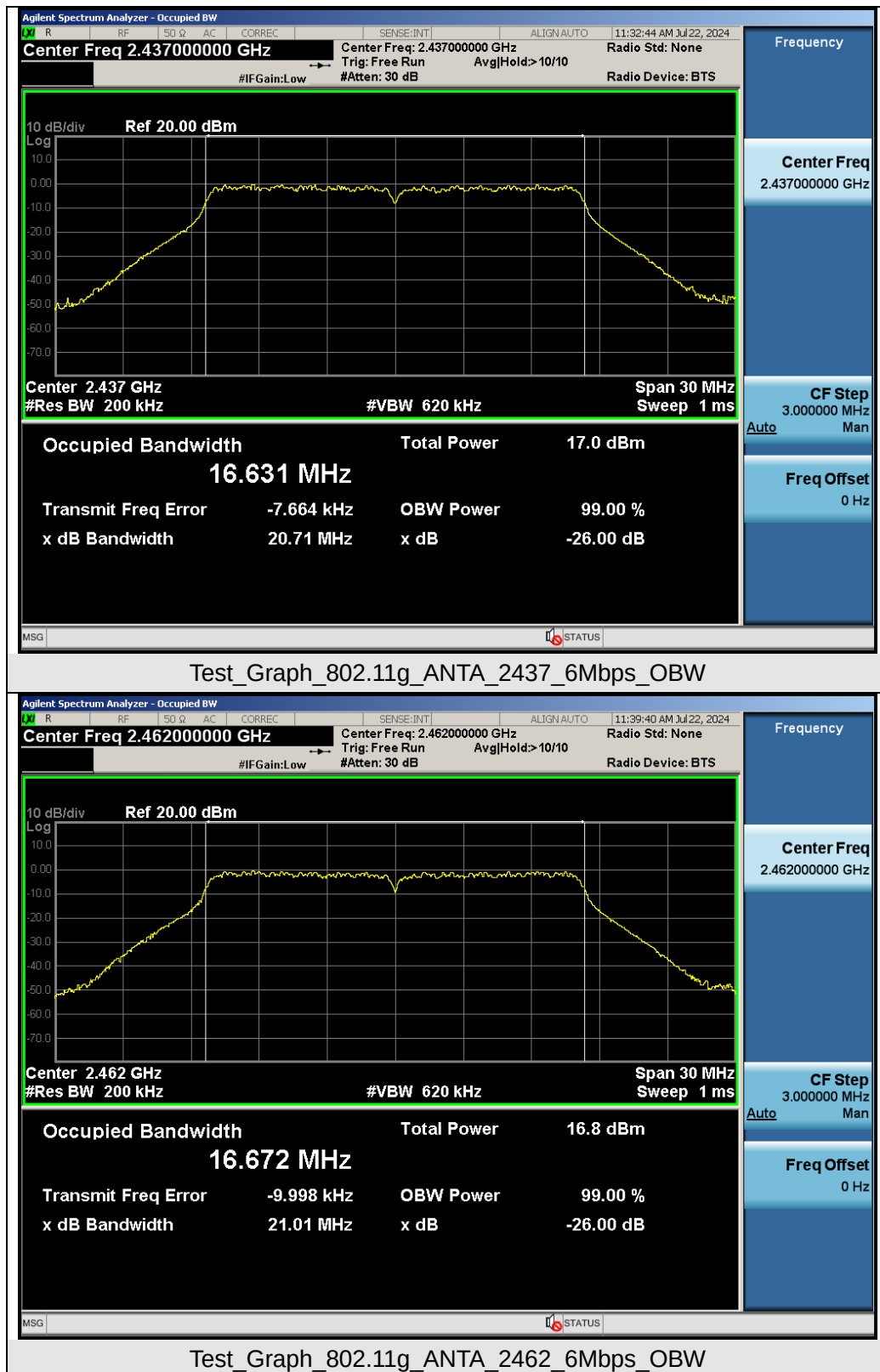

Test Graphs of DTS Bandwidth

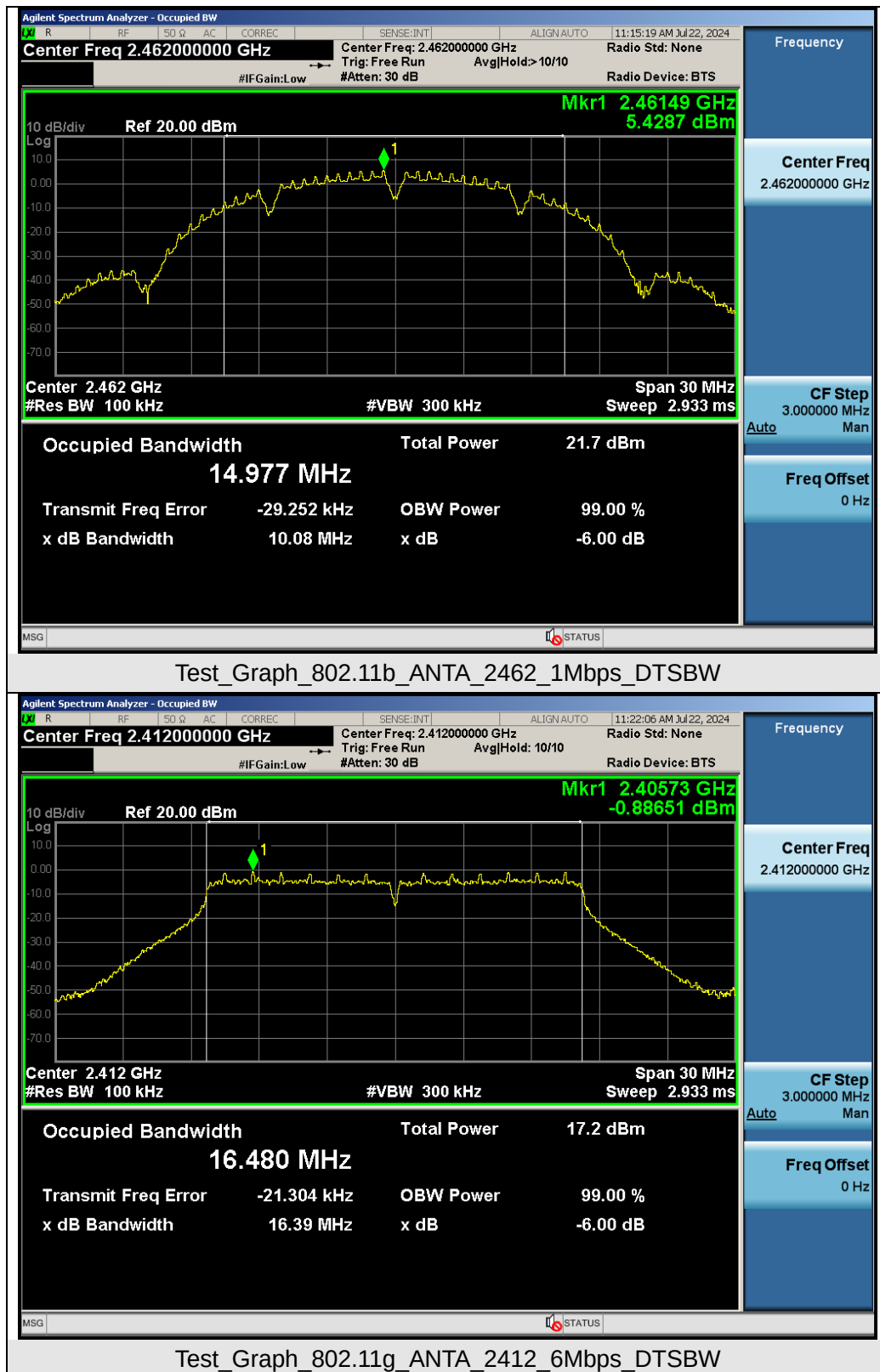

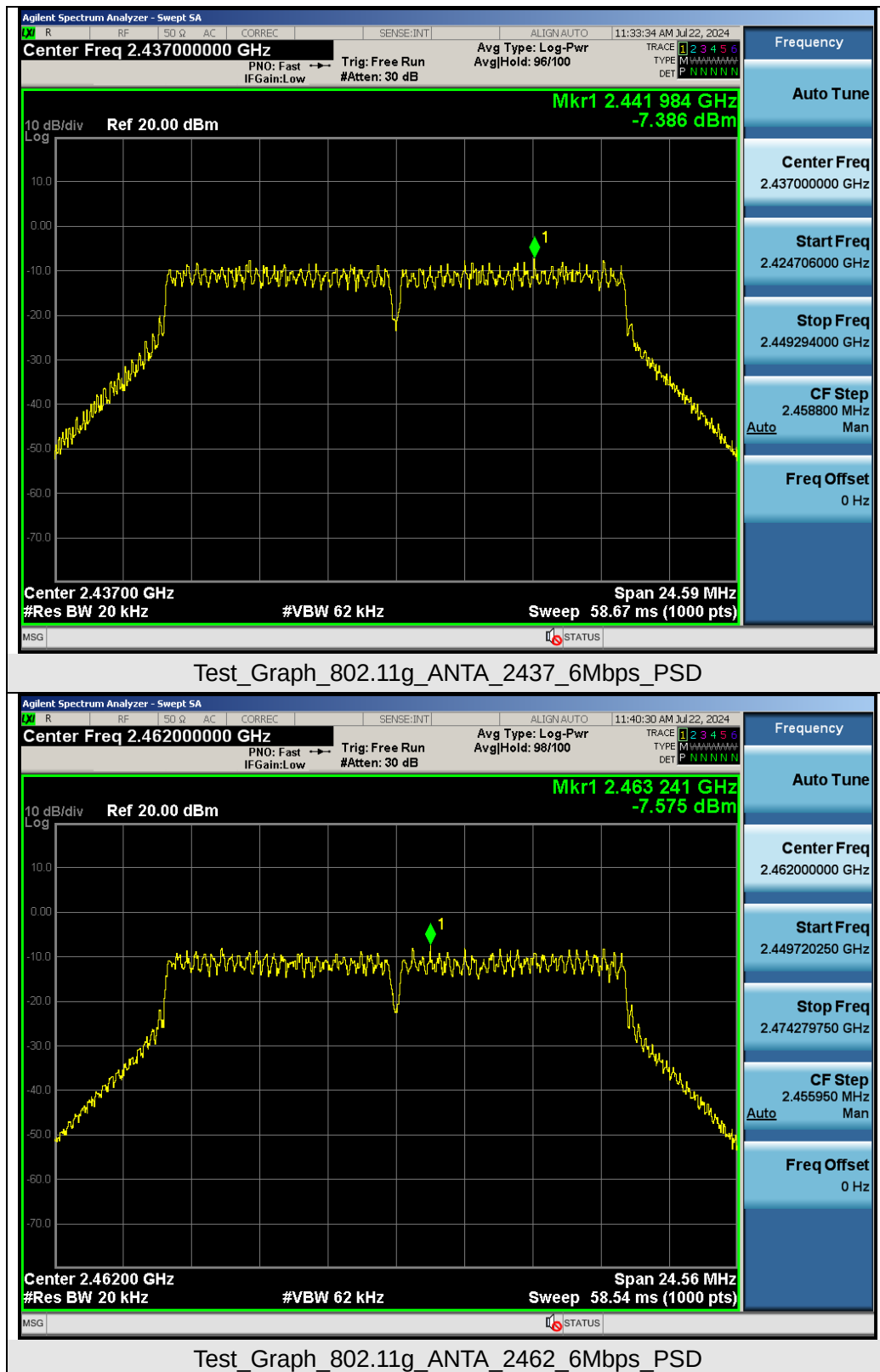
Test Graphs of Conducted Output Power Spectral Density



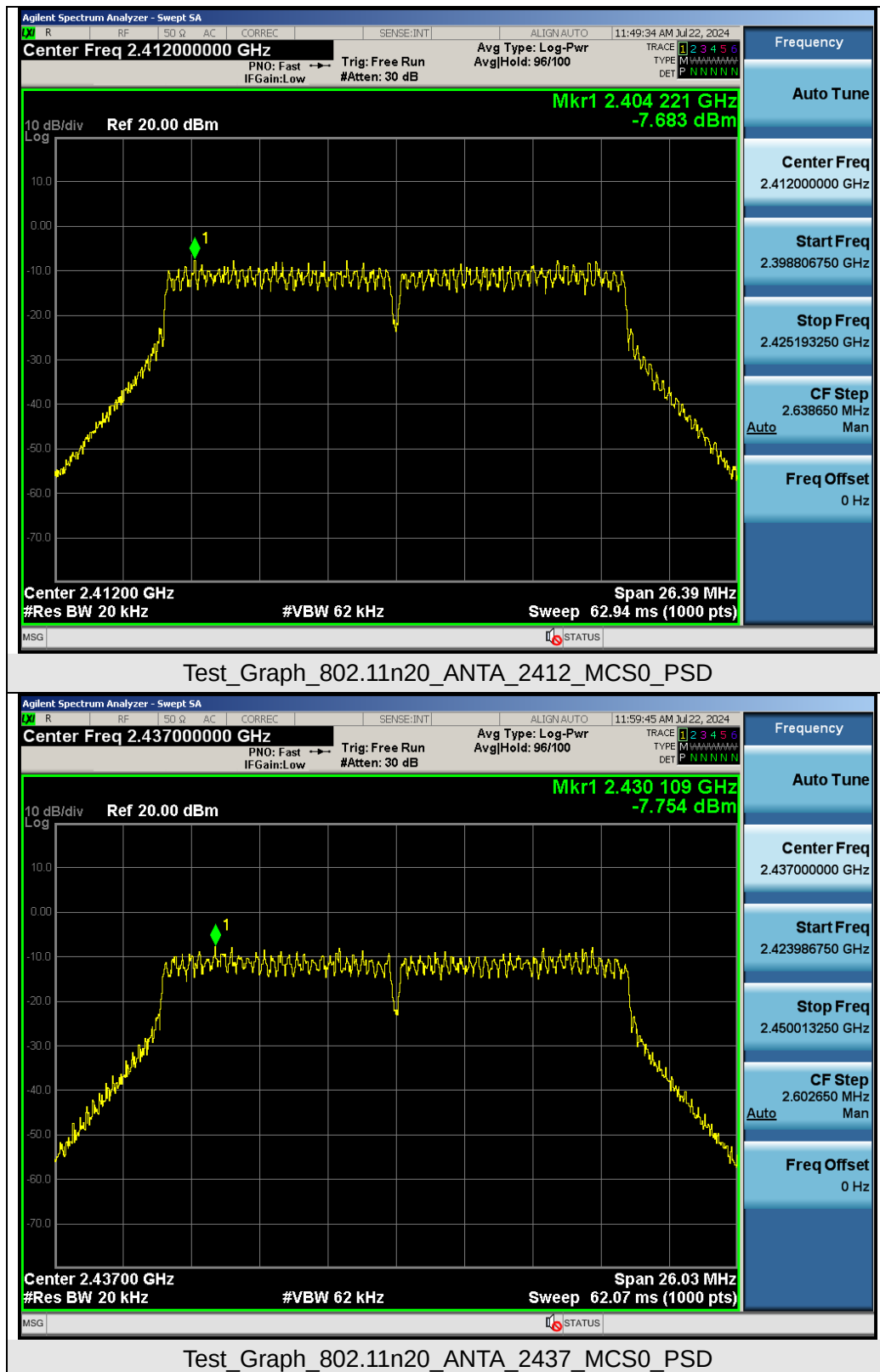

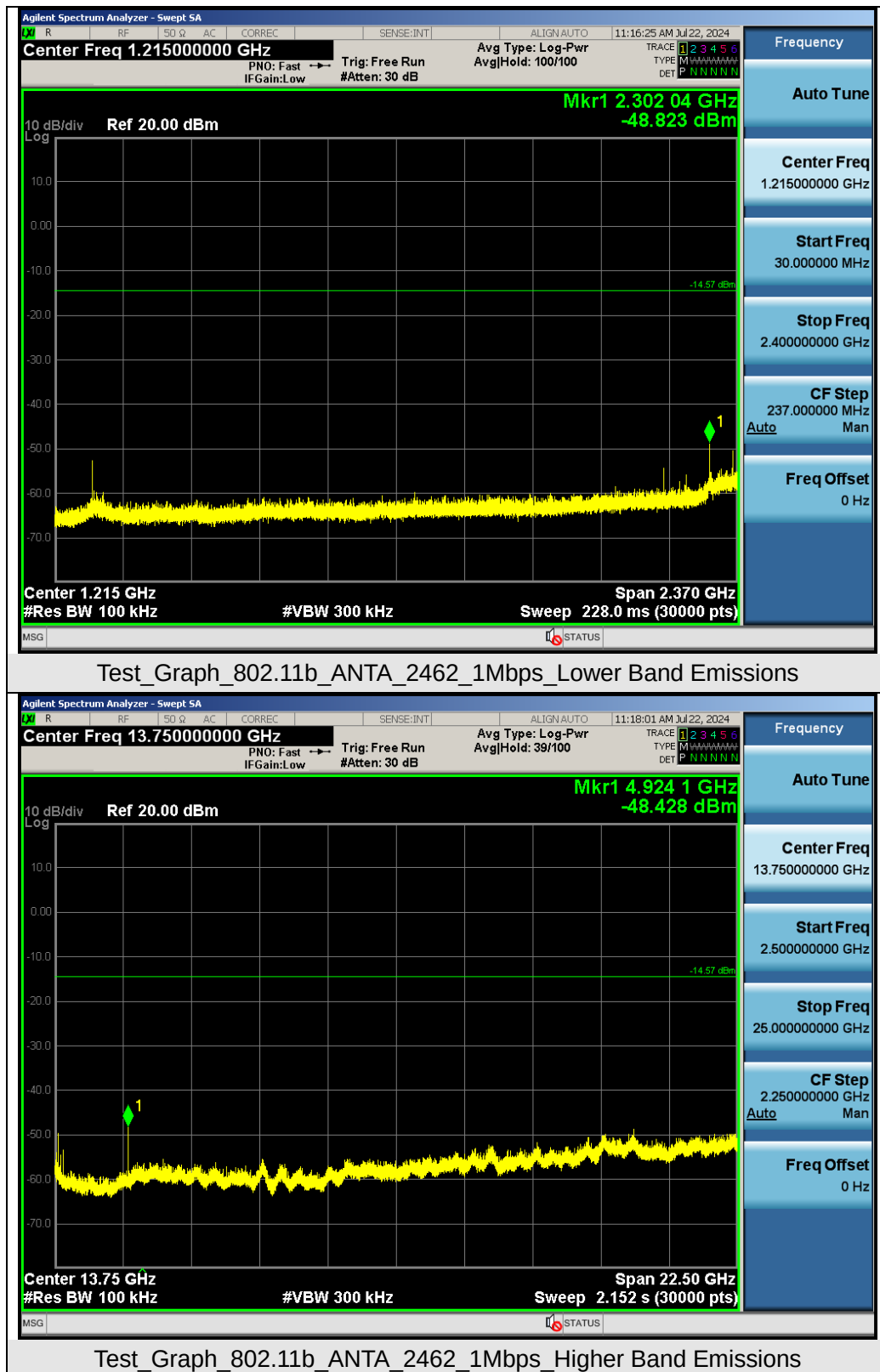
Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



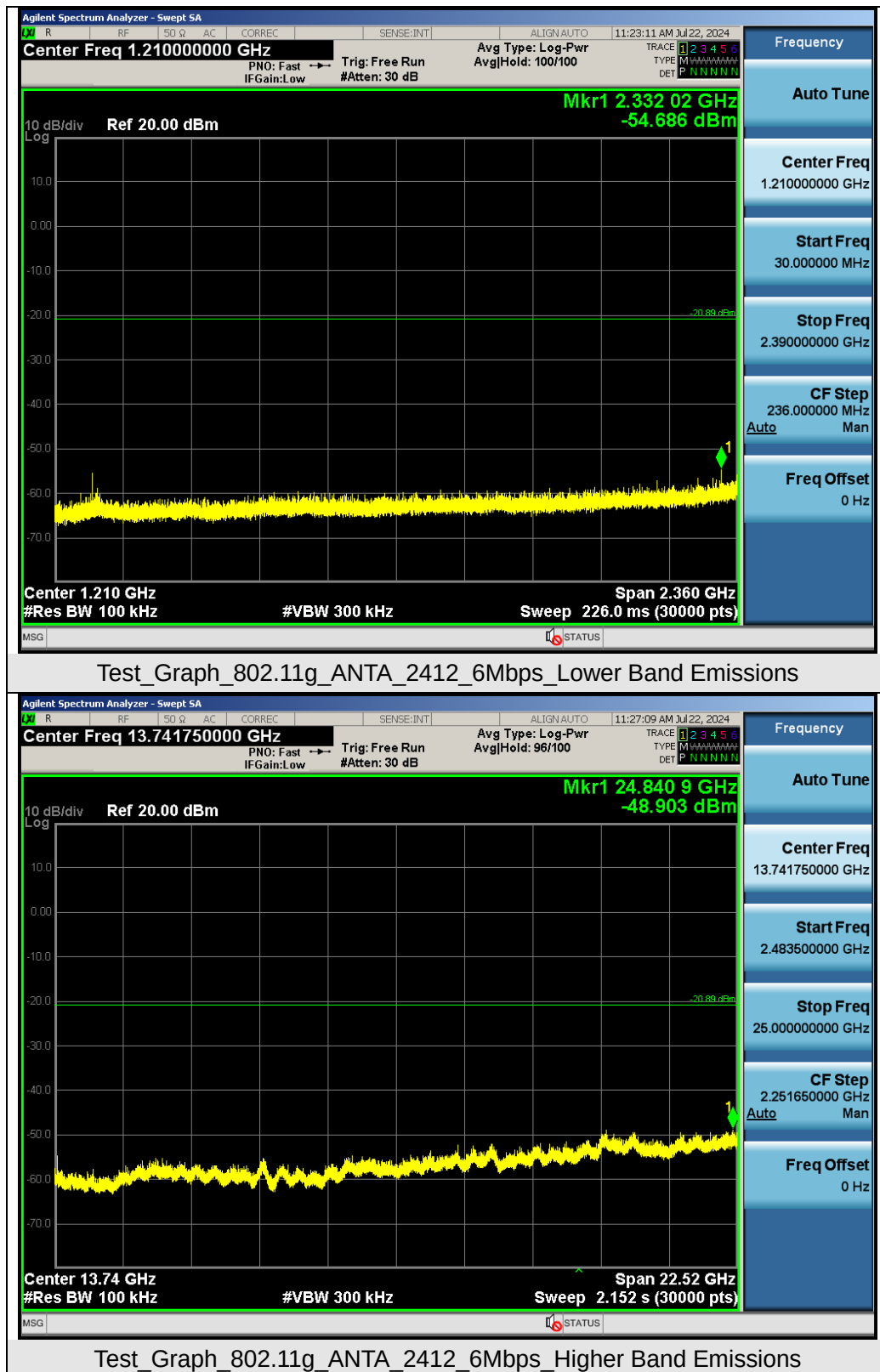
