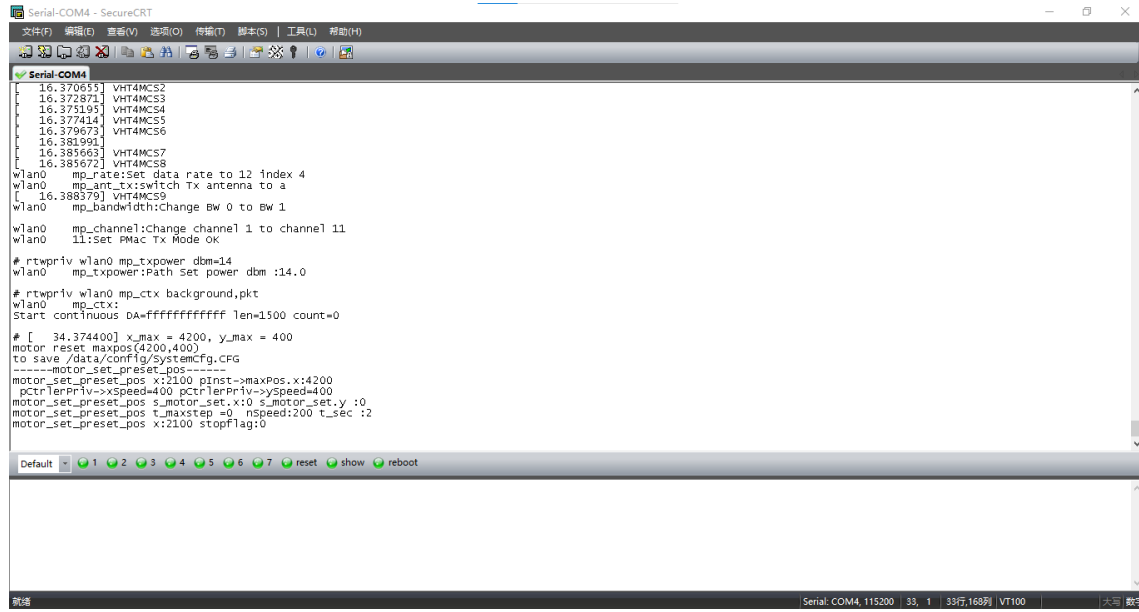

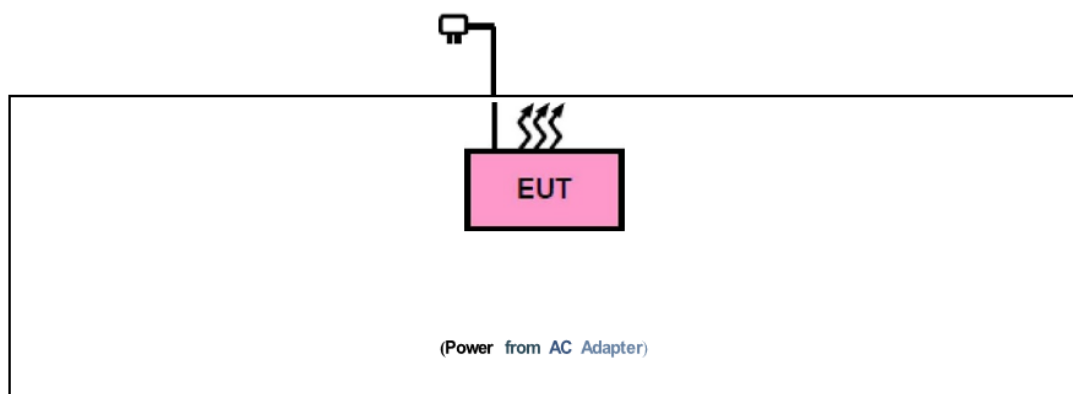

2.4GHz WLAN (DTS) operation is possible in 20MHz, and 40MHz channel bandwidths. The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, and detector = Peak. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

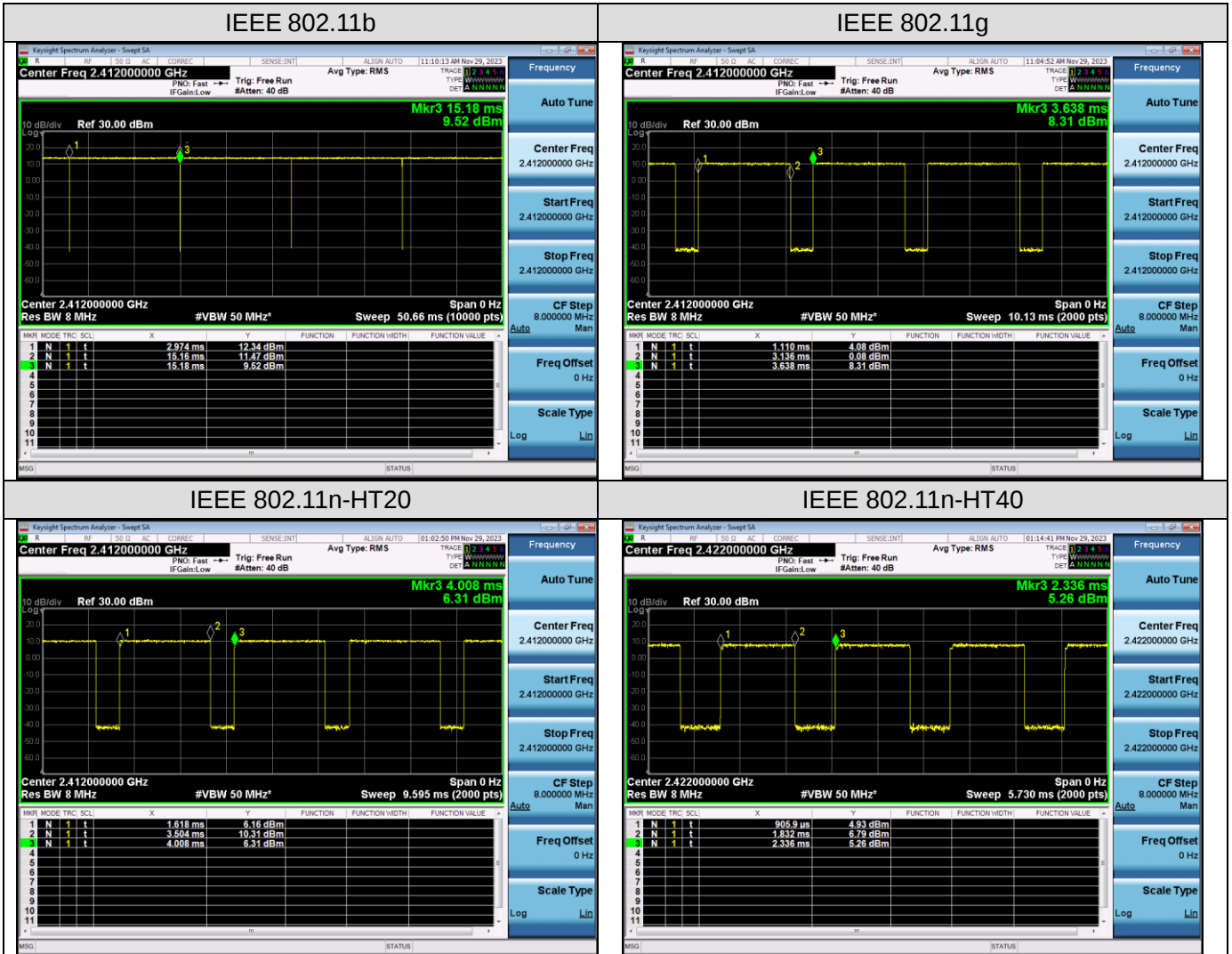

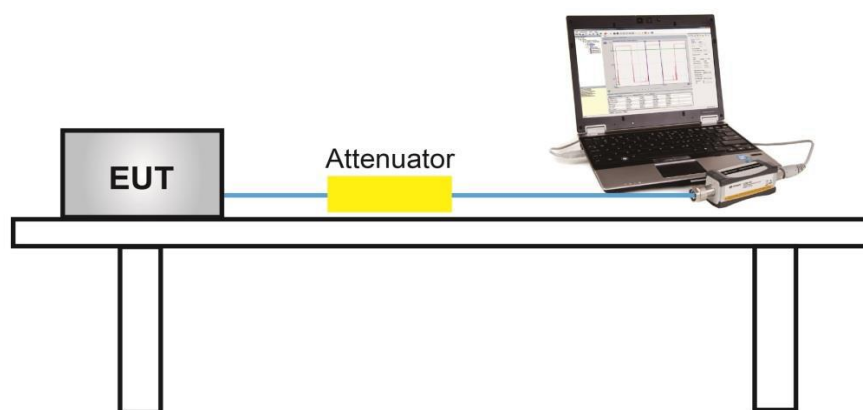

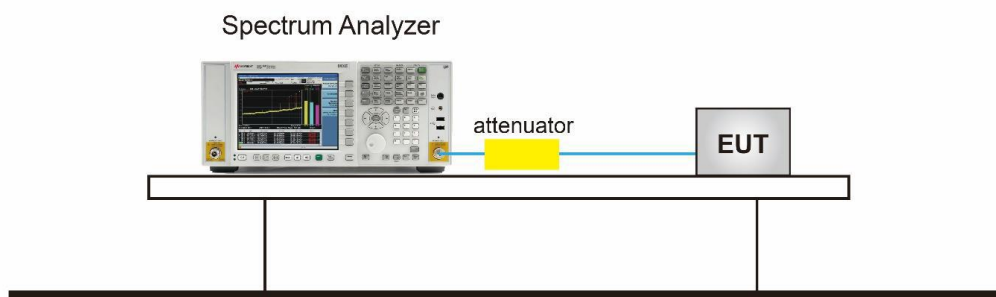
The minimum 6dB bandwidth shall be 500 kHz.

### 8.2 Measurement Procedure

The testing follows the ANSI C63.10 Section 6.9.3 (OBW) and 11.8.1 (6dB BW).

1. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
2. Set to the maximum power setting and enable the EUT transmit continuously.
3. For 6dB Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement.
4. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 1-5% of the OBW and set the Video bandwidth (VBW)  $\geq 3 * RBW$ .
5. Detector = peak
6. Trace mode = max hold.
7. Sweep = auto couple.
8. Allow the trace to stabilize.
9. Measure and record the results in the test report.

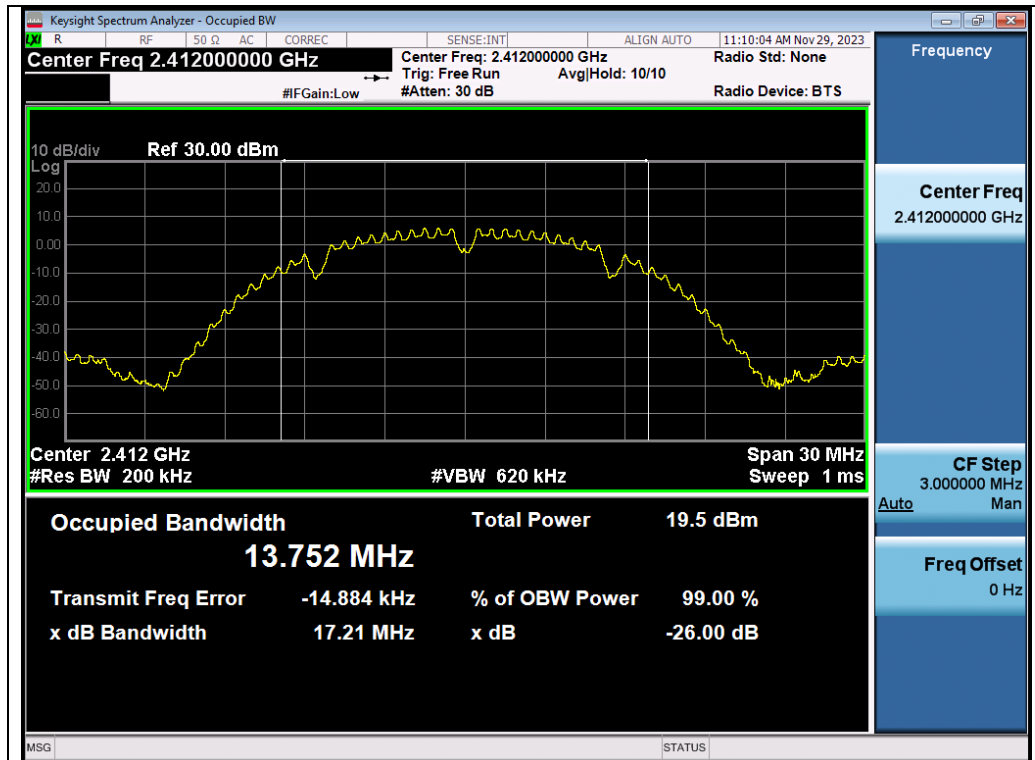

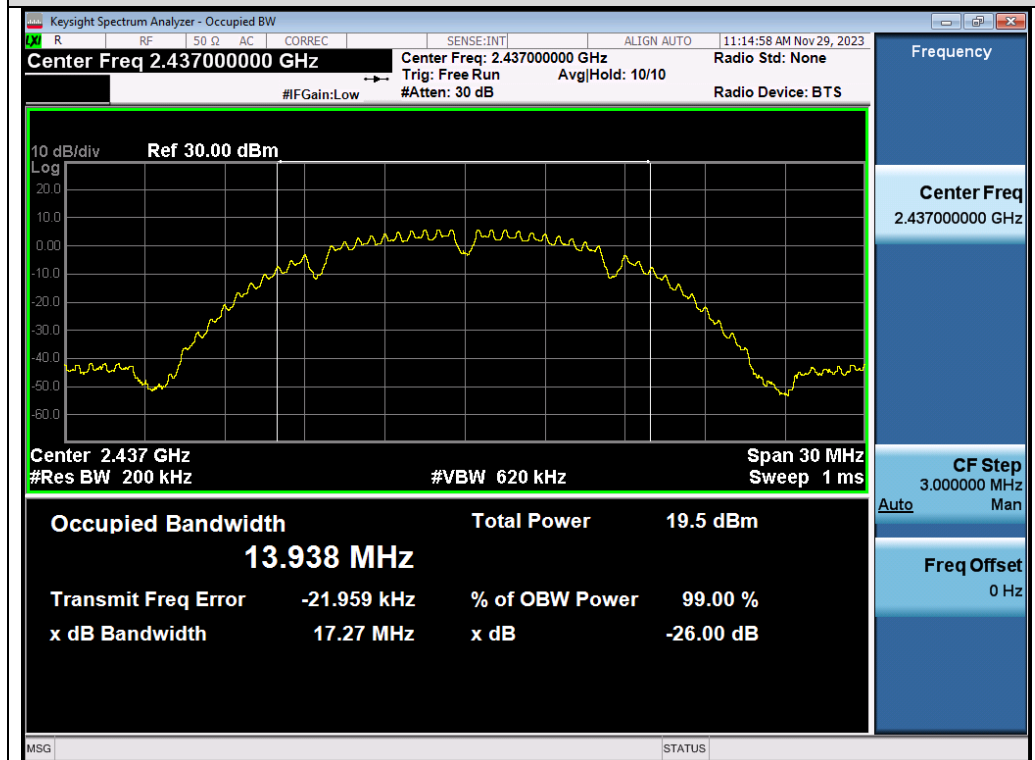

### Test Graphs of Occupied Bandwidth

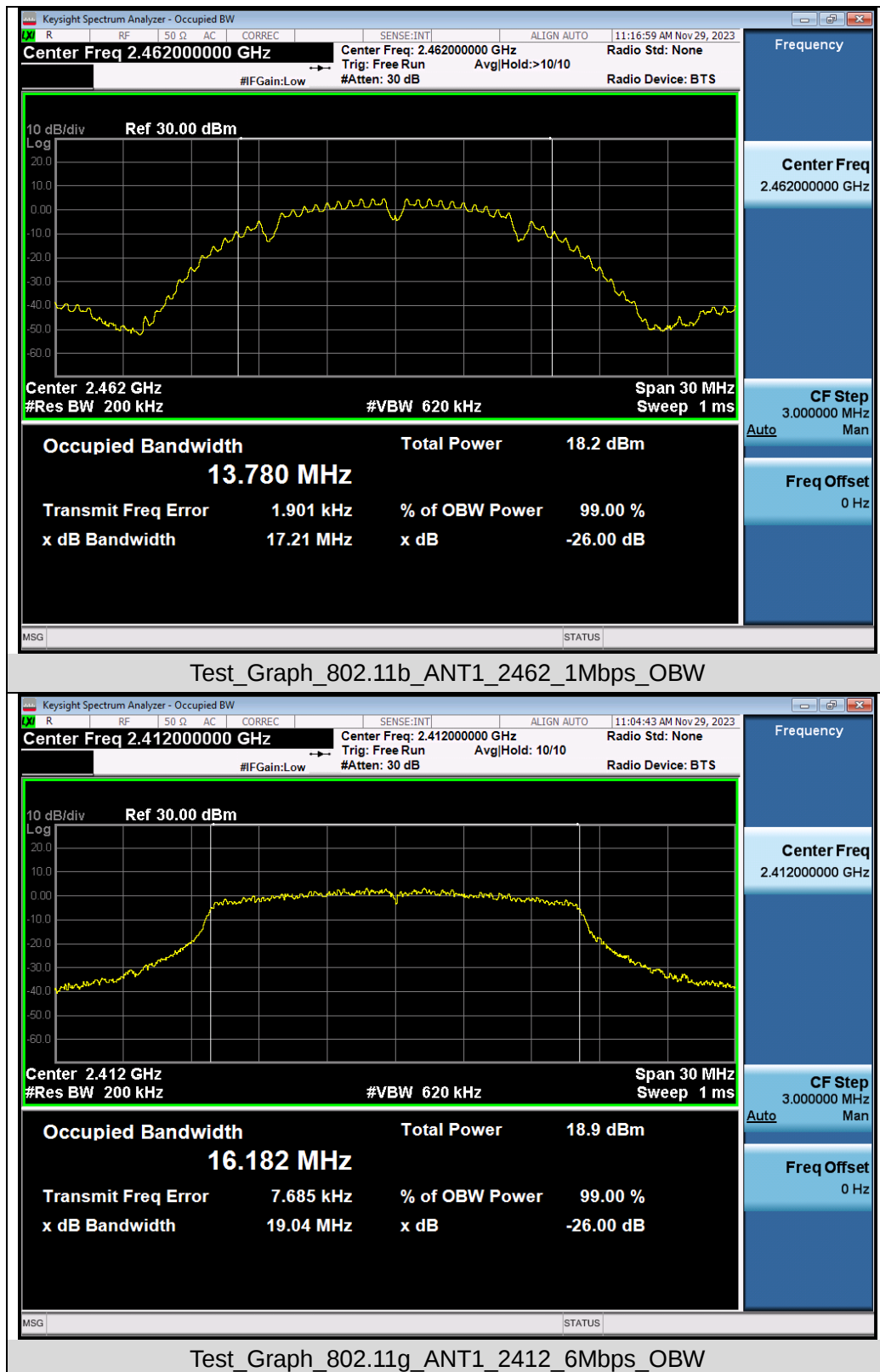


Test\_Graph\_802.11b\_ANT1\_2412\_1Mbps\_OBW

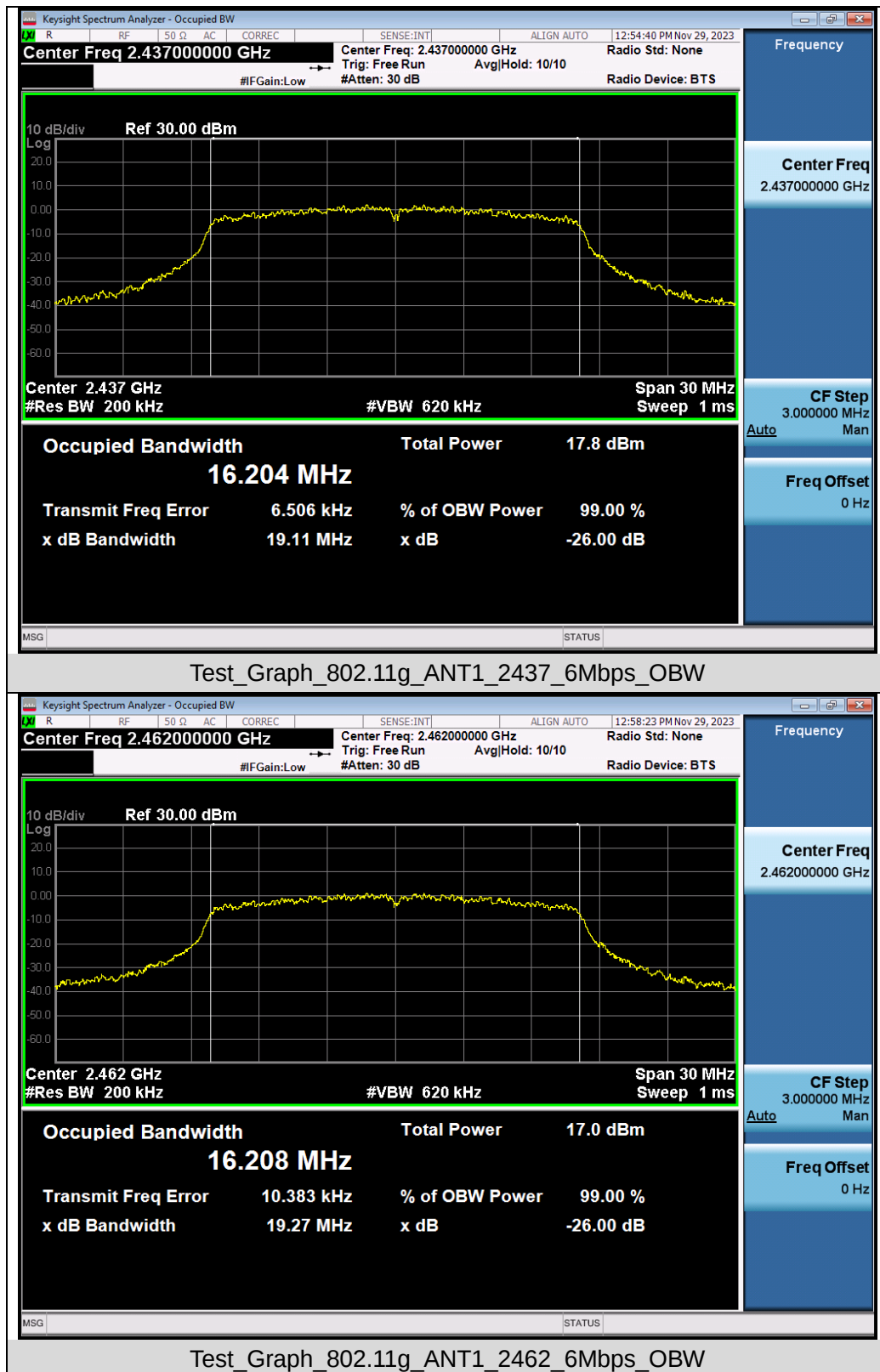

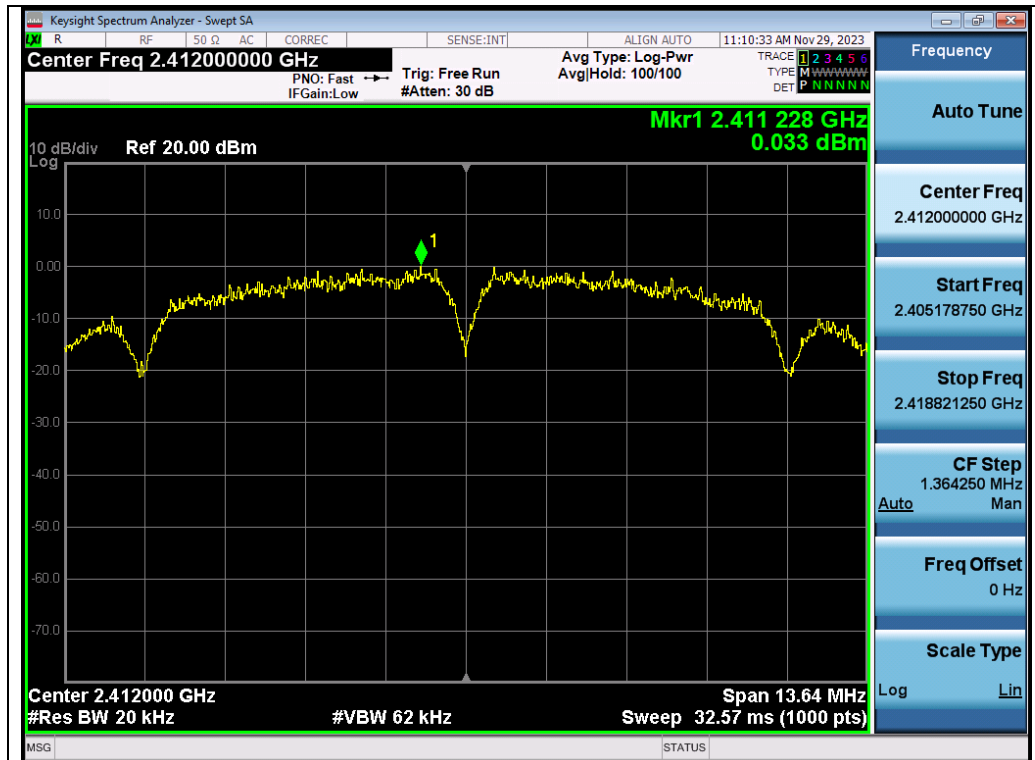

### Test Graphs of Conducted Output Power Spectral Density

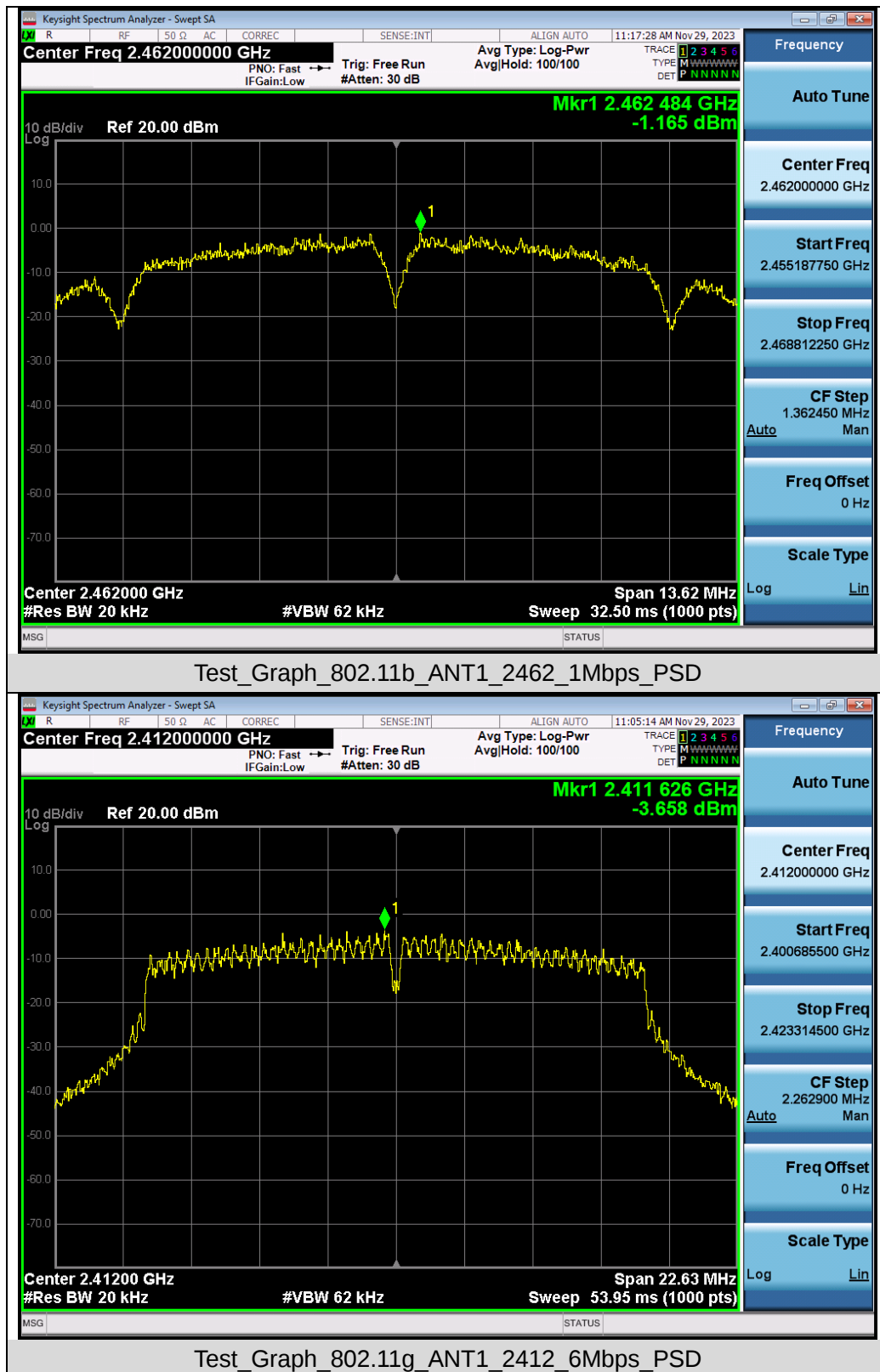

## 10. Conducted Band Edge and Out-of-Band Emissions

### 10.1 Provisions Applicable

In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.

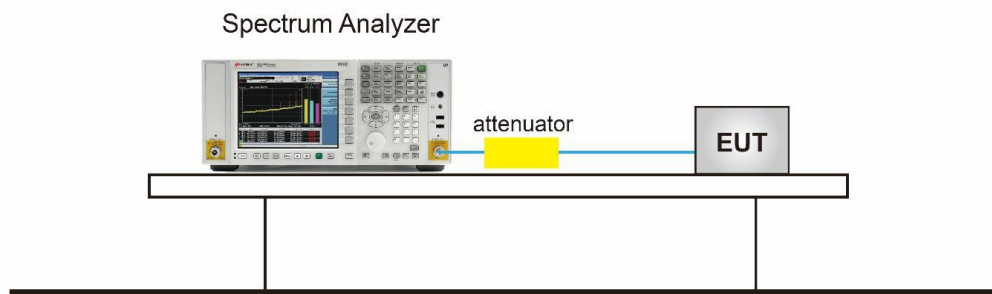

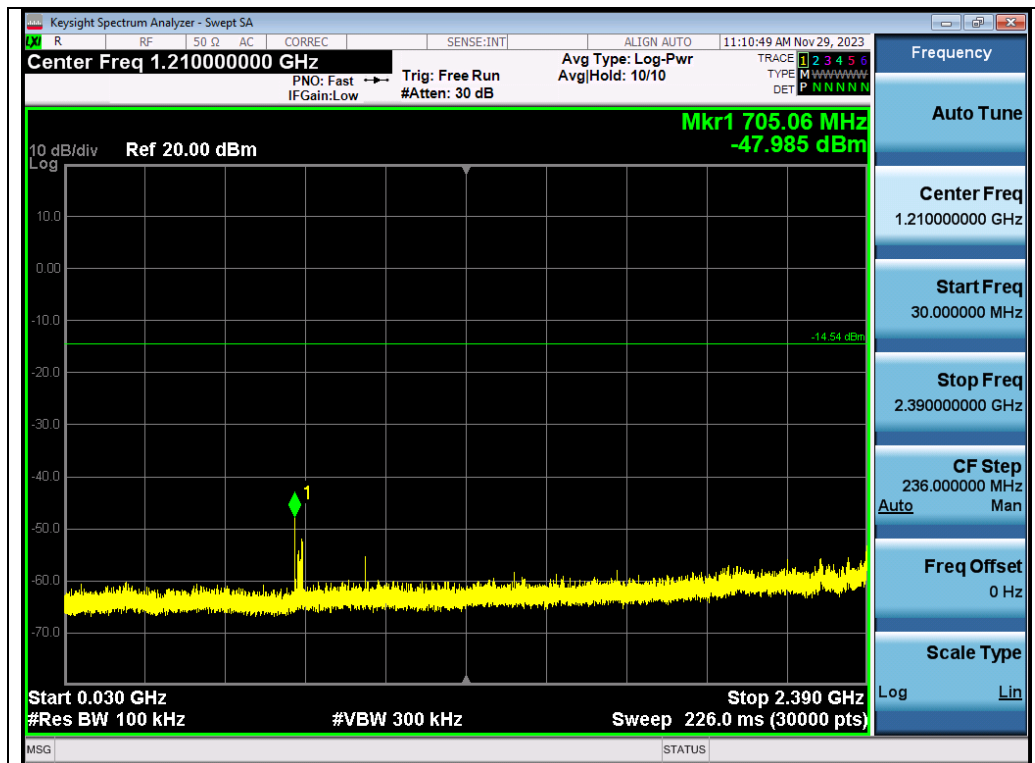

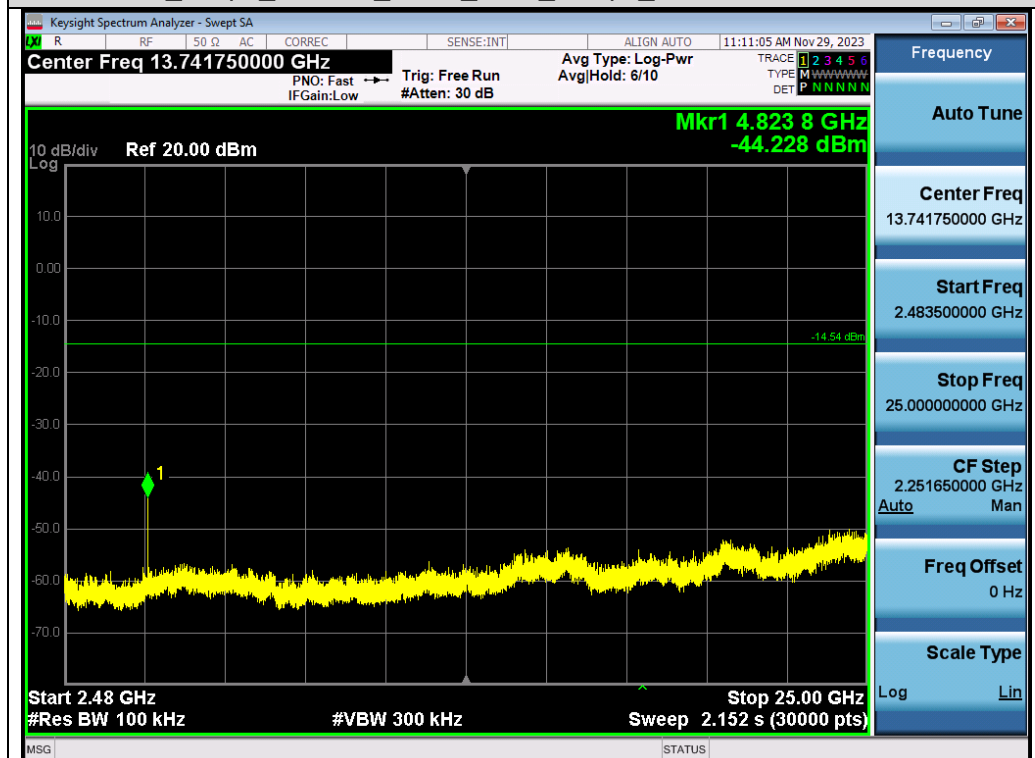

### Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands

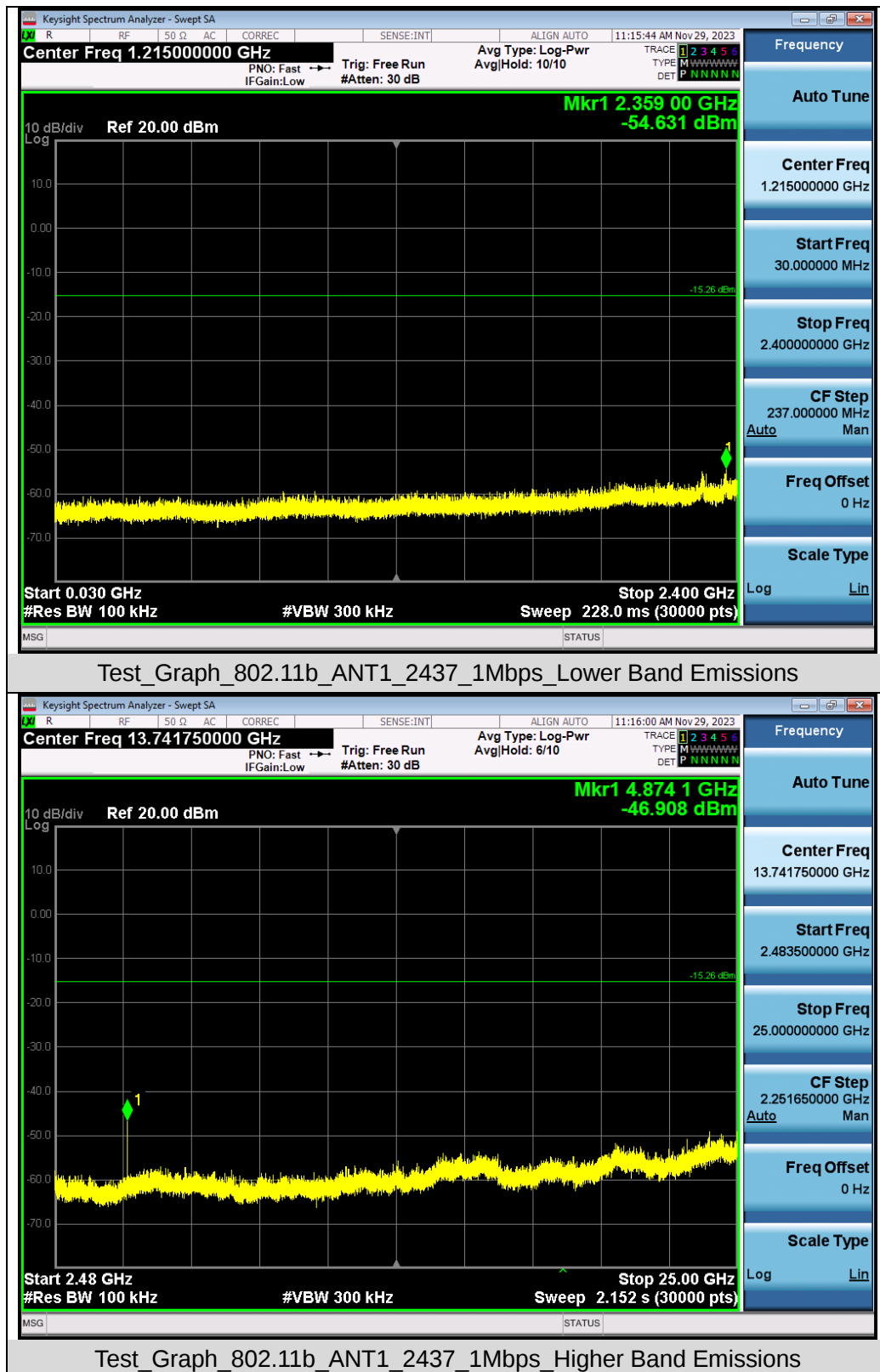


### Test\_Graph\_802.11b\_ANT1\_2412\_1Mbps\_Lower Band Emissions

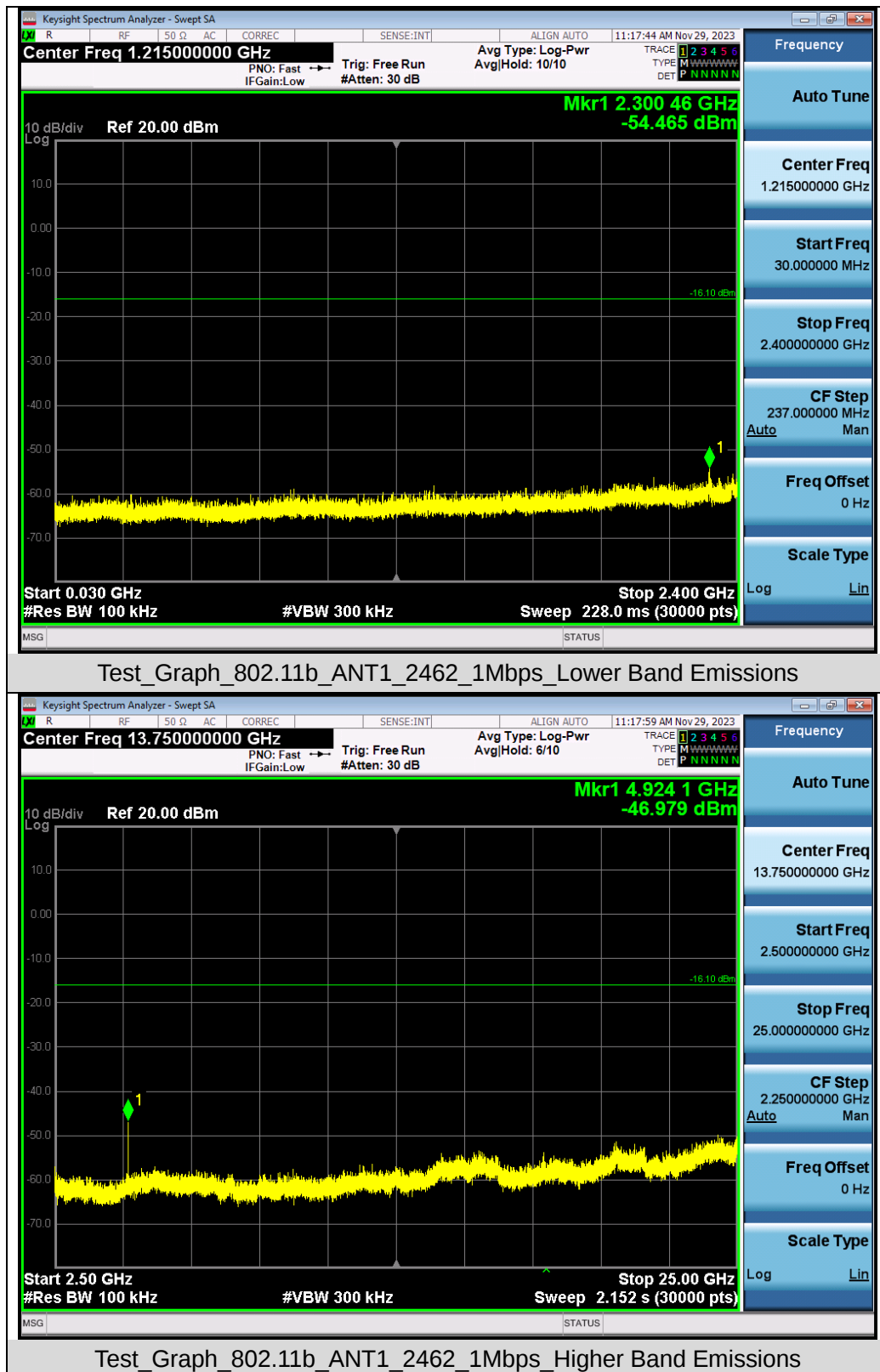


### Test\_Graph\_802.11b\_ANT1\_2412\_1Mbps\_Higher Band Emissions

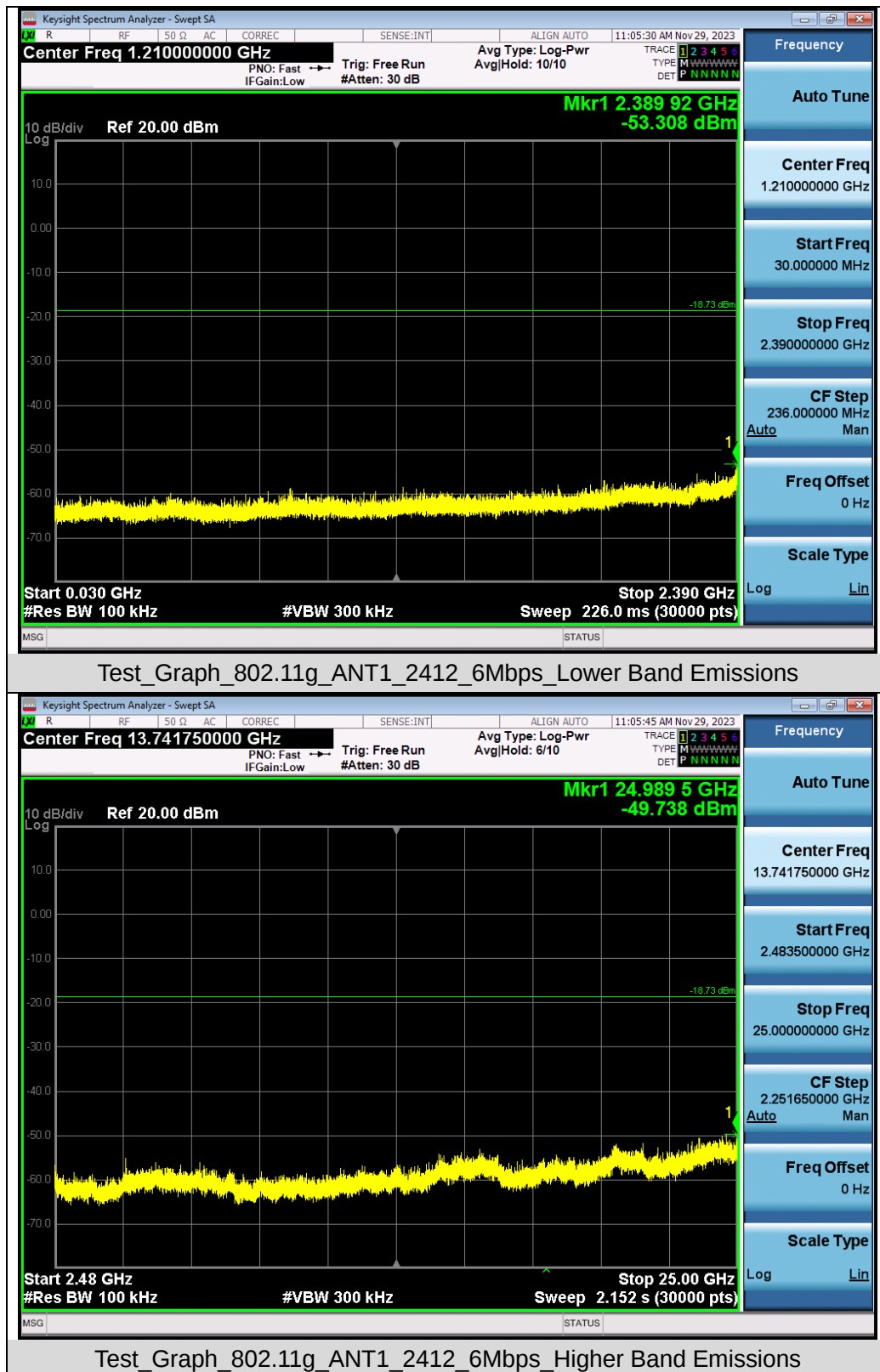

### Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands

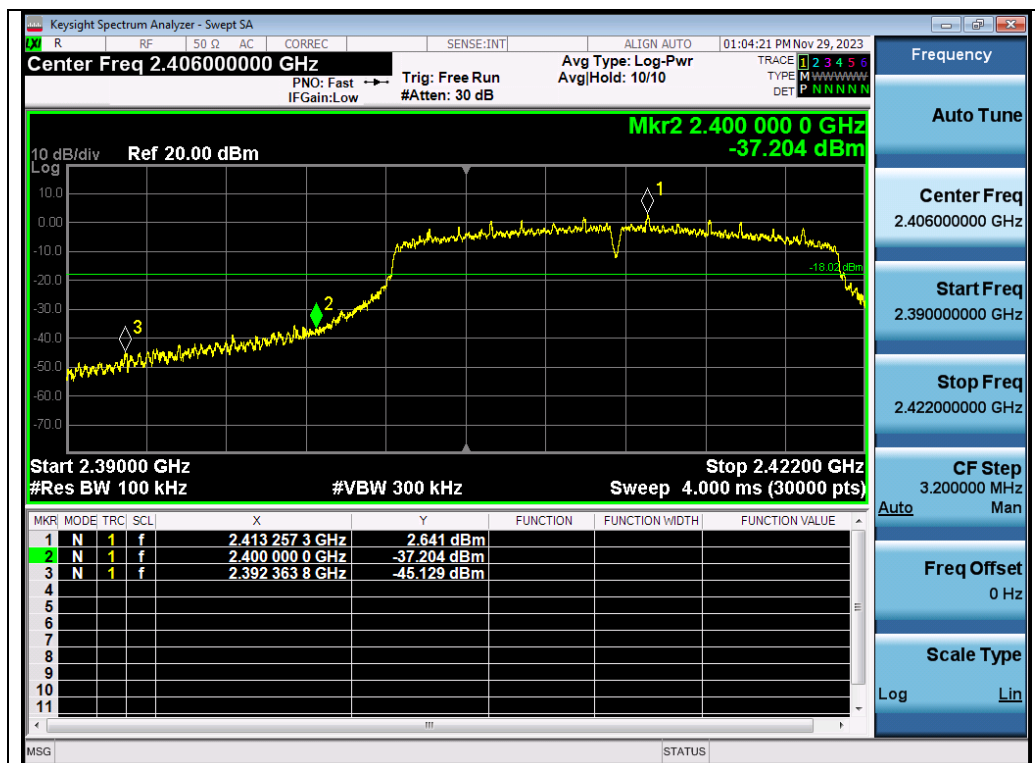

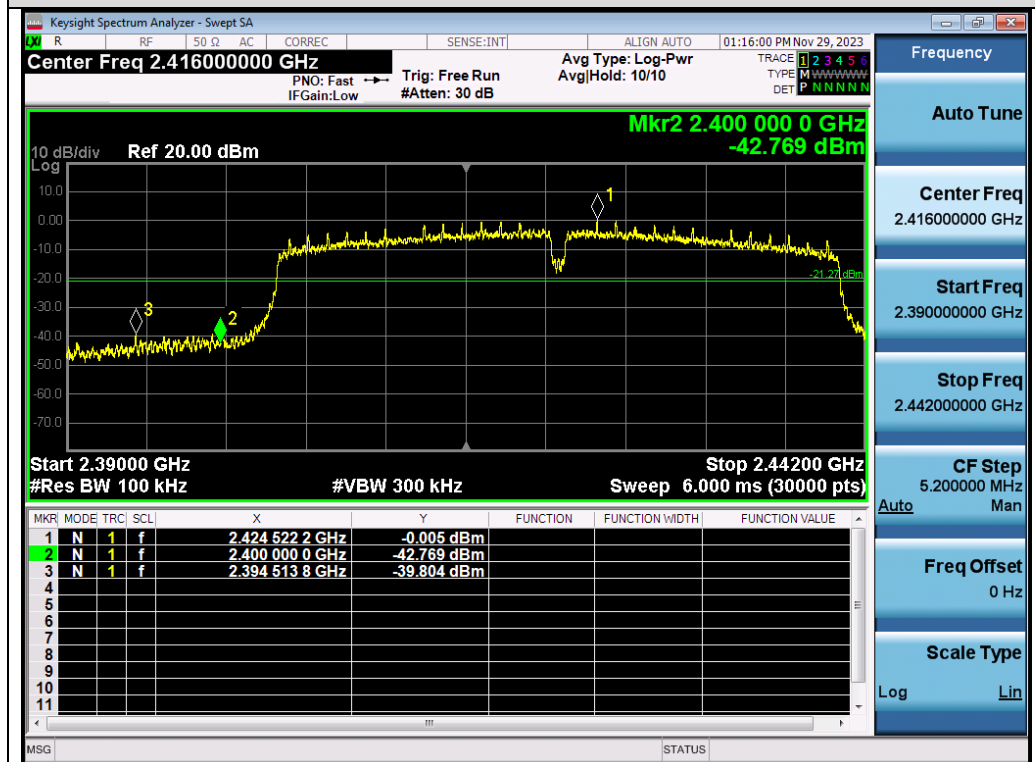

### 11.2 Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds.

pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum values.

8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.

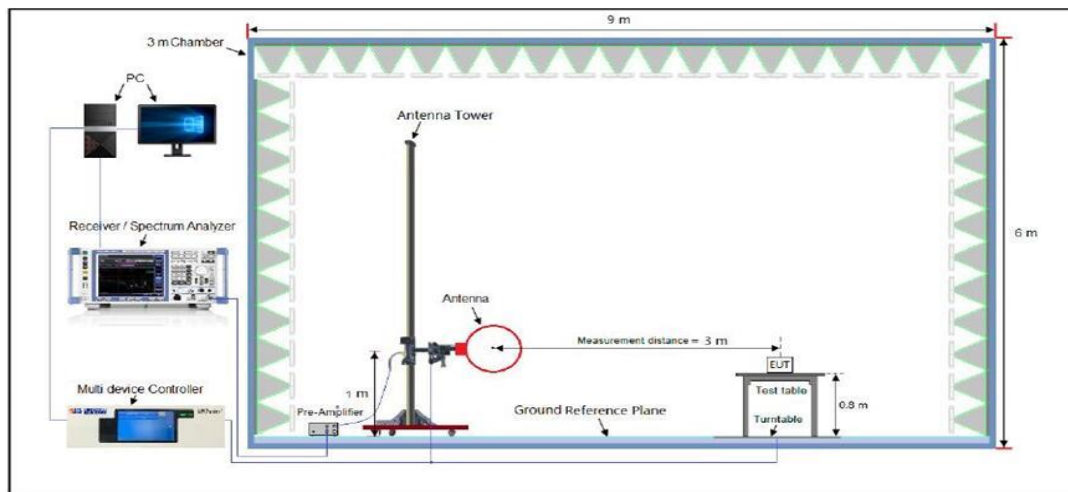

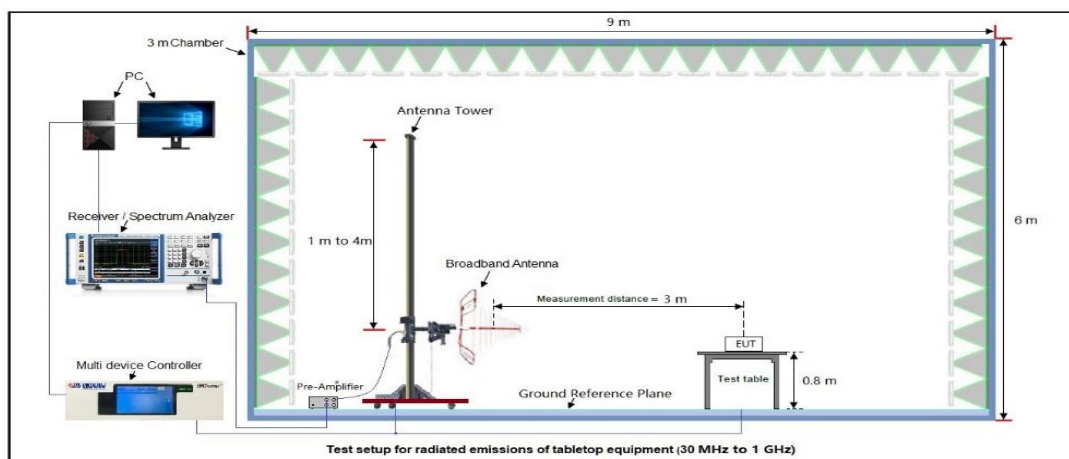

### 11.3 Measurement Setup (Block Diagram of Configuration)

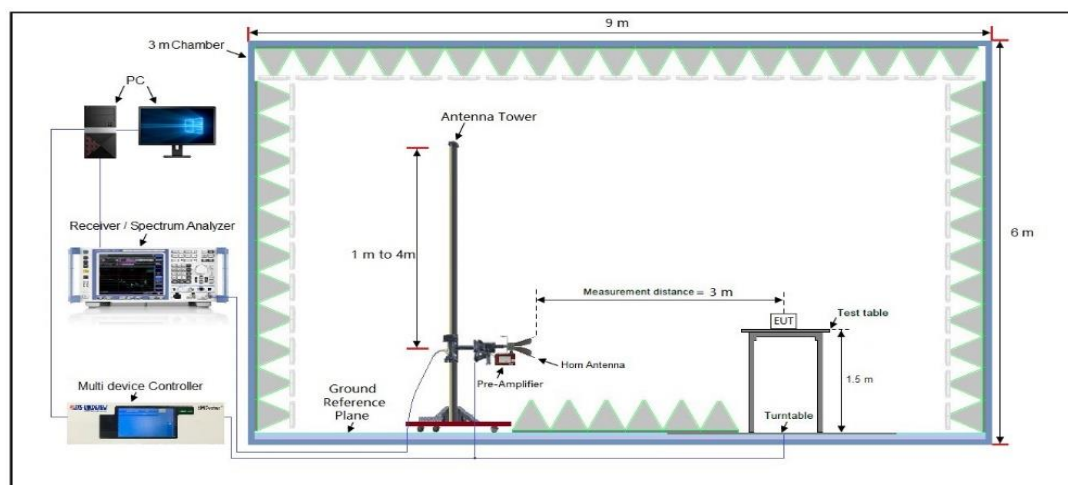
Radiated Emission Test Setup 9kHz-30MHz

Radiated Emission Test Setup Above 1000MHz



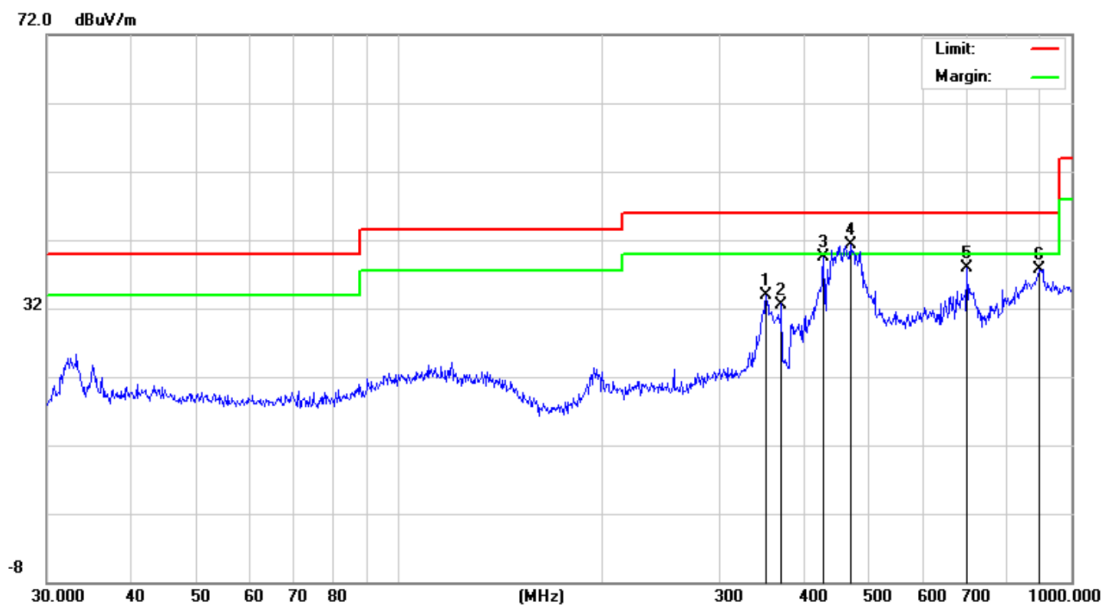

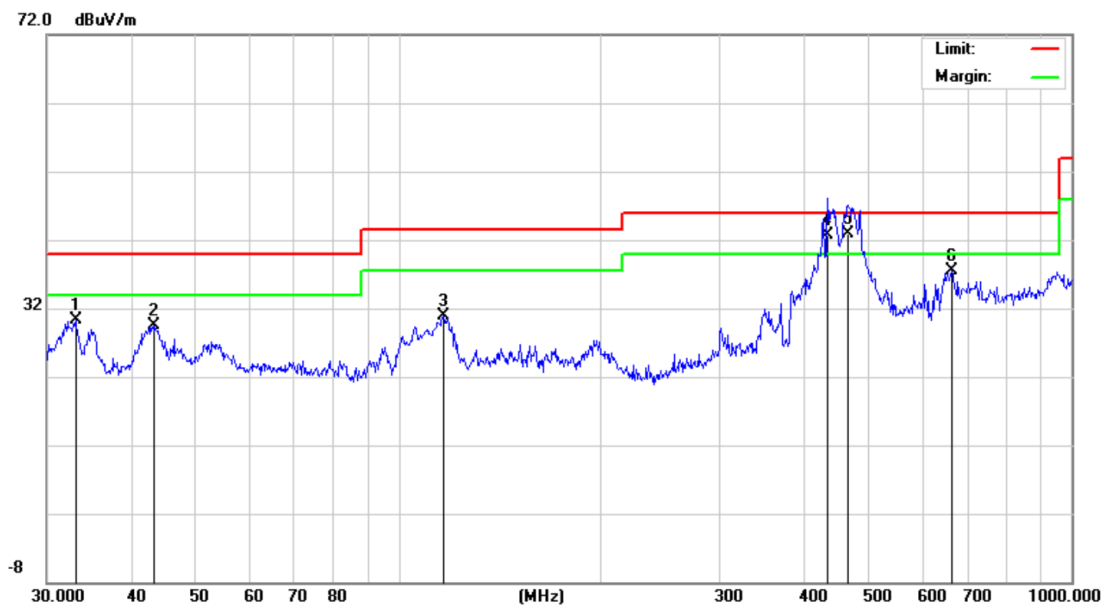
