### **Product Description for Equipment Under Test (EUT)**

The *MAYS CHINA LTD*'s product, model number: *3318 (FCC ID: 2ANUU3318)* (the "EUT") in this report was a *Mobile phone*, which was measured approximately: 10.4 cm (L) x 5 cm (W) x 1.4 cm (H), rated input voltage: DC3.7V from Battery or DC 5V from adapter. 



Note: 1. Support units were connected to second LISN.

2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

The setup of EUT is according with per ANSI C63.4-2014 measurement procedure. The specification used was with the FCC Part 15 B Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The adapter was connected to the Main LISN with 120V/60Hz AC power source.

### **EMI Test Receiver Setup**

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

#### **Test Procedure**

During the conducted emission test, the adapter of laptop was connected to the outlet of the first LISN and the other support equipments were connected to the outlet of the second LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

### **Corrected Amplitude & Margin Calculation**

The basic equation is as follows:

$$V_C = V_R + A_C + VDF$$

Herein,

V<sub>C</sub>: corrected voltage amplitude

V<sub>R</sub>: reading voltage amplitude

A<sub>c</sub>: attenuation caused by cable loss

VDF: voltage division factor of AMN or ISN

The "Margin" column of the following data tables indicates the degree of compliance within the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude



#### **Test Procedure**

During the radiated emissions, the adapter of laptop was connected to the first AC floor outlet and the other support equipments were connected to the second AC floor outlet.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

The data was recorded in the Quasi-peak detection mode for below 1 GHz, peak and average detection mode above 1 GHz.

### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain


