### 1. How to connect

Connect to a bluetooth device

1. The matching mode: press " ", "3-6 seconds long boot, prompt and blue lights flash, enter the bluetooth search pattern.

Open the bluetooth phone and search equipment, found in mobile search list has to

search the bluetooth speakers

Device name "FozentoFt10" click on the match.

Back to connect mode: press "", 3-6 seconds long boot, slow flashing blue lights, this state to back even mode.

If pairing is not successful, please restart your mobile device and your bluetooth speakers, according to the connected steps to reconnect.

If there is no set on mating 5 minutes automatic shutdown.

## 2. How to use

Music mode

Short press "play and pause the music.

Short press the "+" key to increase the volume, long press the "+" key for more than 2 seconds, switch to the next.

Short press "--" to reduce the volume, long press "--" key for more than 2 seconds, switch to the on a.

In the boot state, long press "" button for 4 seconds to turn it off.

Calling patterns

In the condition of connection, double click "" at the end of the keys to number redial.

Calls short press the "" answering the telephone, "" refuse to answer long by 2 seconds.



## 3. How to charge

Insert the charging wire speakers charge, speakers fully charged takes about 3 to 5 hours, if you want to use the charger (please make sure the good charger voltage value of 5 v2a, do not use higher than this voltage charging equipment, in order to avoid the speakers bring damage performance. After charging the red light bright, full of red light. Does not support power tips, using low power will automatically power off.
