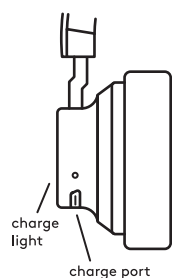

included

- Bluetooth Wireless Headphones
- Micro USB Charging Cable
- 3.5mm Audio Cable

pairing

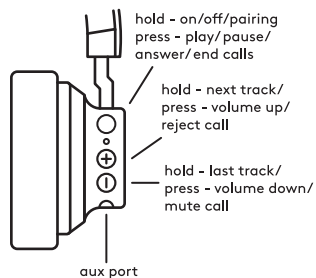
- When headphones are off, press and continuously hold the power button for 7 seconds until indicator flashes white and red
- Use the Bluetooth settings on your phone to pair with HEYDAY HEADPHONES 01
- Flashing white light only - pairing succesful

Note: Hold power button for 4 seconds to only power on and power off

indicators

- Flashing Red and White - Pairing mode
- Flashing White - Paired
- Flashing Red - Low power
- Solid Red - Charging
- Red Light Off - Charging complete

- Ascending Tones - Power on
- Descending Tones - Power off
- Three Rapid Tones - Ready to pair
- Single Chime - Paired
- Two Rapid Dings - Low battery
- Quick Ascending Tone - Max volume
- Quick Descending Tone - Min. volume



front

4 in

charging

- Full charge requires approximately 1.5-2.5 hours
- Charging is complete when red light turns off
- Plug micro end of charger into headphones
- Plug USB end of charging cable into a computer or 5V DC USB power supply

aux/line in

- Insert 3.5mm audio cable into headphone AUX port
- Insert opposite end of audio cable into the music source

troubleshooting

- If the headphones are not working correctly, turn them on/off to reset
- If the headphones won't turn on, recharge the battery and try again
- If the headphones won't charge, make sure the supply works, is 5V>1A, and not damaged
- If the headphones make no sound or do not show as an available device, make sure they are not paired to a different device already.
