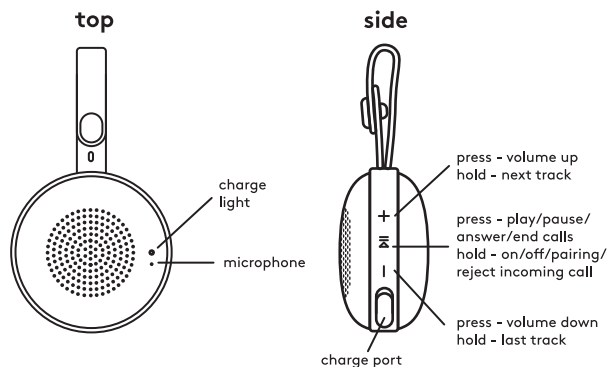

pairing

- Power ON speaker
- Rapid flashing white light
- Use Bluetooth settings on your phone to pair with HEYDAY SPEAKER 05
- White light turns solid followed by a chime - pairing successful

indicators

- * Flashing Red - Low Battery
 - Solid Red - Charging
 - No red Light - Fully Charged
 - Rapid Flashing White - Pairing Mode
 - Solid White - Bluetooth Connected

 - Descending Tones- Power off
 - Three Rapid Tones - Ready to pair

charging

- Full charge requires approximately 2-3 hours
- Charging is complete when red light turns off
- Plug micro end of charging cable into back of speaker DC 5V
- Plug USB end of charging cable into a DC 5V power supply

troubleshooting

- If the speaker is not working correctly, turn it on/off to reset
- If the speaker won't turn on, recharge the battery and try again
- If the speaker won't charge, make sure the power supply works, is 5V>1A, and not damaged
- If the speaker makes no sound or does not show as an available device, make sure it is not paired, if so unpair the device and repair the desired device
