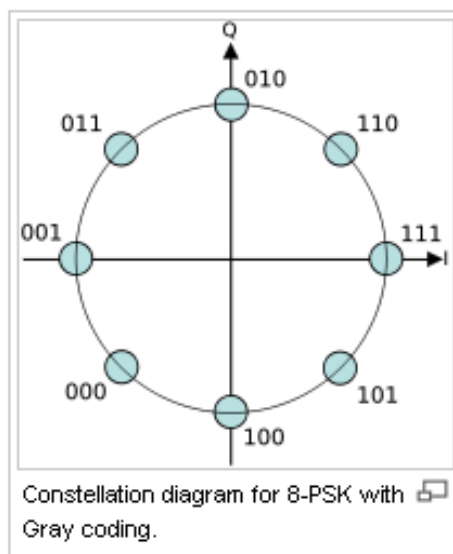

### 7.1 E.U.T. test conditions

**Test Voltage:** AC 120V

**Temperature:** 20.0 -25.0 °C

**Humidity:** 38-50 % RH

**Atmospheric Pressure:** 1000 -1010 mbar

**Requirements:** **15.31(e):** For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

## 7.2 Antenna Requirement

### Standard requirement

15.203 requirement:

For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

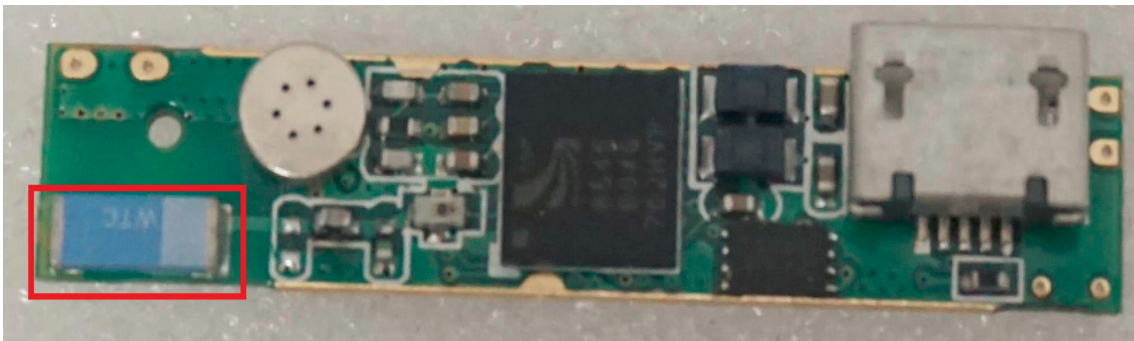
15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed.

Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

### EUT Antenna

The antenna is integrated Chip antenna and no consideration of replacement. The maximum gain of the antenna is 2 dBi.



**Test result: The unit does meet the FCC requirements.**

### 7.3 Occupied Bandwidth

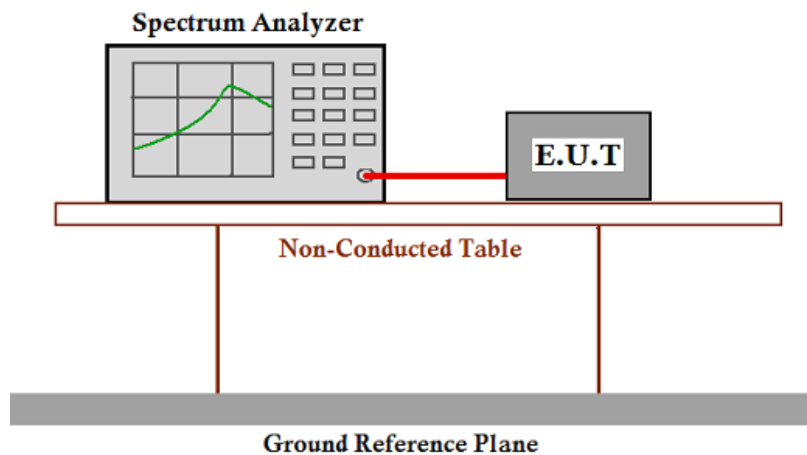
**Test Requirement:** FCC Part 15 C section 15.247

(a)(1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

**Test Method:** ANSI C63.10: Clause 6.9.2

**Test Status:** Pre-test the EUT in continuous transmitting mode at the lowest (2402 MHz), middle (2442 MHz) and highest (2480 MHz) channel with different data package. Compliance test in normal mode (DH5 data packet with GFSK modulation type) and EDR mode (3DH5 data packet with 8DPSK modulation type) as the worst case was found.

**Test Configuration:**



**Test Procedure:**

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer: Span = approximately 2 to 5 times the 20dB bandwidth, centring on a hopping channel;

Lowest Channels: **Carrier Frequencies Separated**

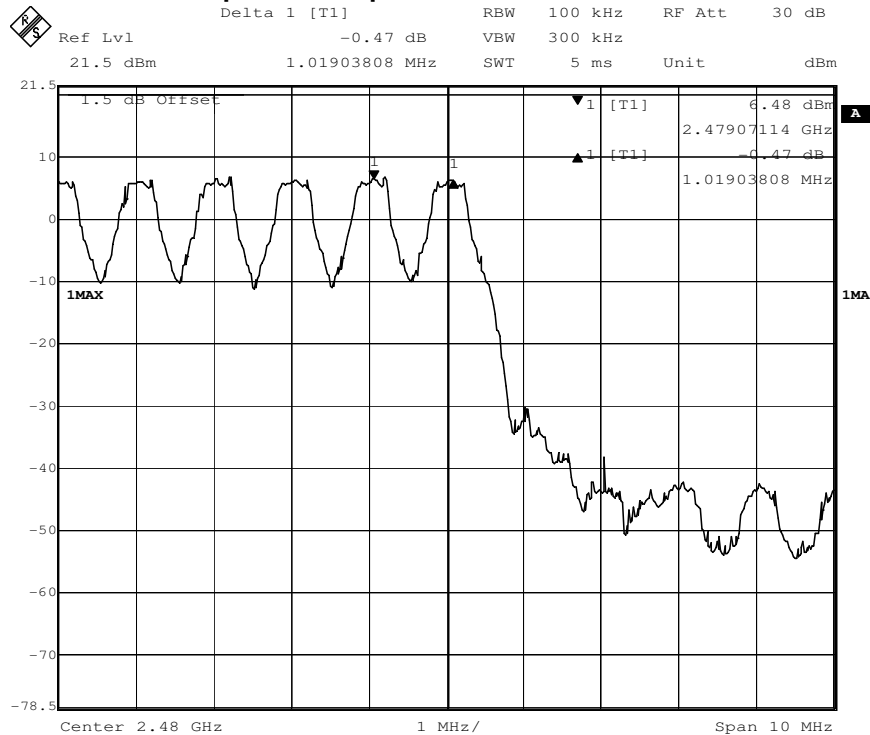


Middle Channels: **Carrier Frequencies Separated**

## **7.7 Pseudorandom Frequency Hopping Sequence**

### **7.7.1 Standard requirement**

15.247(a)(1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater.

Alternatively, Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

### **7.7.2 Other requirements Frequency Hopping Spread Spectrum System**

**Test Requirement:** 47 CFR Part 15C Section 15.247 (a)(1), (h) requirement:

The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

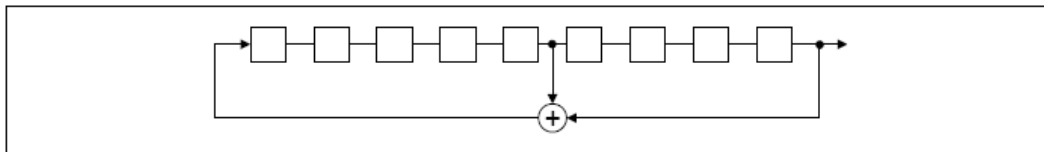
Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.

The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hopsets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

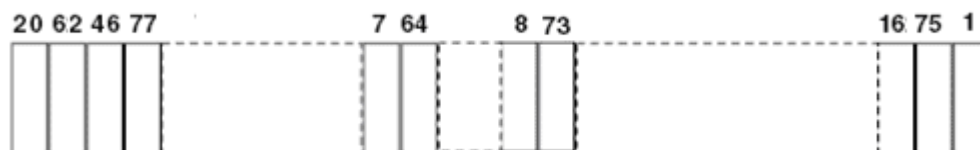
According to Bluetooth Core Specification, the pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONES; i.e. the shift register is initialized with nine ones.

According to Bluetooth Core Specification, Bluetooth receivers are designed to have input and IF bandwidths that match the hopping channel bandwidths of any Bluetooth transmitters and shift frequencies in synchronization with the transmitted signals.

#### **Compliance for section 15.247(g)**

According to Bluetooth Core Specification, the Bluetooth system transmits the packet with the pseudorandom hopping frequency with a continuous data and the short burst transmission from the Bluetooth system is also transmitted under the frequency hopping system with the pseudorandom hopping frequency system.

#### **Compliance for section 15.247(h)**

According to Bluetooth Core specification, the Bluetooth system incorporates with an adaptive system to detect other user within the spectrum band so that it individually and independently to avoid hopping on the occupied channels.

According to the Bluetooth Core specification, the Bluetooth system is designed not have the ability to coordinated with other FHSS System in an effort to avoid the simultaneous occupancy of individual hopping frequencies by multiple transmitter.

**Test Procedure:**

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.

2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a  $50\Omega/50\mu\text{H} + 5\Omega$  linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.

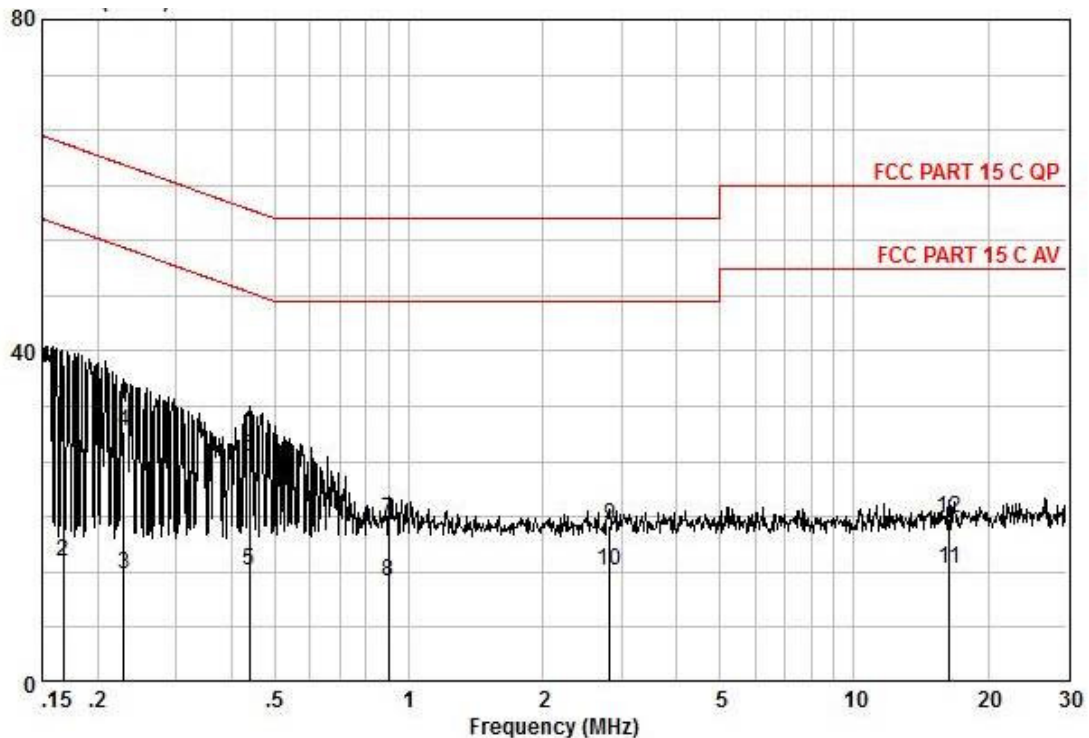
Quasi-Peak and Average measurement were performed at the frequencies with maximized peak emission were detected. For EUT the communicating was worst case mode.

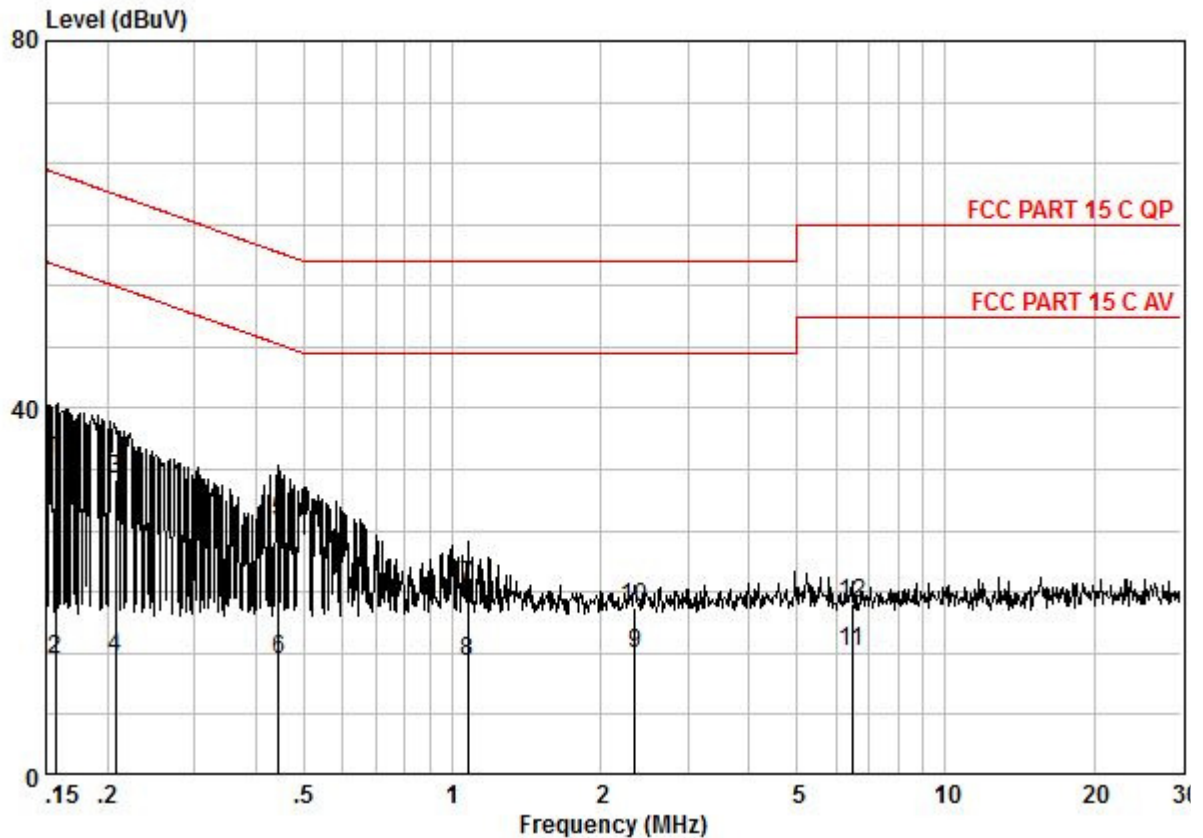
