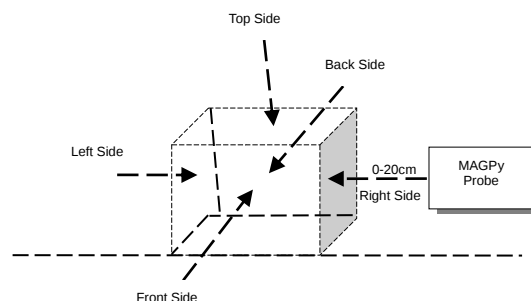

4.1.2. Test Procedures

- The RF exposure test was performed in anechoic chamber.
- Perform H-field measurements for each edge/top surface of the host/client pair at every 2 cm, starting from as close as possible out to 20 cm.
- The highest emission level was recorded and compared with limit.
- The EUT was measured according to the dictates of TCB Workshop "41-Part-18-&Wireless-Power-Transfer - April 27, 2022"

4.1.5. H-field Test Result

For portable exposure condition:

Operating modes with client device (10 %, 50%, 90% battery status of client device) have been test, only show the data of worst case of 1% battery status of client device.

H-field measurements taken every 2 cm (starting as close to 20 cm as possible) on each edge/top surface of the host/client pair were also evaluated for portable use conditions. The report reflects data for the worst 0 cm test distance mode only.

Test condition 1: Mode 1 operating mode with client device (10 % battery status of client device).

Curve-fitting Analysis

1. Locating the MFS

EUT will be a coil with the following parameters:

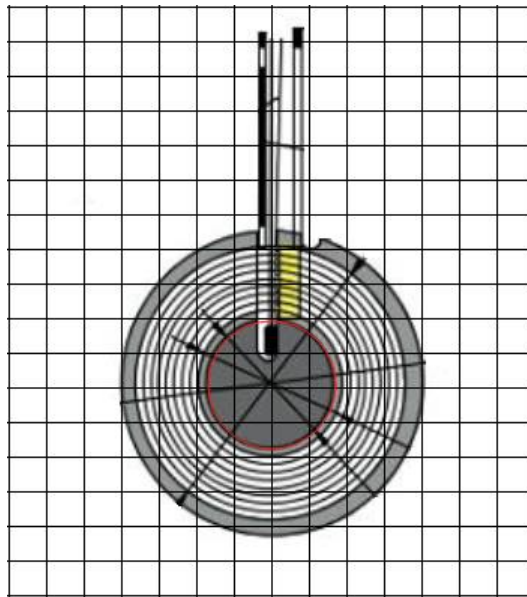
Outer radius: 19.5 mm

Inner radius: 9 mm

Number of turns: 10

Current: 1 Arms

Frequency: 111-205 kHz

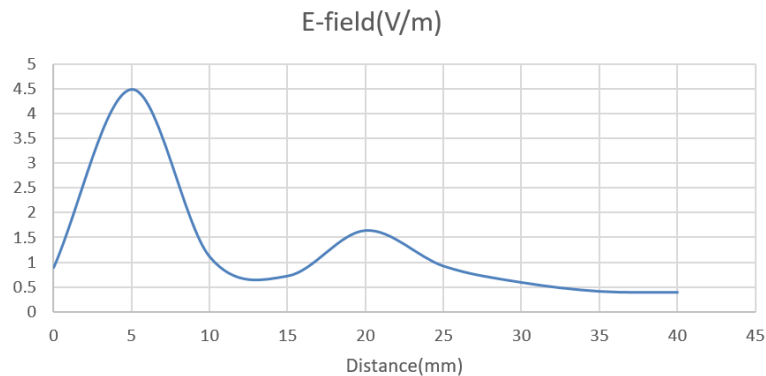


1. A grid of 5mm by 5mm is used due to the size of the EUT and the probe.

2. A probe MAGPy Version 2.6 Handheld System: MAGPy-8H3D+E3D is used to measure the E-field stemming from the EUT.

3. These initial measurements are made at Z = 55 mm from the surface of the XY plane.

4. A Red circle is shown to represent the location of the MFS which is 7 mm from the centre of the coil (4.49V/m).



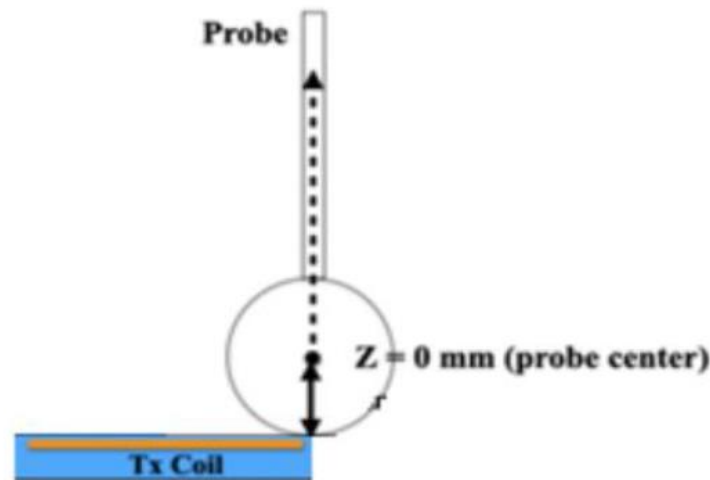
2. Methodology

Start gathering the data;

Measurements are made perpendicular to the XY plane;

Locate the MFS in the XY plane;

Note: The same test method is used for Modes 1-3, except that the power of the test load is changed. The data only reflects the worst mode EUT+Mobile Phone(battery status: <1%), so we use four (4) regression techniques to verify the model errors of the three modes: EUT + Mobile Phone (battery status: <1%) mode,standby mode, and direct exposure mode during device removal.

we use four (4) regression techniques to validate their model errors.

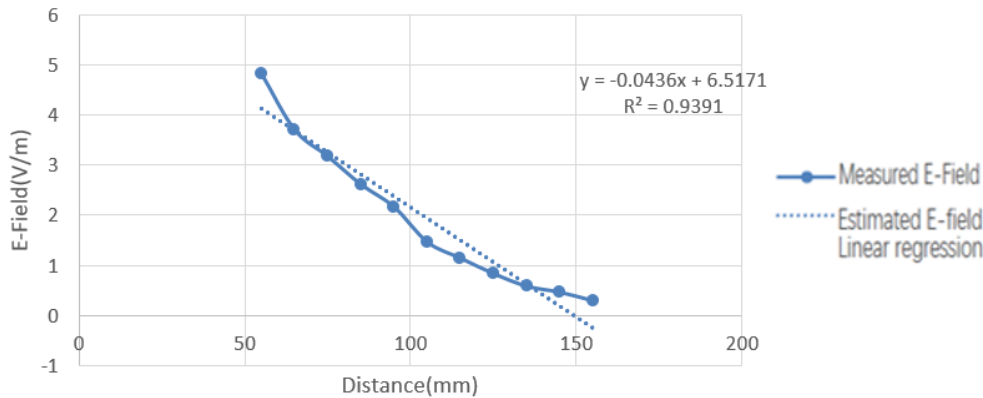

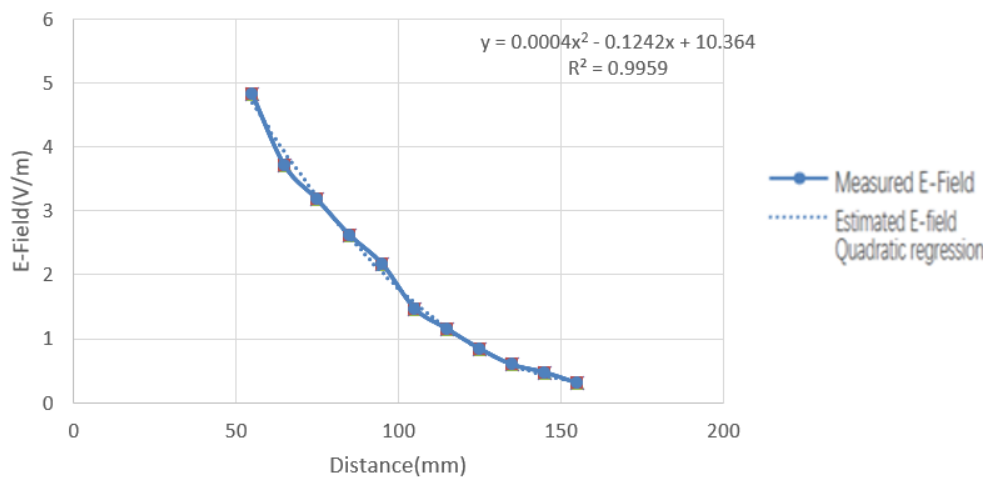

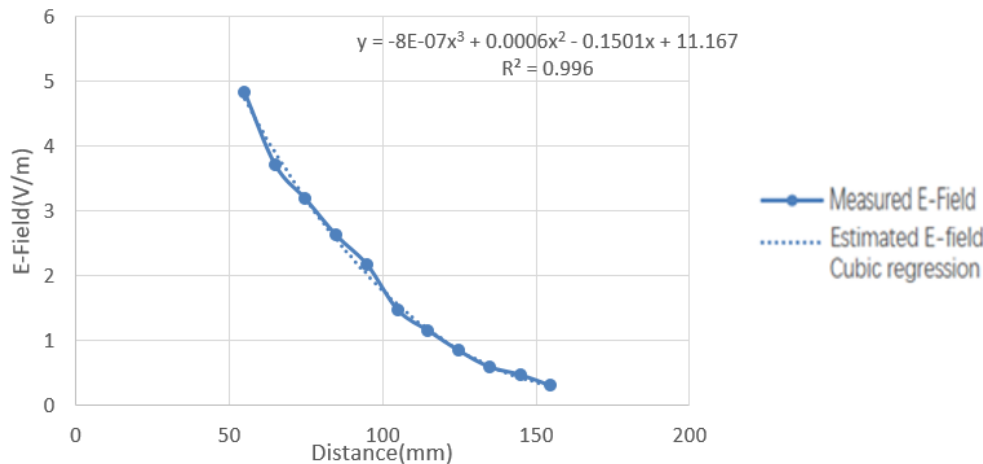
Model 2: Quadratic Regression

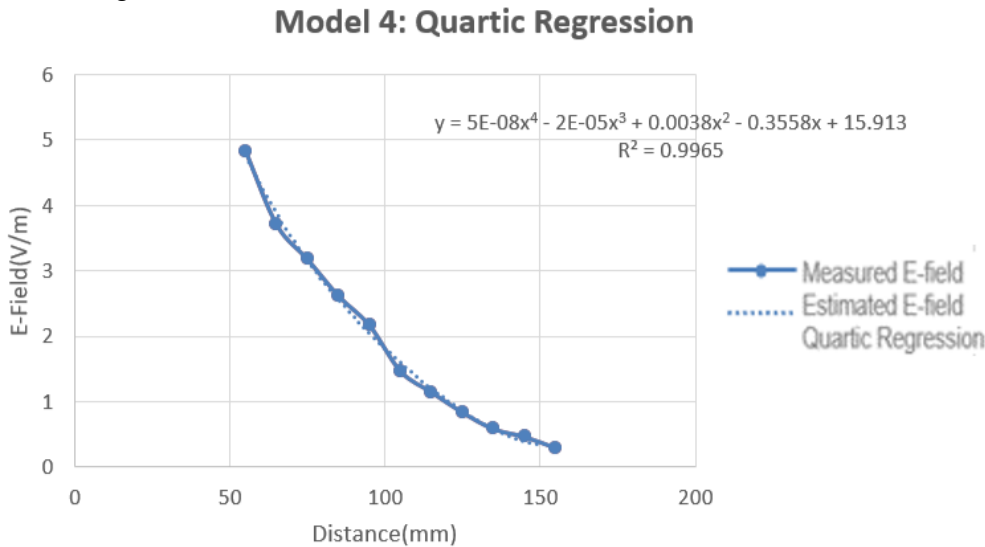


Model 3: Cubic Regression

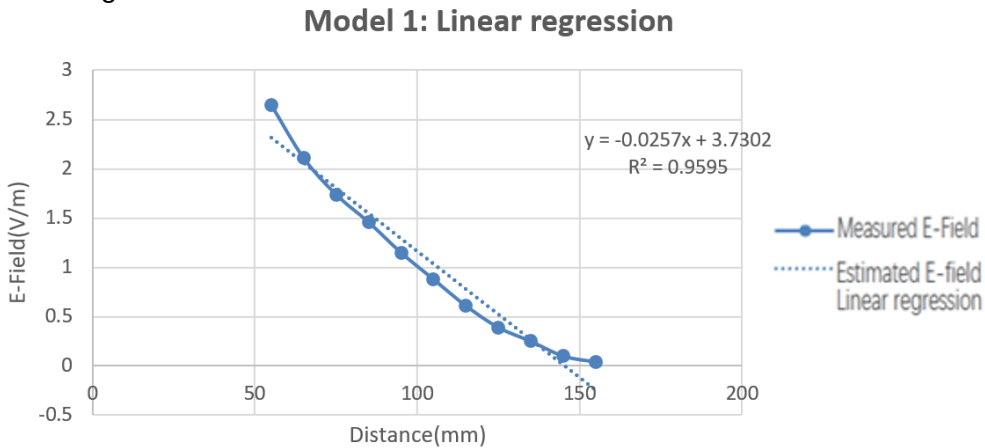


Model 4: Quartic Regression

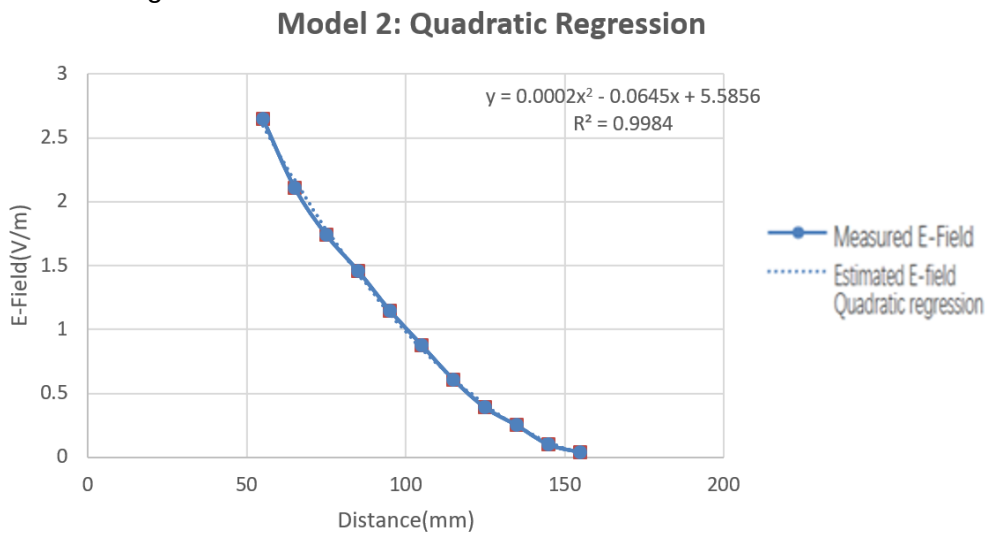

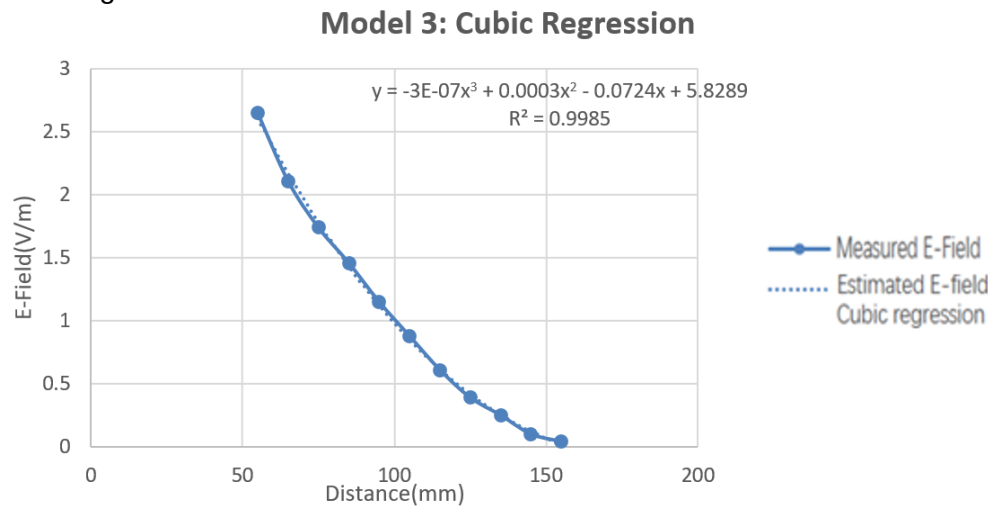

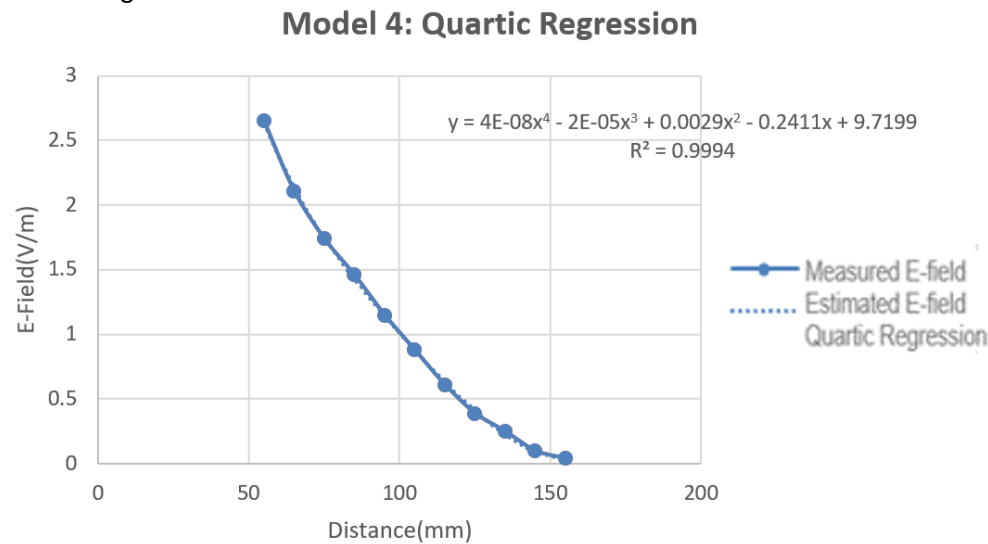
Model 2: Quadratic Regression

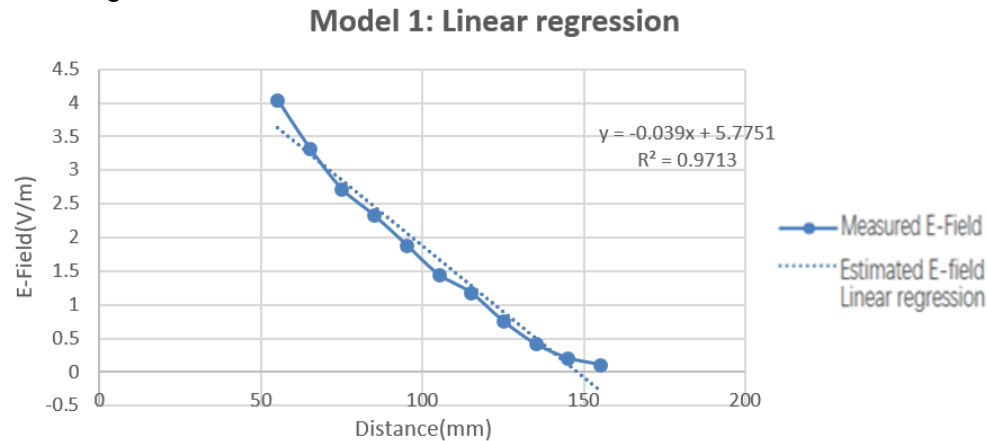

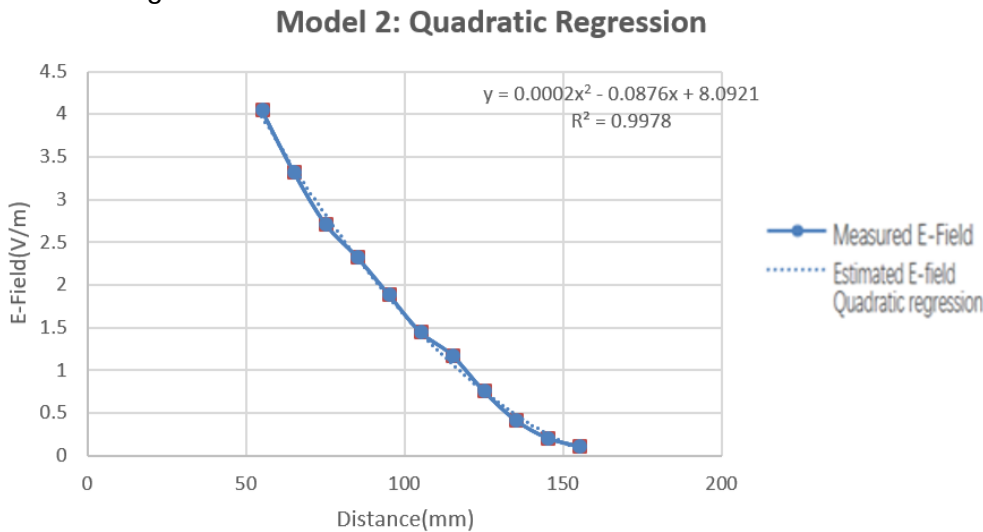

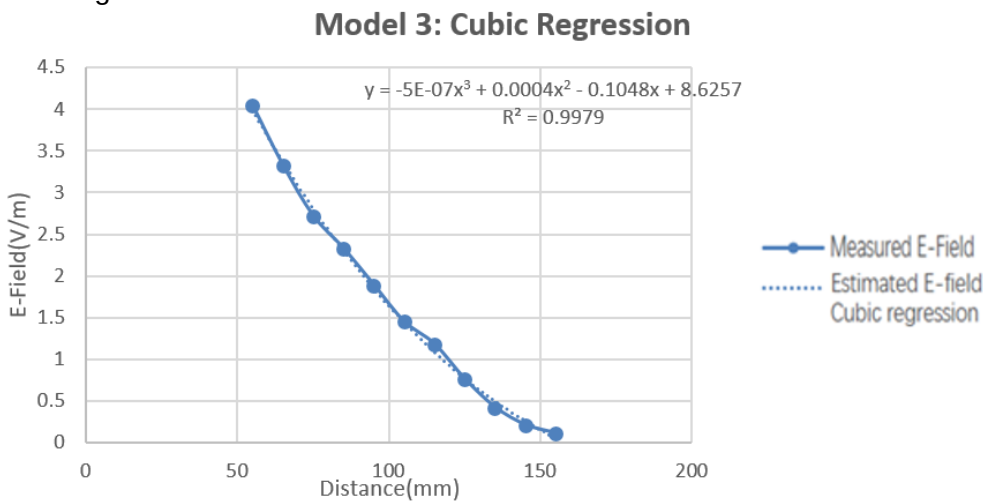

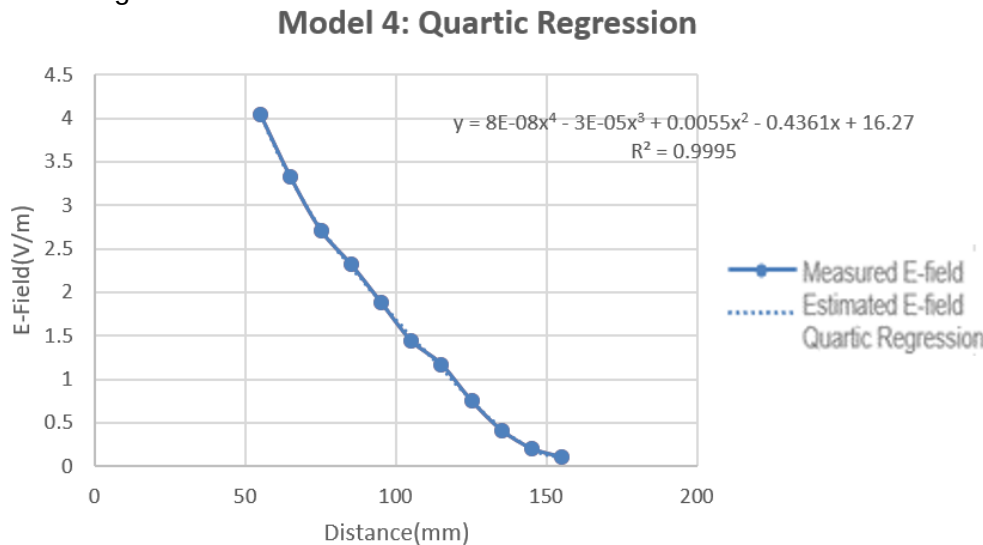

4.1.7. E-field Test Result

As shown in Section 4.1.6, the standard error of the fourth model is the smallest among all the models, which is lower than the minimum standard error threshold of 15% specified . The confidence level used in the regression analysis is 95%, which is the minimum value that the applicant should use. By using curve fitting technology for modeling and calculation, it can be inferred that the electric field at a distance of 0 mm is 15.913 V/m, which is less than the limit of 614 V/m. The judgment result is passed.
