

2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Centre Frequency = Operation Frequency, RBW= 100 kHz, VBW \geq 3 \times RBW.
4. Set SPA Trace 1 Max hold, then View.




TEST PLOT OF BANDWIDTH FOR LOW CHANNEL





TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL





TEST PLOT OF BANDWIDTH FOR LOW CHANNEL






