



For peak power test:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. $RBW \geq DTS$ bandwidth.
3. $VBW \geq 3 * RBW$.
4. $SPAN \geq VBW$.
5. Sweep: Auto.
6. Detector function: Peak.
7. Trace: Max hold.

Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.

Test_Graph_LE1M_ANT1_2440_1Mbps_Peak Power




Test_Graph_LE1M_ANT1_2480_1Mbps_Peak Power

8. BANDWIDTH

8.1. MEASUREMENT PROCEDURE

6dB bandwidth:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Centre Frequency = Operation Frequency, RBW= 100 kHz, VBW \geq 3 \times RBW.
4. Set SPA Trace 1 Max hold, then View.

Occupied bandwidth:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set Span = approximately 2 to 5 times the 20 dB bandwidth, centered on a hopping channel
The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW and video bandwidth (VBW) shall be approximately three times RBW; Sweep = auto; Detector function = peak
4. Set SPA Trace 1 Max hold, then View.

Note: The EUT was tested according to ANSI C63.10 for compliance to FCC PART 15.247 requirements.





Test_Graph_LE1M_ANT1_2402_1Mbps_OBW




Test_Graph_LE1M_ANT1_2440_1Mbps_OBW






Test Graphs of DTS Bandwidth (GFSK 1Mbps)



Test Graphs of Occupied Bandwidth (GFSK 2Mbps)









Test Graphs of DTS Bandwidth (GFSK 2Mbps)









Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions



Test_Graph_LE2M_ANT1_2402_2Mbps_Higher Band Emissions










Test Graphs of Conducted Output Power Spectral Density (GFSK 2Mbps)




