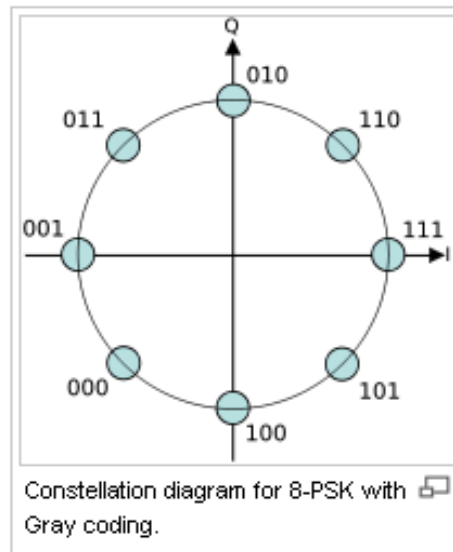

7.2 Antenna Requirement

15.203 requirement:

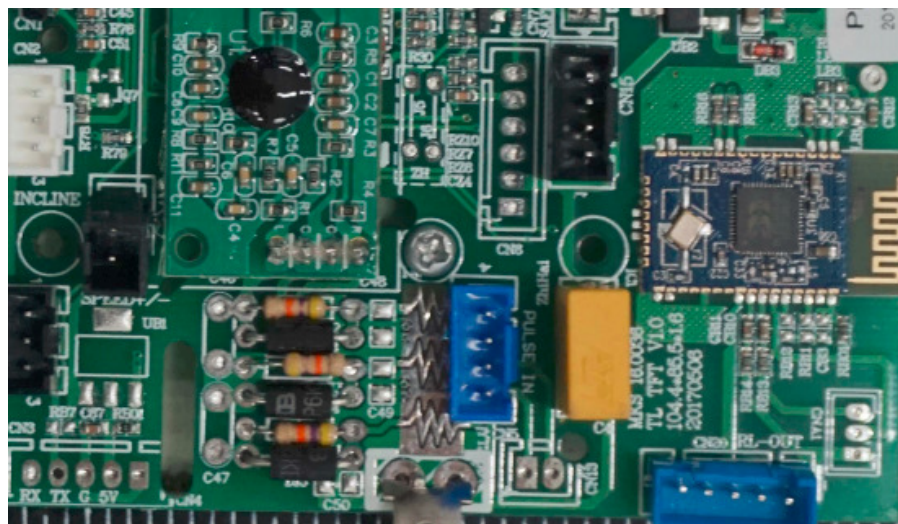
For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

The antenna is integrated PCB antenna and no consideration of replacement. The maximum gain of the antenna is 0 dBi.



Test result: The unit does meet the FCC requirements.

7.3 Occupied Bandwidth

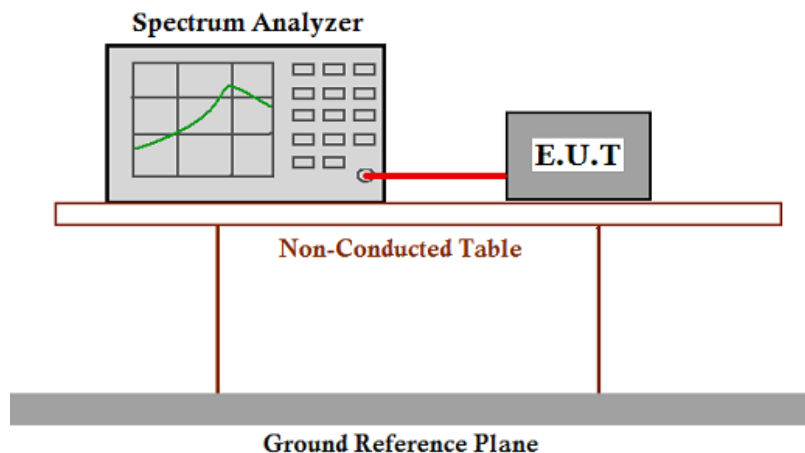
Test Requirement: FCC Part 15 C section 15.247

(a)(1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

Test Method: ANSI C63.10: Clause 6.9.2

Test Status: Pre-test the EUT in continuous transmitting mode at the lowest (2402 MHz), middle (2442 MHz) and highest (2480 MHz) channel with different data package. Compliance test in normal mode (DH5 data packet with GFSK modulation type) and EDR mode (3DH5 data packet with 8DPSK modulation type) as the worst case was found.

Test Configuration:



Test Procedure:

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer: Span = approximately 2 to 5 times the 20dB bandwidth, centring on a hopping channel;
3. Set the spectrum analyzer: RBW:1% ~5% of the 20dB bandwidth ,VBW >=3 RBW. Sweep = auto; Detector Function = Peak. Trace = Max Hold.
4. Mark the peak frequency and -20 dB points bandwidth.

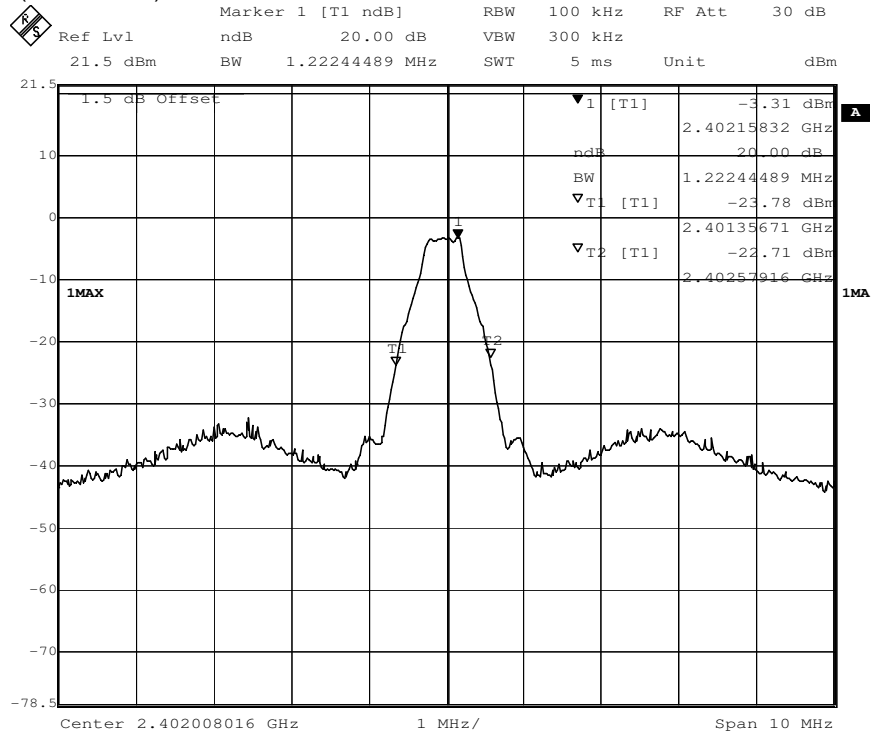

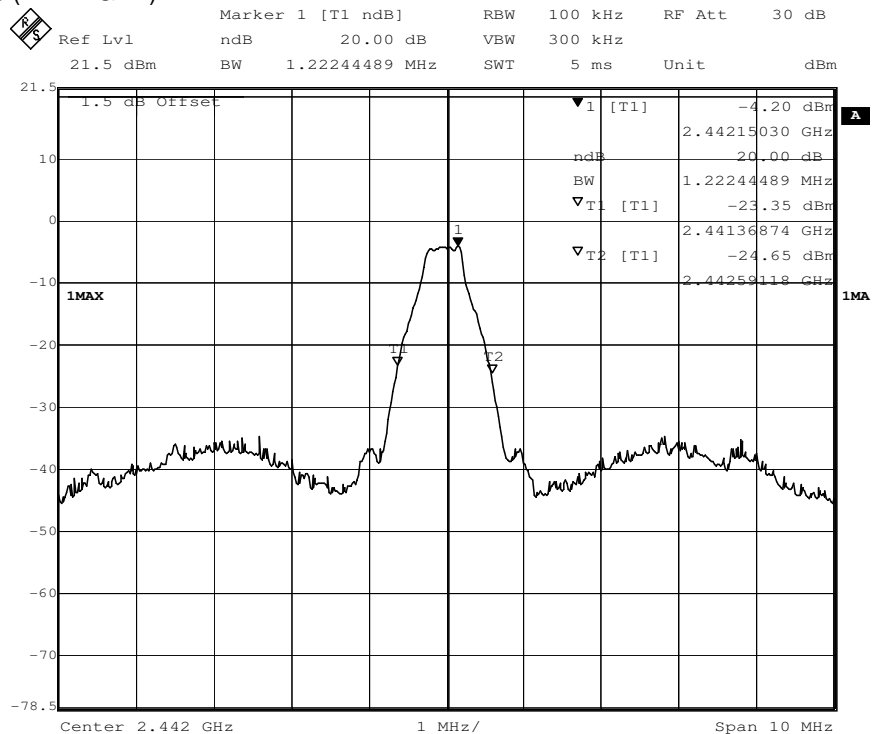

Middle Channel(2.442 GHz):



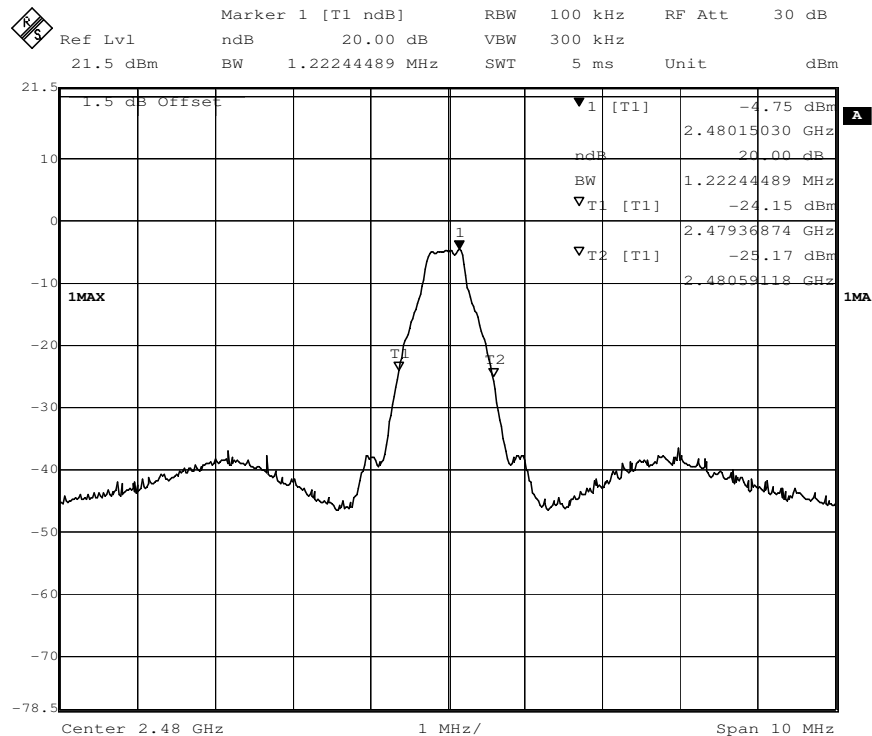

Lowest Channels: **Carrier Frequencies Separated**

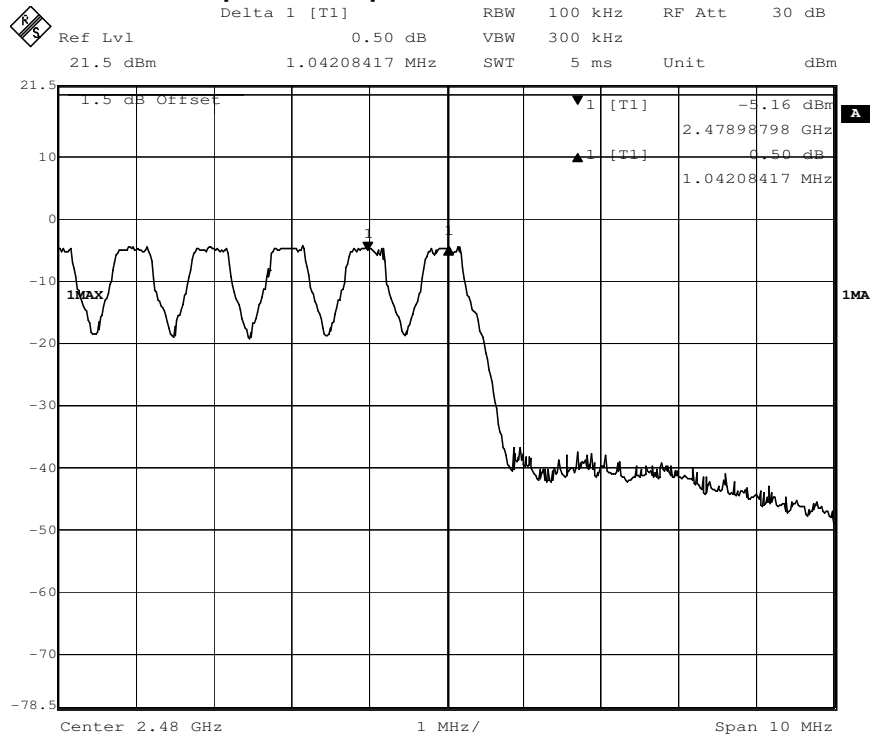


Middle Channels: **Carrier Frequencies Separated**

7.7 Pseudorandom Frequency Hopping Sequence

7.7.1 Standard requirement

15.247(a)(1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater.

The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

7.7.2 Other requirements Frequency Hopping Spread Spectrum System

Test Requirement: 47 CFR Part 15C Section 15.247 (a)(1), (h) requirement:

The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

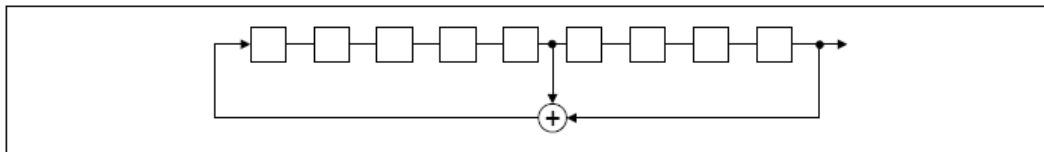
Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.

The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hopsets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

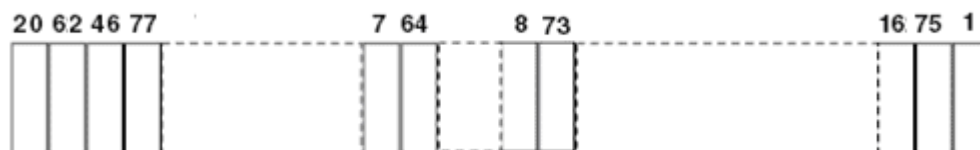

According to Bluetooth Core Specification, the Bluetooth system transmits the packet with the pseudorandom hopping frequency with a continuous data and the short burst transmission from the Bluetooth system is also transmitted under the frequency hopping system with the pseudorandom hopping frequency system.

According to Bluetooth Core specification, the Bluetooth system incorporates with an adaptive system to detect other user within the spectrum band so that it individually and independently to avoid hopping on the occupied channels.

According to the Bluetooth Core specification, the Bluetooth system is designed not have the ability to coordinated with other FHSS System in an effort to avoid the simultaneous occupancy of individual hopping frequencies by multiple transmitter.

Test Procedure:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.
