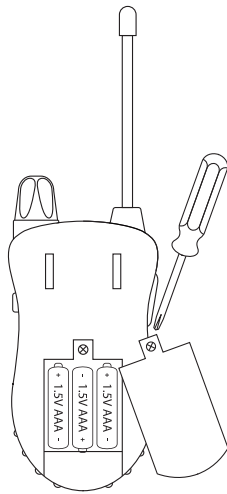
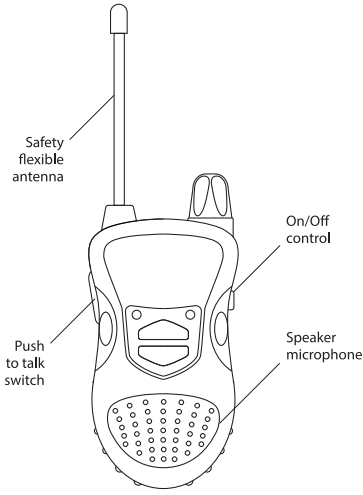

HOW TO OPERATE YOUR TRANSCEIVER

1. Remove screw and open battery door and snap in a 3 x AAA batteries. (Alkaline batteries recommended)
2. Press the "Push to talk" switch for transmitting.
3. Release "Push to talk" switch for receiving.
4. When transmitting, speak clearly in a normal voice, holding the set about 3" from your mouth.
5. Best transmission and reception are obtained when the antenna is held in a vertical position, and fully extended.

CAUTION

1. Your transceiver set has been fully adjusted prior to shipment from the factory and be sure not to touch the internal components other than battery.
2. When the sound becomes weak, it is time to change the battery.
3. After use, always return the ON-OFF switch to the OFF position.
4. Keep your set in dry and clean place.
