

| 3. The modular transmitter must have its own power supply regulation. | Yes, it has a power supply regulation for transmitter inside the chip. |
| 4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c). The antenna must either be permanently attached or employ a “unique” antenna coupler (at all connections between the module and the antenna, including the cable).. | It has a PCB antenna on the module board permanently. |

This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed. | Yes, it has been tested in a stand-alone configuration, not inside another device. |

The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. This exterior label can use wording such as the following: “Contains Transmitter Module FCC ID: XYZMODEL1” or “Contains FCC ID: XYZMODEL1.” Any similar wording that expresses the same meaning may be used. The Grantee may either provide such a label, an example of which must be included in the application for equipment authorization, or, must provide adequate instructions along with the module which explain this requirement. In the latter case, a copy of these instructions must be included in the application for equipment authorization. | Yes, our module has a label on the shielding with its own FCC ID number. And the device will also has a label with wording” FCC ID: XYZMODEL1” which assembled our module inside. |

A copy of these instructions must be included in the application for equipment authorization. For example, there are very strict operational and timing requirements that must be met before a transmitter is authorized for operation under Section 15.231. For instance, data transmission is prohibited, except for operation under Section 15.231(e), in which case there are separate field strength level and timing requirements. Compliance with these requirements must be assured.</p> | <p>Yes, our module has detailed spec and operating requirements comply with Section 15.231 and Section 15.231(e) for application and production.</p> |
