Test Graphs of Spurious Emissions outside of the 5.25-5.35 GHz band

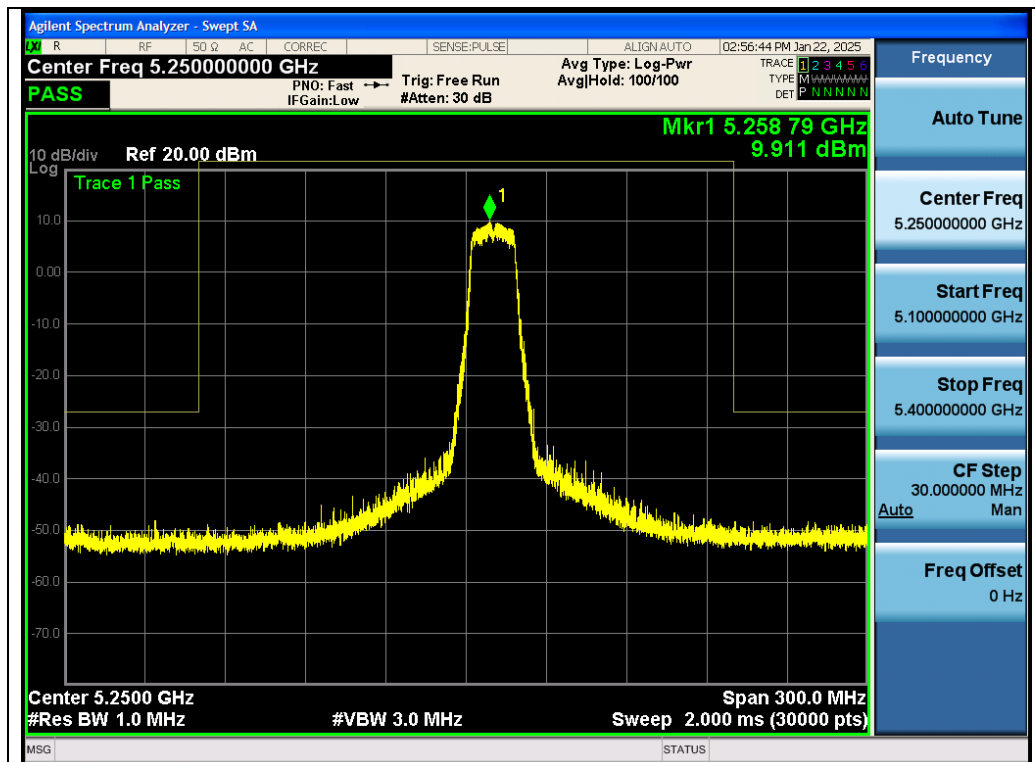

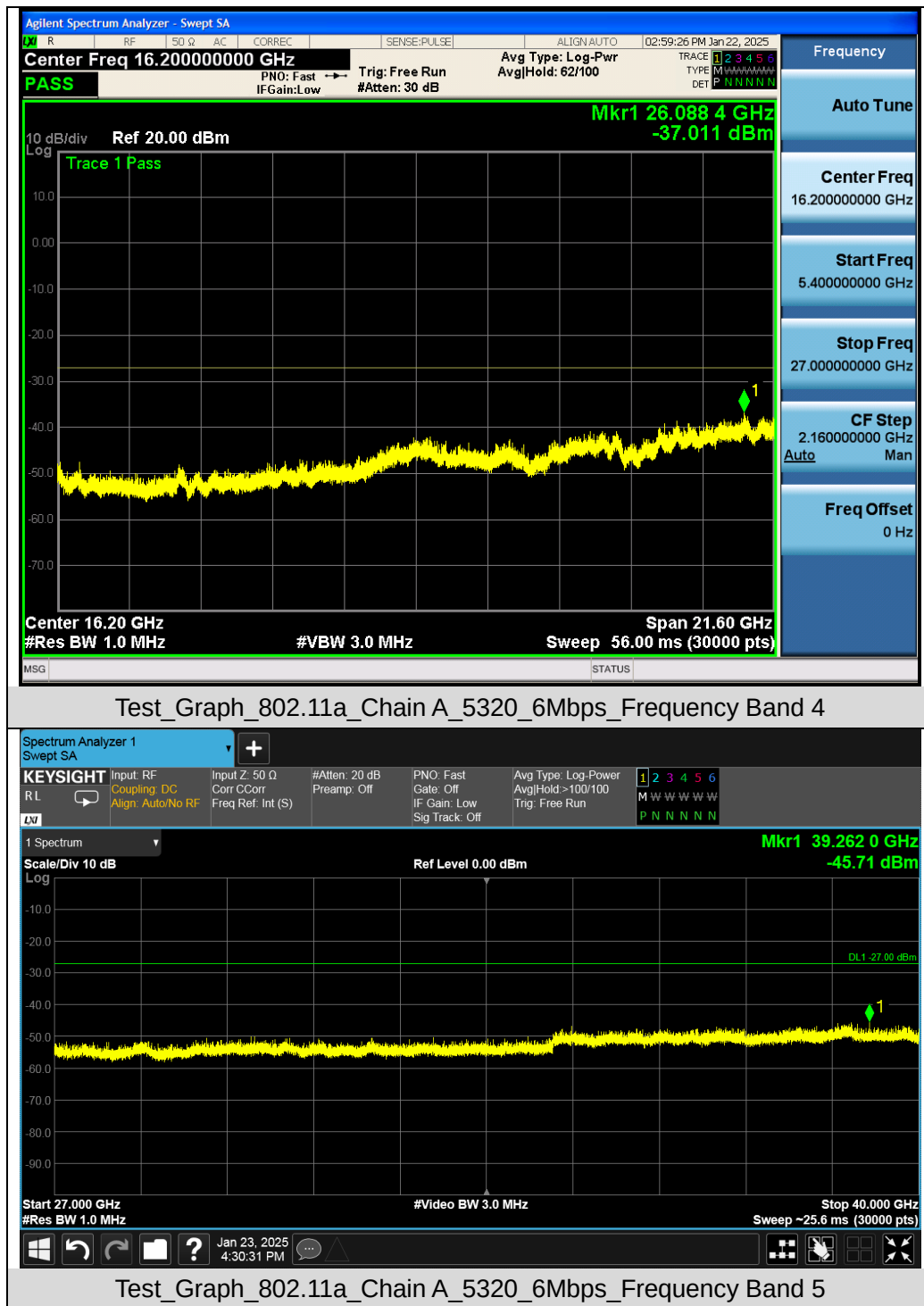


Test_Graph_802.11a_Chain A_5320_6Mbps_Frequency Band 2



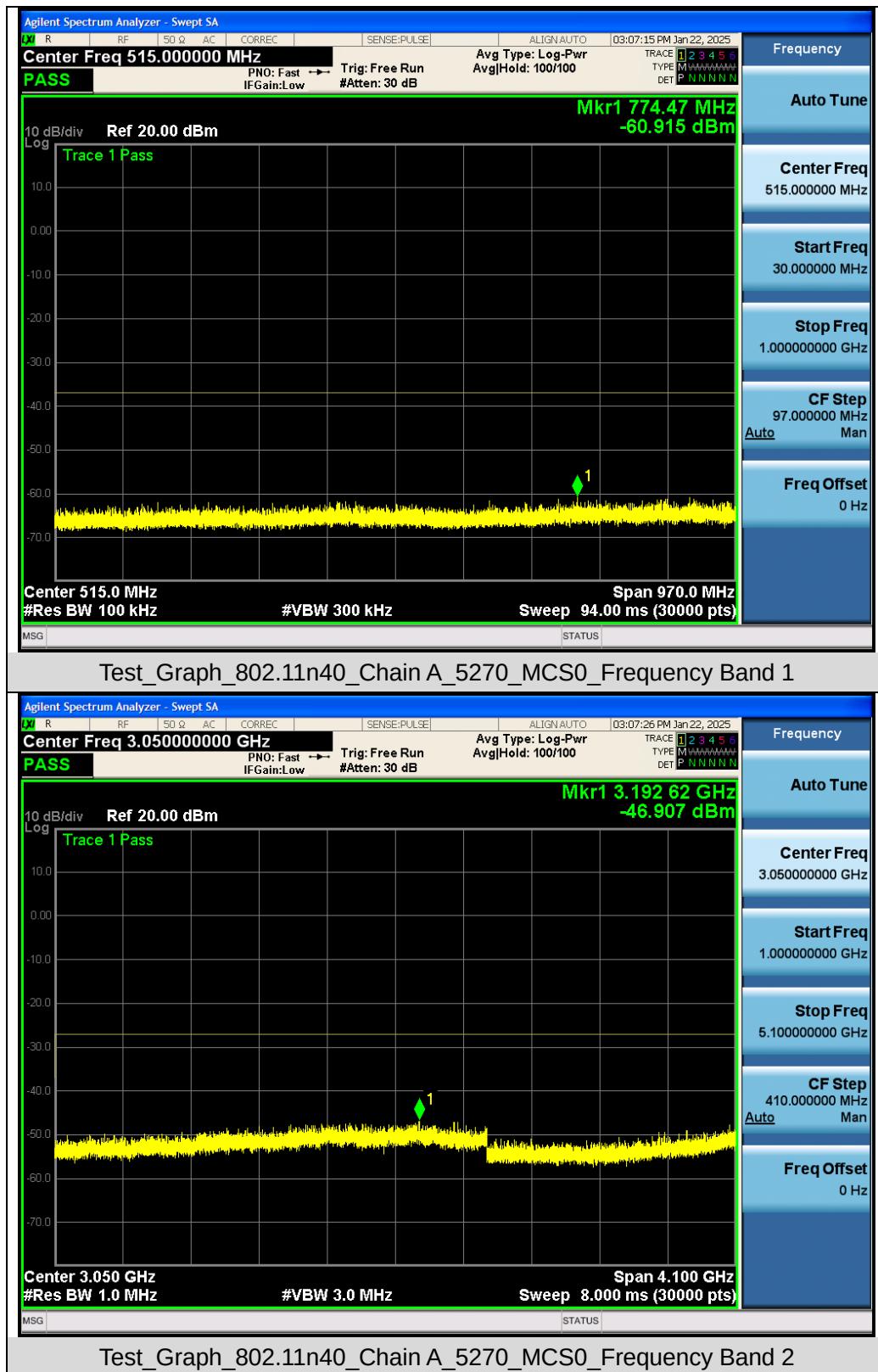
