

## Connecting the device to your smartphone

1. Login at <http://www.radacat.com/>, or scan the QR Code below to download the free Radacat App on your smartphone (available on Android, IOS)

2. Turn on the Bluetooth function on your smartphone, then press the "On" button on the Radacat device. Open the Radacat App with your smartphone and press "Click here to scan device", using the scan function, align camera from your smartphone directly above the Radacat device to initiate Bluetooth pairing.

3. Once the Bluetooth connection is established, you will be able to communicate with other users with text or voice messaging, you will also be able to share your whereabouts by using the "location sharing" function.



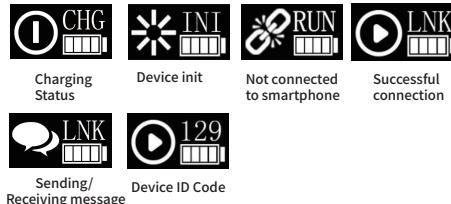

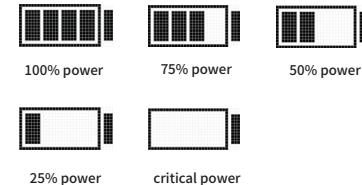
