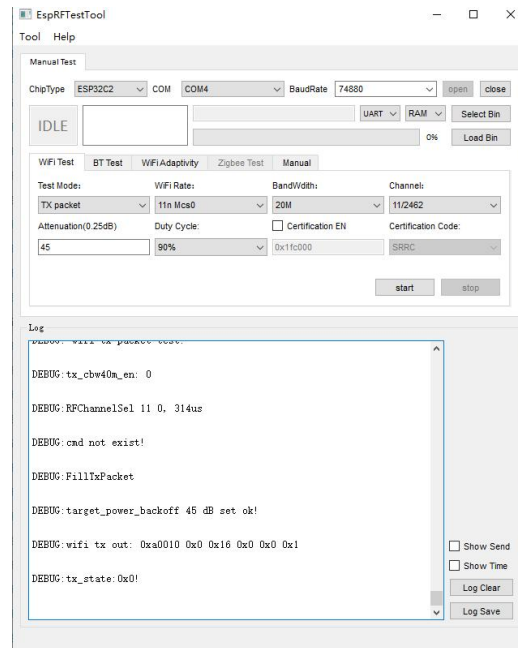

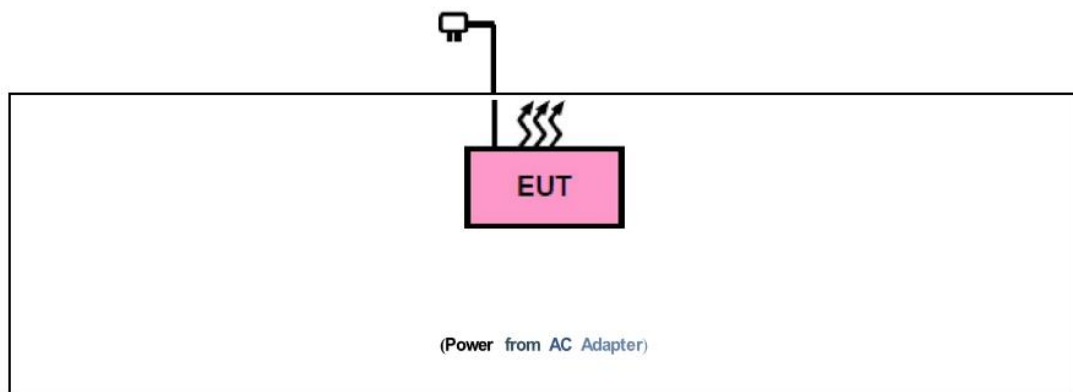

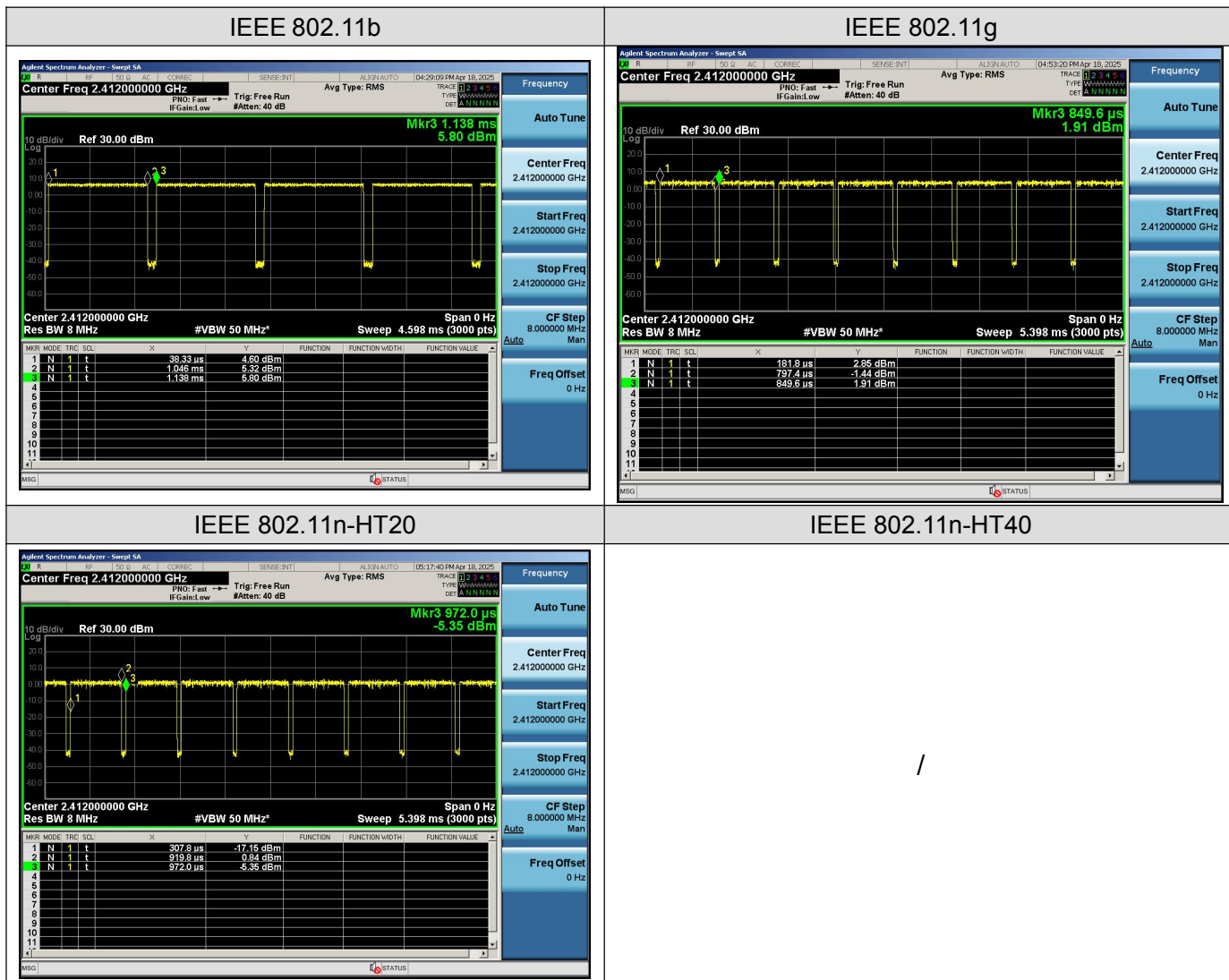

For DTSs employing digital modulation techniques operating in the bands 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1 W.

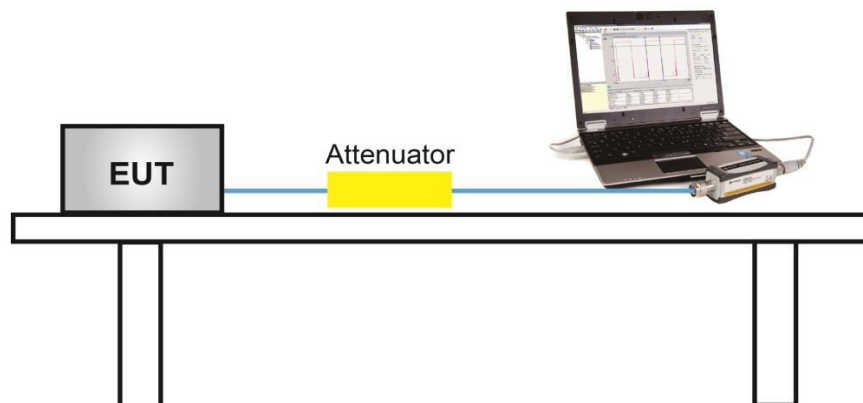

1. The testing follows the ANSI C63.10 Section 11.9.2.3
2. Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the following conditions are satisfied:
3. The EUT is configured to transmit continuously, or to transmit with a constant duty cycle.
4. At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
5. The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.

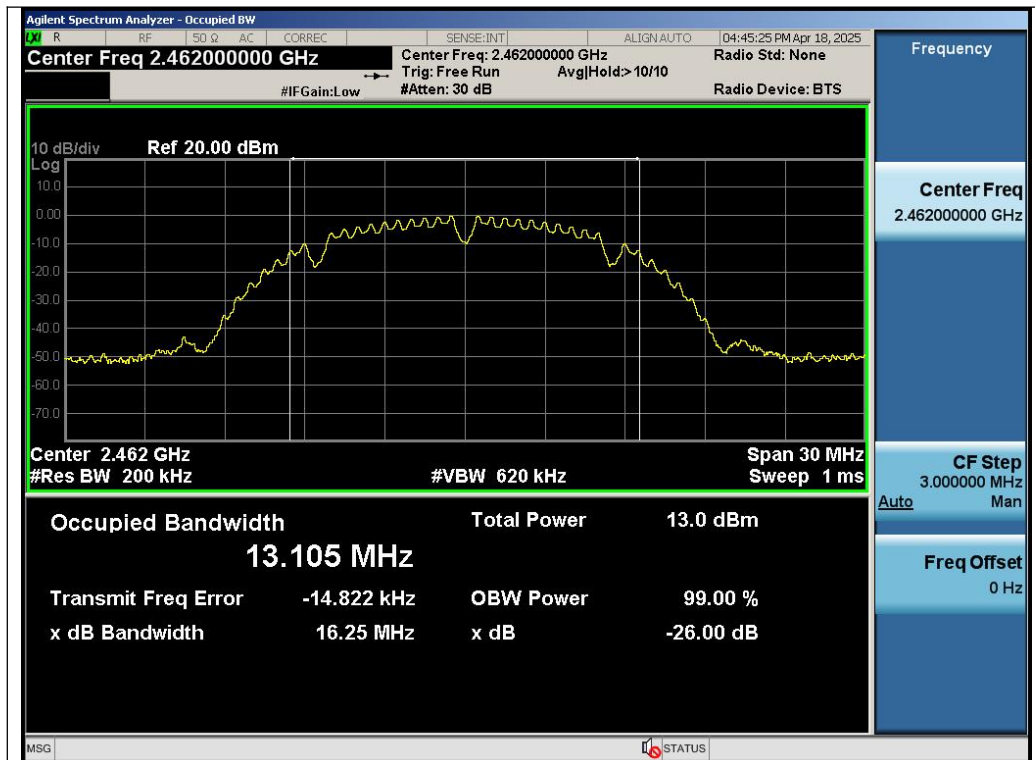

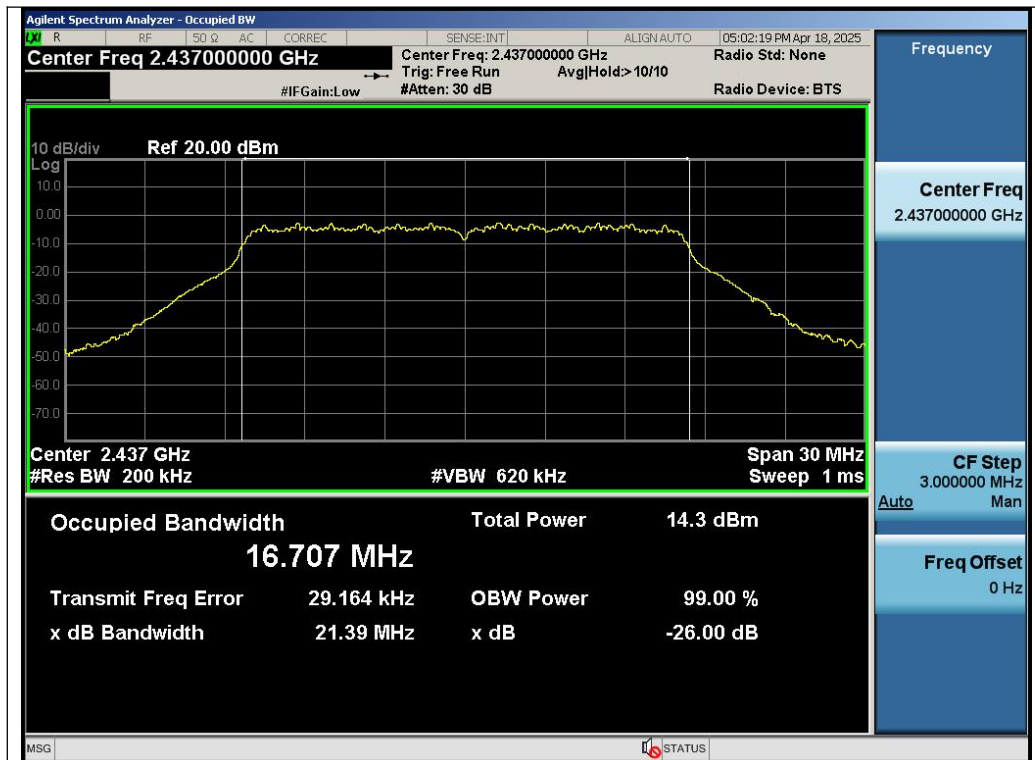


Test\_Graph\_802.11b\_ANT1\_2462\_1Mbps\_OBW

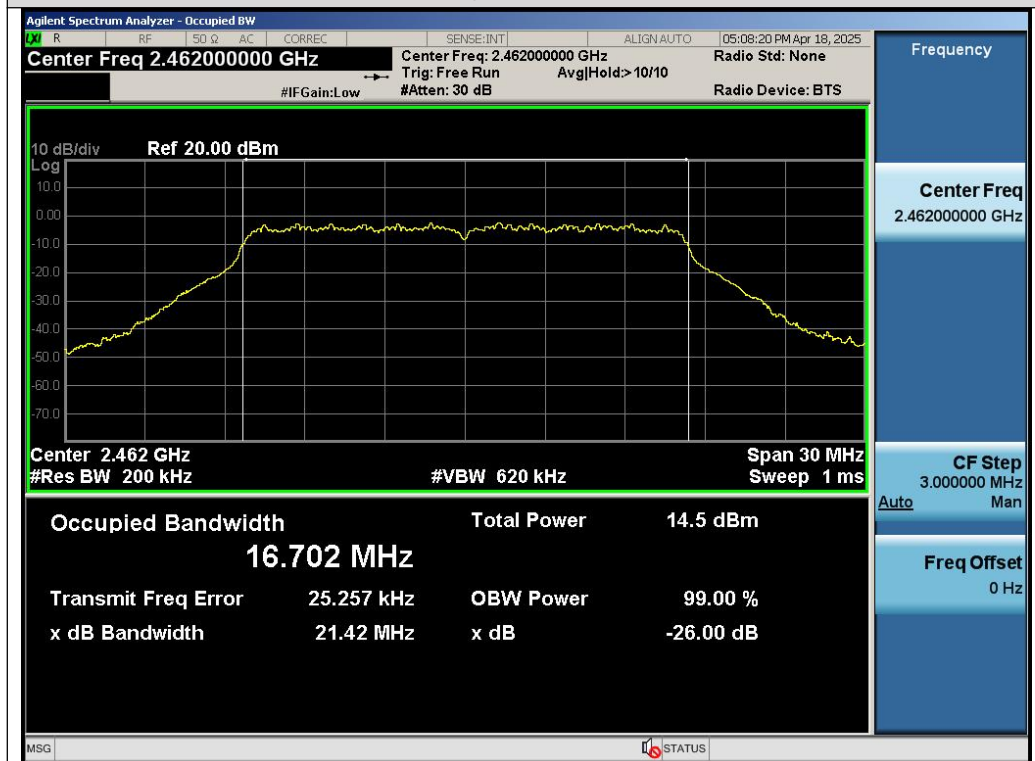

### Test Graphs of DTS Bandwidth

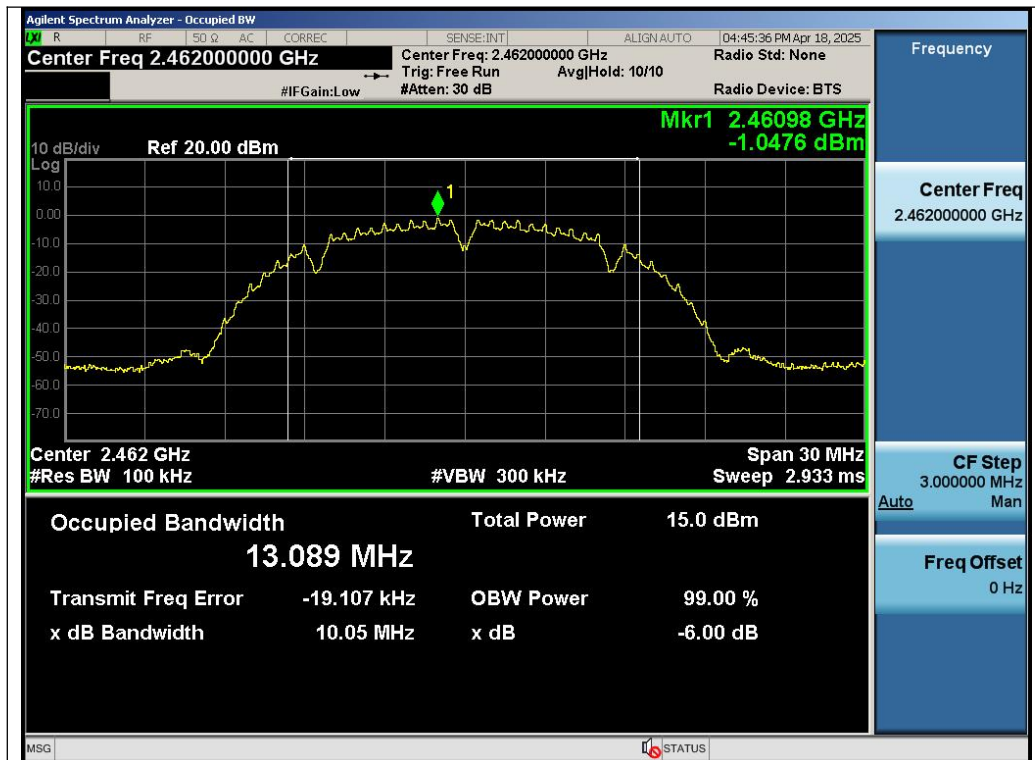

The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

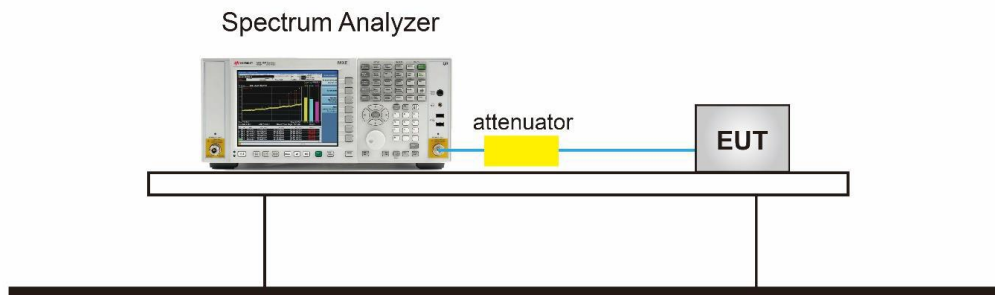

1. The testing follows the ANSI C63.10 Section 11.10.2 Method PKPSD.
2. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
3. Set the RBW = 20 kHz.
4. Set the VBW  $\geq [3 \times \text{RBW}]$ .
5. Set the Span  $\geq [1.5 \times \text{DTS bandwidth}]$ .
6. Sweep time=Auto couple.
7. Detector function=Peak.
8. Trace Mode=Max hold.

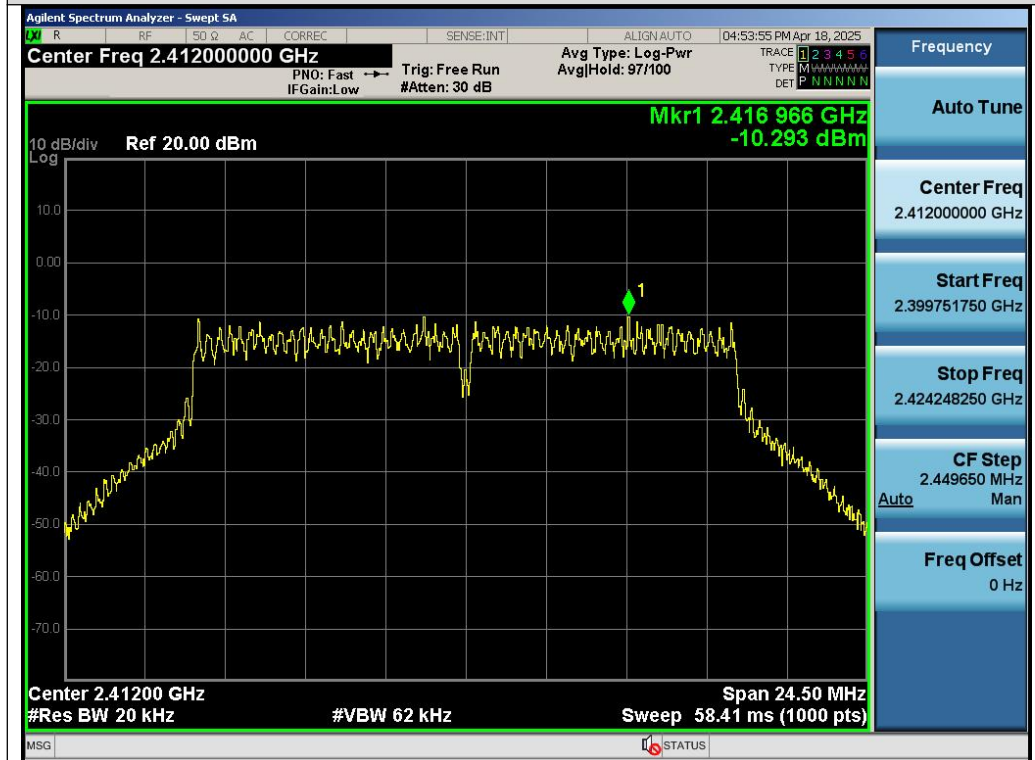

Test\_Graph\_802.11b\_ANT1\_2462\_1Mbps\_PSD

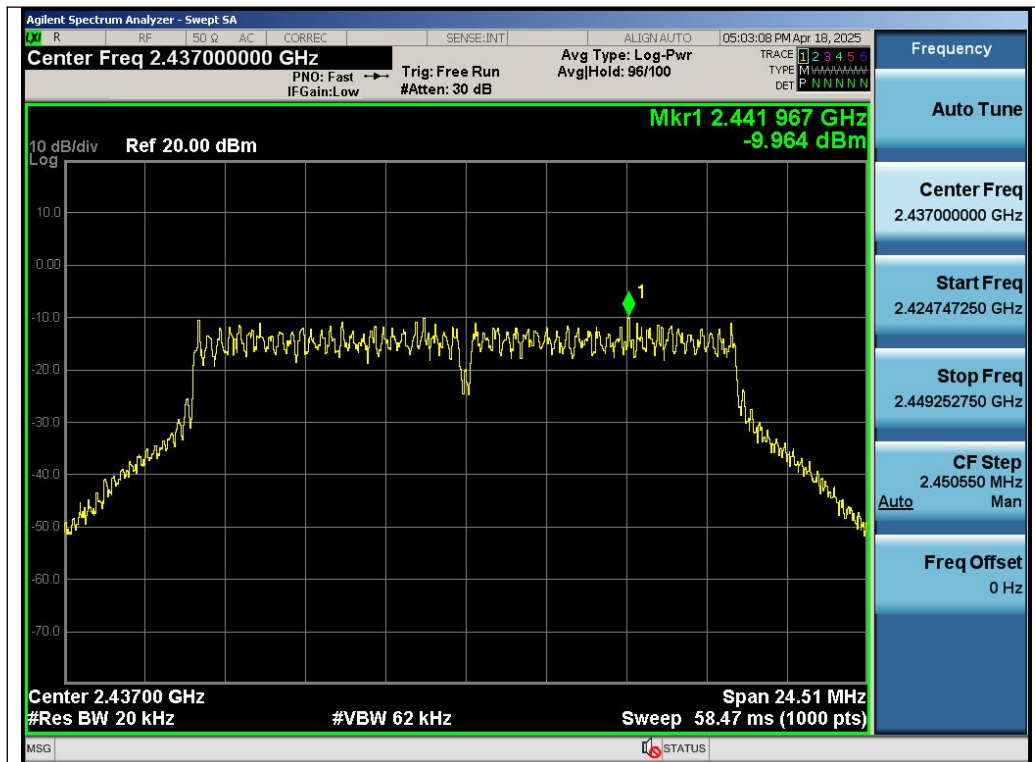

## 10. Conducted Band Edge and Out-of-Band Emissions

### 10.1 Provisions Applicable

In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.

### 10.2 Measurement Procedure

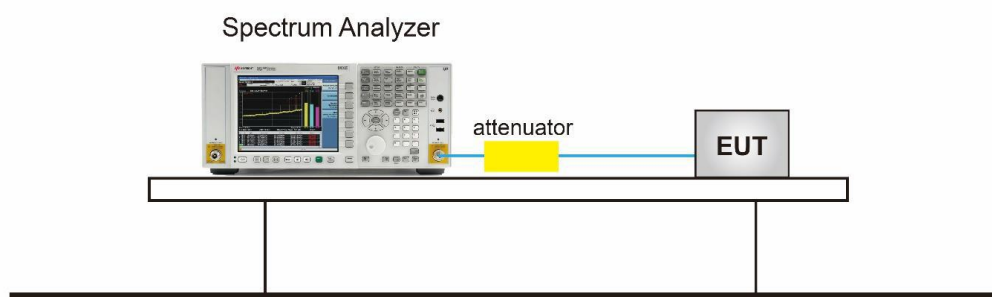
Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.

Use the following spectrum analyzer settings:

- Step 1: Measurement Procedure In-Band Reference Level
  1. Set instrument center frequency to DTS channel center frequency.
  2. Set the span to  $\geq 1.5$  times the DTS bandwidth.
  3. Set the RBW = 100 kHz.
  4. Set the VBW  $\geq 3 \times$  RBW.
  5. Detector = peak.
  6. Sweep time = auto couple.
  7. Trace mode = max hold.
  8. Allow trace to fully stabilize.
  9. Use the peak marker function to determine the maximum PSD level.
  10. Note that the channel found to contain the maximum PSD level can be used to establish the reference level.
  11. For reference level values, please refer to DTS bandwidth test.
- Step 2: Measurement Procedure Out of Band Emission
  1. Set RBW = 100 kHz.
  2. Set VBW  $\geq 300$  kHz.
  3. Detector = peak.
  4. Sweep = auto couple.
  5. Trace Mode = max hold.
  6. Allow trace to fully stabilize.
  7. Use the peak marker function to determine the maximum amplitude level.

Note: The cable loss and attenuator loss were offset into measure device as an amplitude offset.

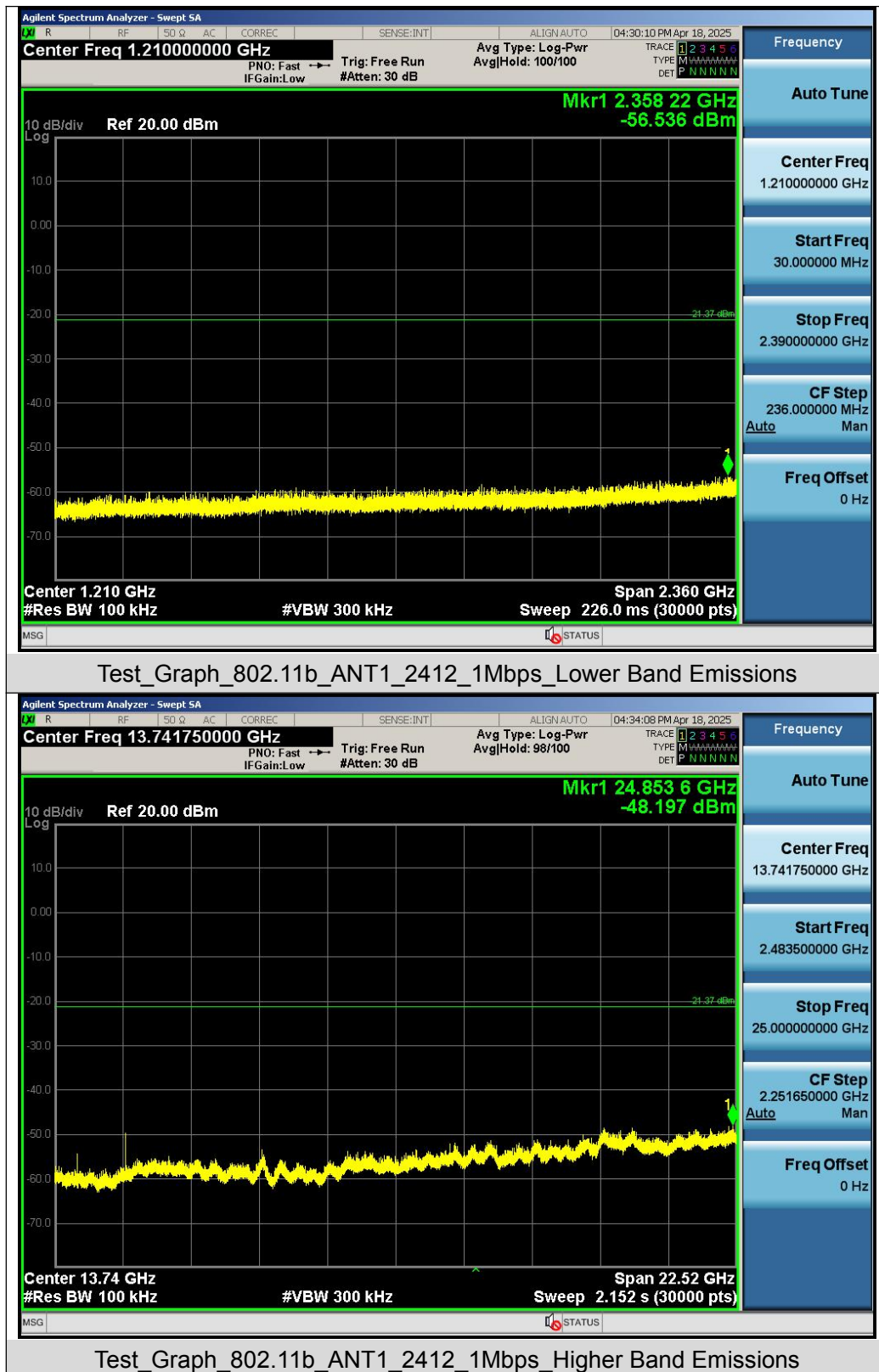
