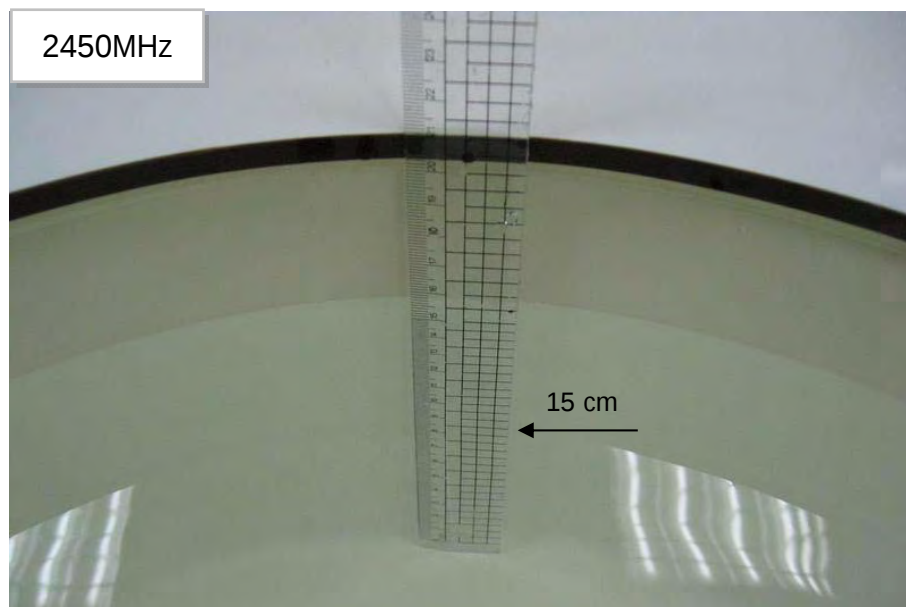

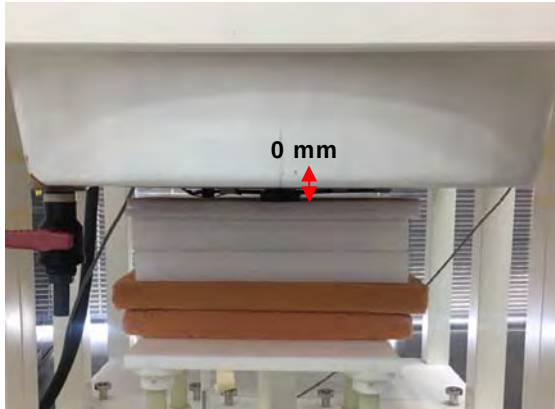


Fig.3 EUT Back side to flat phantom



Body - distance between flat phantom and EUT (12026) is 0 mm

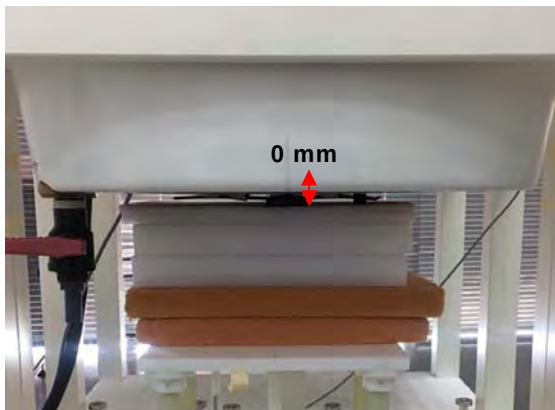
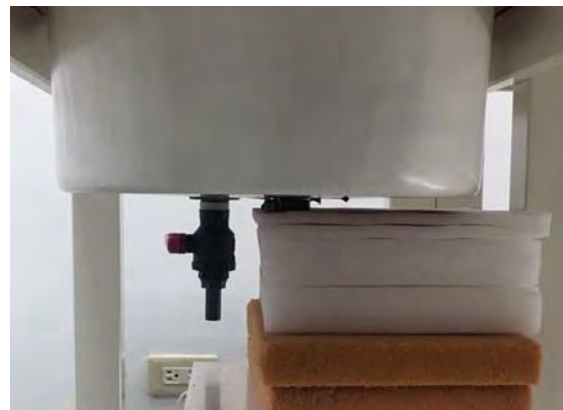


Fig.4 EUT Back side to flat phantom

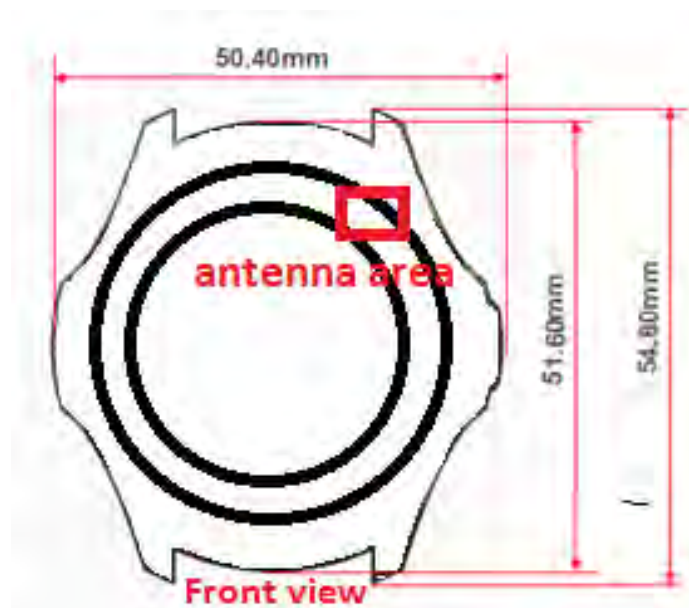


Fig.9 Antenna location
